Dr. Florence Murray Writes From Korea

Mrs. Tait, president of St. James Missionary Society has received the following letter from Dr. Florence Murray of Korea, daughter of Rev. Robert Murray, formerly of O'Leary this province. The letter was read at the last meeting of the auxiliary here and on motion it was requested that it be published. Following is the letter:

Dear Mrs. Tait, It was with a heart full of gratitude that I received a few days ago the sum of \$184.00 for the hospital in Hamhung from the W. M. S. in St. James' Church, Charlottetown. You all know of the distressing debt with which the Board at home has to contend, that makes it impossible for them to send us any money, either for hospital repairs or for equipment. So that such generous gifts as yours are all that we have to depend on for what new equipment we need. Yours was the first gift to reach me for the hospital in Hamhung, for though I have received other sums some months ago I was then in Yongjung hospital and that money was spent there. I wish now to thank you all very heartily for your generosity and to assure you that your kind gift is much appreciated and will be a great help to us. I intend to buy beds with it as we have less than half the number we shall require. However I shall let you know later just how the money is spent, and I hope also to send you a few pictures of the hospital. We are now in the midst of our annual mission meeting and trying to apportion the money at our disposal to the best advantage. It is disheartening to see work that is very promising curtailed for lack of necessary funds, but it is the Lord's work, not ours, and we are praying that in some way He will provide for it. The Girl's School in Hamhung is one of the most needy of the institutions. They have over four

hundred girls and no proper building whatever. The main building was condemned as unsafe some years ago and the walls are several inches out of plumb. Iron bars have had to be run through the walls from end to end and from side to side to prevent the walls from falling apart altogether. Then the partitions between the rooms are so thin that every word spoken in one room is heard in the next. Besides that, the rooms are so overcrowded that the air space is quite insufficient and even then many promising girls clamoring for admission are turned away for lack of room. In addition to this main building several Korean houses with mud walls and floors have to be used as class rooms and here the pupils sit on the floor as they study. Of course it adds greatly to the difficulties of the school. The principal, to have to oversee all these separate buildings, some of which are quite a distance from the rest. The school takes both day and boarding pupils and in the dormitories, which are just Korean houses, the girls are badly over crowded but in spite of this there is very good work done. The teachers are all Christians and very much interested in their school. Many of the girls are Christians and from these devout Christian girls will come the leaders in women's work of the future. Of the girls from unbelieving homes who attend the school most become Christians and the Bible is taught daily. A new school has been promised for some years but as yet the funds for its erection are not forthcoming. In spite of delay, difficulty, and discouragement, Miss McEachern and her teachers are doing fine work for the girls of Korea and the cause of Christ, and we hope that they will not have to wait much longer for a suitable building and dormitories in which to work and live. The Boy's Academy at Hamhung is in if anything a worse position than the Girl's School. Their school building was burned down some time ago and since then the boys have been studying in the church and in a small Korean house on the hospital compound but when the hospital is reopened that building will not be available for the school and Mr. Young, the principal, is at his wits' end to know how to provide for the pupils. The money for this school has been promised for years and it is hoped the building may be soon begun. The Koreans are providing the site and raising a sum of \$5,000.00 towards the erection of this school building that shall provide high school training for the boys from all the territory occupied by the Canadian Mission in Korea. When I write again I shall not doubt be in my own work in Hamhung hospital and will try to tell you something more of the hospital work. Let me thank you once again for your interest and your kind gift to your Korean sisters in this eastern land. Yours very sincerely FLORENCE J. MURRAY, Hamhung, Korea.

Assault Case at Police Court

The Police Court was crowded yesterday morning when the case of the two Chinamen Tom Kim and Honk Chee for assault, causing bodily harm to Alex McKenzie came up for hearing.

Mr. George S. Inman appeared for McKenzie while Mr. W. E. Bentley appeared for the defendants who pleaded not guilty. It was decided to try the case summarily.

Mr. McKenzie who is a farmer living at Iris, told of coming to the city on Wednesday last on business connected with the Pension Board; he is a returned soldier. He made several calls before he went to the restaurant conducted by the defendants for his dinner about one o'clock. He ordered steak, etc. and also apple pie. He consumed part of the pie before he noticed it was mouldy and greasy inside. He called one of the Chinamen (pointing him out in court) and told him that the pie was not fit to eat and that he would take it to a doctor. He started to go out but the Celestial bolted the door; one followed him and hit him with a club of wood on the head and the other with an iron bar on the arm. He could not tell which one. The bar of iron was three or four feet long. The wood he was struck with on the head over two feet long. He was struck on the head first. He called to a young fellow outside to get some one to break open the door. One of the Chinamen then opened the door and he got out. He went to the hospital where he was treated by Dr. Jenkins, the young man.

Cross examined by Mr. Bentley witness said they wanted 50 cents for the dinner, pie and all. He offered to pay for the dinner but refused to pay for the pie. There was no tomato sauce on the table. He was not sure which of them asked for the money, or which looked the door. He understood one of them to say he would telephone the police. He never hit the Chinaman with a bottle.

A very great debt for what he did in the establishment of the cheese industry and in teaching our farmers to co-operate together for the promotion of their material interests. Speaking recently in the House of Commons on the salaries of the metropolitan police force, she declared the present force of women was totally inadequate.

Viscountess Astor said more women police were needed in London for patrol duty, and she appealed to the Home Secretary to increase their number and widen their authority.

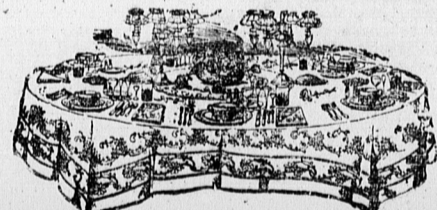

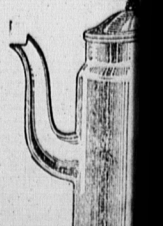
