Death occurred at her home 34 York Lane., Charlottetown, on Thursday of Euphemia Jane Goodwill, widow of the late Rev. John Goodwill. Mrs. Goodwill was seriously injured on February 4th when she was struck by a runaway horse on Queen Street and as she was 83 years of age she was unable to rally from the effect of the injury.

Mrs. Goodwill was the eldest daughter of the late Mr. and Mrs. Cooper of Pugwash, Nova Scotia, where she was born on September 11, 1847. After her marriage with Rev. Mr. Goodwill who was then a missionary in the New Hebrides, she accompanied him to the mission field in the Island of Santo, New Hebrides, where they spent five years. Many interesting stories could be told of her experiences when with her husband on the mission field. At one time they were shipwrecked and on another occasion they were carried off in a slave ship.

Yielding to the repeated request of members of the Church of Scotland and as the climate had begun to undermine his health, Mr. and Mrs. Goodwill returned to the Island where he conducted services for a number of years under the auspices of the above named church. He passed away about twenty-five years ago. There are left to mourn two sons, Dr. V. L. Goodwill of Charlottetown and Rev. T. W. Goodwill of Blythe, Ontario. A daughter, Elizabeth and a son Edward, a barrister at law, Peterboro, Ontario, predeceased her. Before the regrettable accident, referred to, the late Mrs. Goodwill was in excellent health and despite her advanced age was very active, tending to her business about town. She was of a very lovable disposition, extremely charitable and always took a deep interest in church and mission work.

It is our sad duty to chronicle the death, on Sunday, January 26th at Kelly's Cross, of Mrs. Catherine Haughey, in her 90th year. The deceased lady, who was an outstanding figure in this parish for the last three quarters of a century, was bright and active up till less than a month before her demise, and up to the last hour of her long life she had the glorious privilege of retaining all her faculties and consciousness of the approaching end. Her long life was truly a preparation for the life eternal, and having received frequently, and again twenty-four hours before her passing away the consoling Sacraments of the Catholic Church, she willingly and peacefully breathed forth her soul into the hands of her Creator.

The deceased, who was the relict of the late Patrick Haughey was a resident of Kelly's Cross, of whom every one was an admirer for her many amiable and generous characteristics. Her home was a warm place of welcome to both friend and wayfarer, her great desire was ever to do a large share to further the interests of the parish. From her cosy little farmstead she had an unobstructed view of the parish church, and thither her eyes and her heart were frequently directed, and latterly would she make reference to the obviously brief span of life left remaining for her, and though she led a blameless life the thoughts of death would make her pause to think, even in her merriest moods, for she was the soul of humor and optimism. Now that she has gone to enjoy a well merited reward for a spotless sojourn here it is our duty who knew her and survive her to frequently breathe a prayer for her eternal repose.

Mrs. Haughey had no family, but besides a wide circle of relatives and admiring friends, she leaves to mourn an adopted niece, Miss Adriana Monaghan, as well as two sisters, Mrs. F. R. Monaghan, Kelly's Cross, and Mrs. Wm. Matters, Maiden, Mass and several nephews and nieces. The funeral took place Tuesday morning January 28th to St. Joseph's Church where a Requiem High Mass was sung by Rev. Dr. Curran. The pall-bearers were: Jerome McGulgan, Francis Hagan, Joseph Kelly, Edward Carragher, James McAvinn and M. A. Smith.

The death of Senator B. C. Prowse took place at his late residence on Dorchester Street at 3:25 p. m. Saturday after an illness of five months. His son George, hastening home from Boston, completing the last lap of the journey from St. John to Charlottetown by aeroplane, arrived home three minutes after his father's passing. Born Dec. 10, 1852 at Central Royalty, the late Hon. Benjamin Charles

Prowse attained a prominent position in civic, business and political life, occupying the position of Senator in the Dominion Parliament, and being successively City Councillor and Mayor of Charlottetown as well as one of its most prominent, enterprising and successful merchants. Senator Prowse's education was gained at the rural and city schools, followed by the practical experience gained through a successful business career. For a time after leaving school he worked as clerk in the dry goods store of his brother the late Mr. L. E. Prowse, with whom he became associated in business in 1886, forming the original firm of Prowse Bros.

In 1906 a limited stock company was formed, and Senator Prowse became vice-president and business manager of Prowse Brothers Ltd., the president, 'the late' Mr. L. E. Prowse, being then located in Sydney. On the death of the latter four years ago, Senator Prowse became president of the firm, a position he has held until his death. The deceased served Charlottetown as city councillor for two terms, from 1904 to 1908, when he was elected Mayor and during the next two years served in this responsible capacity. In 1911, under the Laurier administration he was appointed Senator for Queen's County.

A member of the Methodist and later of the United Church, Senator Prowse was a man of general characteristics and generous principles. He befriended the poor and needy on very many occasions, but he was never ostentatious in the performance of the charitable actions which he looked upon as a privilege as well as a duty. He was a man of warm and sincere friendships, loyal in his politics and frank and outspoken in his transactions with all men.

Senator Prowse's first wife was Miss Amanda Miller, daughter of the late George Miller, city. Three children survive, George, in Boston, Carl, at Mount Allison University, and Mildred (Mrs. Preston McLean), city. Senator Prowse's second wife was Miss Clara McMillan, Cymbric, this Province, who survives and to whom sincere sympathy will be extended. There are also the following brothers and sisters: Col. W. B. Prowse, Charlottetown; Robert, British Columbia; Albert, Toronto; Cornelius and Artemus, Summerside, Mass.; Agnes (Mrs. I. Brehaut), Weymouth, Mass.; Lavina, (Mrs. Wm.
