THE MARKETS

(Canadian Press) MONTREAL, Que., June 13.—The foreign demand for grain here today continued of a limited character and exporters stated that they only worked a few odd loads of Manitoba wheat with the United Kingdom.

The demand from exporters for cash grain in the local market was slow, there being only sales of odd loads of Canadian western oats at 61-2 cents per bushel over the Winnipeg July option c.i.f. Montreal. The car lot trade in oats was also quiet and prices scored another decline of one cent per bushel.

The trade in spring and winter wheat grades of flour was slow but values were well maintained.

A moderate amount of business was done in all lines of mill feed and the undertone to the market was firm.

OTTAWA, Ont., June 13.—(Eggs) A very healthy feeling continues on Canadian egg markets and prices are holding firm.

Toronto—There is a keen demand for eggs on this market and the price for extras shows a partial advance, general paying prices to country shippers being 32 cents for this grade. Paying prices for firsts and seconds are unchanged at 28 to 29 and 23 to 24 cents respectively.

Extras are selling wholesale at 37 cents. The poultry market is very firm except on broilers. Dressed fat hens are selling wholesale as high as 35 cents per pound.

Montreal—The local egg market is holding fairly steady with buyers showing more disposition to take on supplies.

St. John—The local egg market is quiet with receipts showing a gradual decline and local consumption is now absorbing a larger proportion of receipts, so that the surplus for storing is small. Prices to country shippers have advanced to extras 31, firsts 27, seconds 21, delivered, cases returned.
