**ONE SENATOR, THREE DEPUTIES, ARE KILLED.**

PARIS, Dec. 22.—There will be a number of empty seats in both Houses when the French Parliament meets on Dec. 22. Those of Senator Emile Raymond and Deputies Pierre Gougon, Edouard Nortier and Paul Froust, who were killed in battle, will be draped in crepe.

There are a number of Senators and Deputies in the territory occupied by Germany and the French Government has been trying to communicate with them through the Spanish Embassy in Berlin, but so far unsuccessfully. Among these members is one of the Deans of the Senate, the Academie-cian Alfred Mesieres. Others in the occupied territory are Senators Charles Noel, George Ermant, Charles Seblime, Joseph Delouve, Gustave Dron and Auguste Potie who are Mayors of the cities they represent in Parliament and remained at their posts.
