Arrange For X-Ray Survey At Bristol

About 60 residents of Bristol met in a school house on Wednesday evening with Mr. Patrick Sinnott in the chair to consider the chest X-ray survey. Mr. Jardine and Mr. Murphy of the Tuberculosis League were present. Mr. Jardine reported that 35,000 persons were X-rayed during the last 12 months that the unit worked. Many of the cases found by X-ray units are in the early stages, he said. Statistics from Ontario indicate that 59 per cent of the cases found by Mobile Units are in the minimal or early stage, as contrasted with 28 per cent. found by other clinics.

It is planned to bring the Mobile Unit to Bristol on May 15th from 10 to 11:30 A.M. The audience enjoyed a film called "Target TB" as well as some other delightful moving pictures lent by Mr. Martin of the National Film Board for the occasion. This meeting was arranged by Miss Mabel O'Brien and the other officers of the Bristol Women's Institute in co-operation with the Prince Edward Island Tuberculosis League.

(Continued from Page 1) styled as a judge of the County Courts." The latter provision to come into effect by proclamation.

Little To Do

Mr. Saville said the County Court judges have much less work to do now than they formerly had. Perhaps one would do all the work they have to do. "In a way I don't like the idea of each County not having its own judge," he said. "At the same time I don't think that any individual who feels he has necessarily to go to court will suffer in consequence. It may help to get a proper Court of Appeal, which lawyers and judges have been looking for for several years. I think that is more important."

Bar Society Movement

Mr. Morley Bell: "There has been a movement on foot from the Bar Society for some years to have an Appeal Court. I think negotiations have been carried on with the Dominion Government and they have reached the point where they will consider appointing a fourth Supreme Court judge and of course pay for his services, but will cut down our County Court judges to two; which will save the money they are now paying the County Court judge, so that the extra cost to the Dominion would be a small amount."

Mr. Hunter: "In other words, you are going to promote one County Court judge to the Supreme Court?"

Mr. Morley Bell: "No, the idea is that sooner or later when the members of the County Court judges retire, or otherwise vacate, they will not make new appointments but instead they will press the Dominion to appoint a fourth Supreme Court judge."

Mr. R. R. Bell: "It is all cut and dried!"

Mr. Morley Bell: "I don't think it is cut and dried."

Mr. R. R. Bell: "And a man from Prince County is to be the fourth judge?"

Mr. Morley Bell: "I just wished to bring the bill into committee. I would move now and we report progress and ask leave to sit again."

After some further discussion, the motion was put and carried.

Already Provided For

Mr. Strong: "I believe there is a provision in the Dominion Act now that says one Judge can ask another to take his circuit. It is done on request. Now the Attorney General, as Mr. Bell says, is to designate what judge is going to try these cases. He can send Judge Lewis down to Georgetown if he wants to, and vice versa."

Hon. Mr. Barbour: "I believe what the member from Fourth Prince says is correct. I know in the past Judge Stewart went up to Prince County and tried cases on request of Judge McQuarrie. But I remember talking to the late Judge Stewart at the time about it, and he said there was not enough County Court work in the Province for one judge."

(Continued from Page 1) cent on the basis of a long-term lease, might be used for domestic rentals.

In the case of commercial rentals, too, accommodation which is offered for rent for the first time has been released from control and it was thought this method of lifting restrictions might be applicable to ordinary dwellings.

Generally, however, the domestic changes are expected to be governed by such factors as whether or not the accommodation is rented or heated and the amount of landlord or junior service provided.

Some further modification of eviction controls to allow persons owning homes but unable to occupy them to take over the premises may also be announced. A change was made in this field March 1 to allow a limited number of landlords to occupy tenanted homes which they had bought in the "justifiable" belief that they would be able to obtain occupancy.

There have been reports that the Government has been under heavy pressure from landlords to make some adjustment which would give title to owners of pre-war accommodation which still is renting at a rate established before the war.

Cabinet members have admitted freely that the government has been seeking to make some such changes but could not find a workable formula. Presumably, a formula now has been devised which the government believes will be fair to landlords and tenants.

Government Member Denounces Government Liquor Traffic Roundly

An attempt to explain his position on the liquor question by Hon. Horace Wright, Fourth District of Prince, elicited scathing Opposition comment in the Legislature on Monday. The discussion occurred during the debate on the Draft Address.

Mr. Wright said the member from 2nd Queens (Mr. R. R. Bell) was trying to ride two horses on the Prohibition issue. He had stated that men of sound judgment drunk in this Province, but when he voted for the amendment two years ago he was catering to the liquor traffic. Now he blames this Government for increasing the consumption of liquor. The responsibility for this measure rested on the Legislature not the Government, Mr. Wright maintained, because there were three members of the Government who voted against it.

Hon. Dr. MacMillan: "One resigned."

Mr. Wright: "If all the members of the Opposition had voted against it, it would not have carried."

Mr. R. R. Bell: "Didn't the Attorney General ask to give that Act a trial?"

Mr. Wright: "The Attorney General is making a good effort to enforce the law, but it is a ridiculous law. It is a farce."

Dr. MacMillan: "Why don't you resign again?"

Mr. Wright: "I ask you, is it not illegal to drink alcoholic liquor as a beverage under the Prohibition Act?"

Dr. MacMillan: "Ask the Attorney General."

Mr. Wright: "I am asking you, Dr. MacMillan, am I not a lawyer, I am a doctor?"

Disciplines Responsibility

Mr. Wright maintained it was ridiculous for doctors to claim they could tell whether patients required liquor six months hence. Why did they at first declare that they would not use these six months' scripts at all? Did they agree with the amendment at that time?

Dr. MacMillan: "Some of them are like you, they did one thing once and then repudiated it." (Laughter.)

Mr. Wright: "I will ask my hon. friend to take that back because I didn't repudiate anything I ever said in this House."

Dr. MacMillan: "You repudiated your resignation."

Mr. Wright: "I want to put the responsibility now of this Act on the other side of the House. I am prepared as a member of the House to vote against that measure that was passed two years ago."

Dr. MacMillan: "Why don't you resign again M that's the way you feel?"

Mr. R. R. Bell: "The amendment was all right. It is a matter of administration, and you know it."

Mr. Wright: "I know very well the amendment is not all right. It cannot be considered temperance legislation at all."

Mr. Hunter: "You are still a member of the Government. Why don't you do something about your resignation?" (Applause.)

Mr. Wright noted that the Canadian Legion had opposed the vendor's store at Cardigan, and the member from Cardigan (Mr. MacDonald) had stated that wherever you have a government store you should have police protection. That was evidence they were detrimental to the public interest. Everyone who had voted in favor of the amendment two years ago was responsible for present-day conditions, he maintained. A larger percentage of the members of the Government had voted against the amendment, than had voted against it in the House. The House therefore should bear the responsibility. Personally he had always been opposed to the liquor business, and he always would be.

thing, become worse. The question is to find means whereby the farmers can get more help. One way is the labor shortage is the unemployment insurance money, paid to those who took up industrial employment. Farm labor should have been placed in the same category. War labor boards were established to keep industrial wages down, but later was nothing to control farm labor costs, with the result that our farmers now have to pay \$4 a day.

Mr. Kichham: "You were chairman of the farm labor board. Those soldiers got \$3 and maintenance and they were not worth two-thirds of the work of a local man."

Mr. Wright said the board of which he was chairman had nothing to do with controlling farm wages. Today, though farm prices are high, it is impossible to make any large profit, and the farmer is working harder than any man should have to work. There is now more machinery that really increases the farmers' work. The only remedy seemed to be the importation of farm labor into the country.

Mr. Strong: "What do they pay those Poles they imported here?"

Mr. Wright: "I understand that the minimum rate of pay for those men was \$45 a month and board, and from that up to \$75. As far as I know \$45 and board is the rate of pay here."

Mr. McNeill: "What do you pay Japanese labor?" I understand there are some in your district."

Mr. Wright: "There was one fairly came to Bedeque, I don't understand, and he gives good satisfaction. I can't tell you what rate of wages he is getting. I am not advocating Japanese coming here, but there are countries in Europe, such as Scandinavia, Norway, Sweden and Denmark that have a good many men, and it might be to our advantage to import them here."
