LAIRD, SASK., Oct. 20—(CP)—Cut down by police bullets as he prepared to fire at his pursuers, George Whyte, fugitive from justice, was killed near here late today. Poses had combed the area, 70 miles southwest of Prince Albert all day for the man who wounded Constable J. E. Williams after locking the Royal Canadian Mounted Police officer in his cell. Aided by police dogs, the posse trailed Whyte to a stack on the outskirts of Laird. Whyte broke from his hide-out when Detective Sgt. E. J. DesRosiers approached and reached for his gun when a bullet from a police gun crumpled him to the ground.

QUEBEC PUBLIC ACCOUNTS PROBE REOPENS

Brother of Former Premier Appears Before Committee.

QUEBEC, Oct. 21—(CP)—Antoine C. Taschereau, 72-year-old brother of Quebec's former premier, assured the Public Accounts Committee today he would submit a statement showing the total interest he derived personally from Government funds deposited in his name as accountant of the legislature for more than 20 years.

Tired and so sickly his physician accompanied him, witness gave the assurance to Premier Duplessis whose motion led to expulsion from the hearing of Valmore Bienvenue. The motion, passed 25 to six by the committee, was made by the Premier who charged counsel with prompting his client in answering questions.

"Such a practice," declared the Premier, "is against the rudimentary elements of decency expected from a lawyer of so many years standing."

Opposition Leader T. D. Bouchard charged Mr. Duplessis with contravening "the spirit of British justice," and displaying "autocratic conduct."

But the Premier moved that the committee rescind the permission given Mr. Bienvenue to attend the hearings, and the crowd cheered as counsel left the room.

Calling of the witness roll brought no response to the name of Oscar Beriau whose "signs of Canada Limited," manufactured motor license plates for the province, and Chairman Alexandre Tache said he had been informed Beriau was "visiting" in the United States.

"Swell," said the Premier, "I warn those who are scheduled to appear before this committee that the inquiry will last four years and if they are going to stay away all that time it will prove costly. Furthermore, if they refuse to come back to Quebec, necessary legal steps will be taken to bring them back."

Witness agreed with the Premier that he had returned more than \$15,000 to reimburse the Government for interest he had received personally on public funds deposited in Banque Canadienne Nationale.

"Did you," asked the Premier, "reimburse the Government for interest paid on public funds by the Bank of Montreal, Banque Provinciale de Canada and the old National Bank?"

"No," replied witness, visibly shaking, "I did not."

"You paid back only what was discovered and brought to light," the Premier said.

There was no reply from the aged witness.

Georges Dussault, 28 years secretary in the attorney-general's department, denied he ever received commissions on materials purchased for Montreal jail and told Premier Duplessis he was not responsible for renting his apartment to "two international crooks" who occupied the suite while the secretary was in Europe.

LONDON, Oct. 21—(CP)—Havas—Amy Johnson Mollison's unwillingness to play the role of "a hypocritically tragic widow" if her estranged husband, Capt. James Mollison, falls in his projected west-to-east transatlantic flight was one of the reasons which prompted her to announce their separation publicly, the long-distance flier revealed tonight.

Mrs. Mollison, who disclosed last night that she and her flying husband had agreed to separate, tonight elaborated on her announcement.

"Before he left for the United States," she continued, "we agreed amicably to go our own ways."

"In a few days he is planning to make what I consider a very hazardous flight, and while I wish him all good luck, I can't help but feel he has not seriously considered my role in his flight—that is either that of embarrassed absence at his safe arrival or a hypocritically tragic widow if he fails.

"Because of this false position which for some time has been more and more unbearable I decided on making my position quite clear."

MOLLISON'S SEPARATION ANNOUNCED

Likens Tasmania To This Province

HOBART, Tasmania, Oct. 21—Small communities could contribute their quota of advancement to the Empire and the good of mankind. Rt. Hon. R. B. Bennett, Canadian Conservative leader, said today in acknowledging the hospitality extended by him to Tasmania.

He compared the Island state smallest commonwealth unit, with Canada's Prince Edward Island. Like the Canadian province, Tasmania has rich resources. Its population of less than 250,000 enjoyed prosperous industries in wool, fruit, and fisheries, and was endowed with great natural scenery. He urged that greater efforts be made to attract tourists.

Mr. Bennett was the guest of Governor Sir Ernest Clarke, at Government House and luncheon was tendered to him by Premier A. J. Ogilvie and the cabinet ministers. He was also a guest of honor to day at a luncheon tendered by the Chamber of Commerce with 100 business men in attendance.
