Hits Top And Works Up To Climax

They start at the top and work up to a wrecking climax in Paramount's "Wrecking Crew" which unfolds a career of thrills yesterday at the Capitol Theatre.

Starring Richard Arlen, Chester Morris and Jean Parker, the film packs the wallop of a cannon ball, an instrument of destruction which is an important part of the equipment of professional house wreckers.

In "Wrecking Crew", Dick and Chester are pitted against each other in a contest for beautiful Jean Parker, and for the best wrecking record on a big job.

Closing a series of three lectures on the Bahai' faith at the Queen Hotel, Mrs. Marnie L. Seto spoke last evening on the life and teachings of Bahai' founder, Baha'ullah, the faith which she claimed has become world-wide in scope and adherence.

This world educator, who was born in Persia, died in 1857, of distinguished lineage, was eldest son of Mirza Abbas, a minister of state in the Shah's government.

He announced to the world that the world had arrived when all the glorious promises left by the prophets of past ages would be fulfilled.

"This mission was to bring unity to a world dangerously divided by strife, hatred, misunderstanding and wars. He taught that the purpose of religion was to unite and not to separate mankind, and that the basis for religious unity because the foundation of all religions is one. He showed the need for the reconciliation of all languages to solve the difficult language problem, a language which should be taught in all the schools of the various countries of the world in addition to the mother tongue. Equality between men and women was another of his teachings; and throughout his teachings he emphasized the need for an understanding between the different peoples of the world, he advocated the use of an international auxiliary language to solve the language problem, a language which should be taught in all the schools of the various countries of the world in addition to the mother tongue.

For the reviving of such teachings and principles, Mrs. Seto said, Baha'ullah suffered all his life, he endured persecutions, exile and was banished from his native land to the penal colony of Akko, Palestine, where he died in 1852, at the age of seventy-five and was succeeded by Abdul-Baha, his eldest son. The latter continued to carry on the work of disseminating the teachings of the Bahai' Faith, and toured Europe, Canada and the United States in 1911-1912. A knighthood in Order of the British Empire was conferred on him at Haifa, Palestine on April 26, 1920. He died Nov. 28, 1921, and his grandson, Shoghi Effendi, Oxford educated, now heads the faith as Guardian, with headquarters at Haifa.

Farm Loan Board Operations In P. E. Island

Since the year 1929, the Farm Loan Board has been loaning money to farmers on a 25-year mortgage loan plan in a number of provinces in the Dominion.

The Board loaned a total of only \$1,320,000 in the last fiscal year, 1943. The rate of interest on first mortgage loans is 5 per cent per annum.

To the end of the Board's last fiscal year, March 31, 1943, the Board had loaned in all provinces \$49,151,000, of which \$33,120,000 was outstanding at the above date. The Board holds a total of only \$1,320,000 in the last fiscal year, 1943.

The beginning of the present war, the number of applications for loan has been greatly reduced and, in the last fiscal year, only 1,320,000 collections in the last fiscal year totalled \$5,201,000, consisting of \$3,393,000 of principal repayments and \$1,808,000 of interest.

The Board's operations are self-supporting agency of the Dominion Government, and provides for its administrative costs and reserves from its revenue and interest on paying interest on monies borrowed for loaning purposes. The cost of administration for the last fiscal year was \$125,000, and the value of the assets under administration.

In the Province of Prince Edward Island, the Board has loaned \$1,320,000 in the last fiscal year, and had loans outstanding of \$1,009,000. During the fiscal year ended March 31st, 1943, the Board received payments of \$1,320,000 from borrowers in the Province of Prince Edward Island as follows:— On account of interest \$125,000; on account of principal \$500,000.

Out of a total of 756 first mortgage loans made in the province since the Board's inception, only one security through sale or foreclosure proceedings as at March 31st, 1943.

In the present fiscal year, April 1, to Dec. 31, 1943, borrowers from the Board in Prince Edward Island paid on their mortgage accounts the sum of \$1,320,000, as compared with \$750,000 for a similar period in the year 1942-43.

Brief Presented On Civic Playgrounds

Following is the text of a brief presented to the City Council by Lt. Col. K. S. Rogers, chairman of the joint service clubs committee on playgrounds.

"The Worshipful and Members of the Council:

Speaking on behalf of the joint committee of the Charlottetown service clubs as their chairman, I wish to express my appreciation of your courtesy in holding this special meeting this afternoon. We feel that the cause which we are presenting is one which you, Mr. Mayor and the members of your council, have just as close to your hearts as have the members of the joint service clubs. We are delighted to appear before you today.

It is the cause of the youth of Charlottetown on whom the future of this city rests. We know that with such a cause, you, Mr. Mayor and your council, will be happy to do many things, but we also know that there are many things which you would hesitate to do, without the solid backing of a large body of citizen tax-payers. This is the reason we have done in excess of 150 members, leading business and professional men of the city of Charlottetown. These clubs are united in their opinion that the time is long past when Charlottetown, as a city, should devote money, thought and energy to the care of the city's children.

During the various holiday periods throughout the year.

"Organized playgrounds have been in use for a long period of years in other municipalities in the United States and Canada. Wherever they have been properly established, they have resulted in a reduction of juvenile delinquency and traffic accidents. We wish to commend your body for the work which you have done in the establishment of the Charlottetown Street School, Government Pond and other places, and we wish to offer you our aid in presenting the case to our fellow citizens of Charlottetown in favor of a wide extension of these small ventures, which you have already made into the realm of playgrounds. It is the consensus of opinion of the service clubs we represent that the time has now arrived when the city should appoint capable, paid supervisors and should establish civic playgrounds in the east, north, west, south and central portions of Charlottetown as an all-year enterprise. Such playgrounds should have proper slides for small children during winter and summer. Sand piles should be provided for the children to play with. Police supervision of the area immediately surrounding the playground is essential so that children can, when necessary, be safely conducted across busy traffic thoroughfares on their way to and from the playgrounds.
