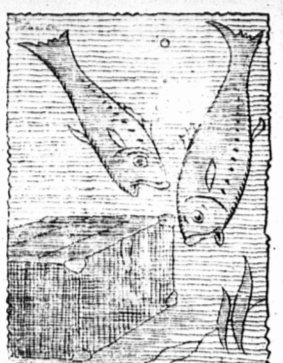

Pleasant, Esther and other short streets off Longworth Ave., by Corps Cadet I. Dalziel and Miss Florence Henderson.

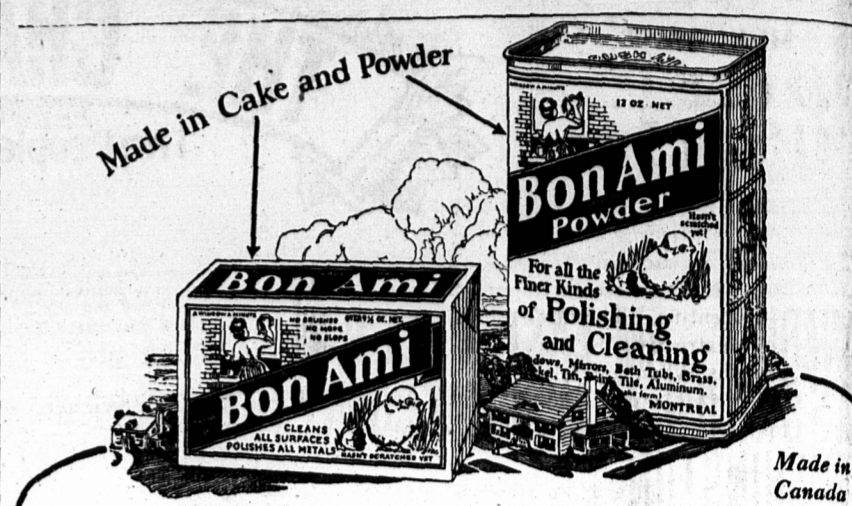

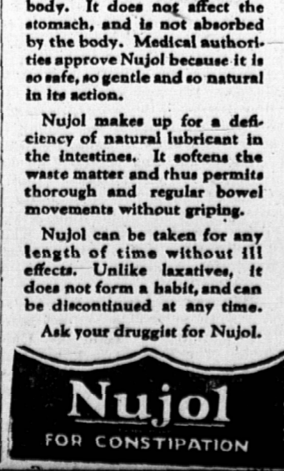
