## STRIKES IN PROGRESS AT BESCO MINES

### No. 2 Mine, Company's Largest Producer, Idle—Drivers Demand a Local Contract.

GLACE BAY, July 14.—Strikes at the two largest producing collieries of the British Empire Steel Corporation are in progress today. No. 2 Mine the Company's largest producer is idle since yesterday afternoon, the drivers on the afternoon shift refusing to work without a local contract. The day shift drivers did not turn out this morning, so the pit is idle again today.

An I. B. A. Colliery ranking second in production to No. 2, about seventy of the drivers appeared this morning but refused to go down in the mine. All other workmen went below, about 480 in number.

## Bolshevism Is Growing in Japan

VANCOUVER, B. C., July 14.—Bolshevism is growing in Japan today and although it is watched it shows itself, I would never be surprised if a crash came.

This was the opinion given by Rev. A. Lea, Anglican Bishop of South Japan, on his arrival here yesterday from the Orient, en route to Toronto.

Notwithstanding the Red menace, Christianity, he said, was gaining strength in Japan, with two native bishops functioning in the country.

LONDON, July 14.—The executive committee of the British Miners Federation began a series of conferences today which have stirred unusual interest because of reports that a possible move for peace in the coal dispute may be forthcoming.

## Quarterly Meeting Board of Trade

An interesting discussion took place last night at the quarterly meeting of the Charlottetown Board of Trade, on the question of Maritime Rights, and the placing of the grievances of this Province before the Committee that is to sit here about the end of this month.

Emphasis was placed on the fact that the case for P. E. I. could be most favorably stated if it was placed before the Maritime Rights Commission in a properly organized manner.

A committee consisting of Messrs J. O. Hyndman, R. E. Mutch, R. L. Cotton and Alfred Pickard, was appointed by the President Mr. W. M. Rowe, to call on the Provincial Government and the Board in having the facts fully presented.

Last night's meeting opened with President Rowe in the chair, and after the reading of the minutes of previous evening the Secretary, Mr. W. L. Higgins, read the communications, which included the following:

Correspondence from the Canada Board of Trade, notifying that a trade conference was proposed to be held in Canada in 1927, to which authorities on British trade conditions would be invited, and requested to make a thorough study of conditions in Canada, with a view toward increasing the amount of British capital invested in Canadian industries. It was decided by the local Board to send the organization a letter expressing approval of the contemplated move.

This correspondence also included an itinerary of the delegation from the West, which will hold a meeting in St. John on Sept. 28-30, to hear the views of the Maritime Provinces in regard to transportation and other matters. One delegate was invited from the Charlottetown Board. The appointment of this delegate was referred to the Council.

Notice was read of the change in the date of the Associated Boards of Trade, annual meeting, from August 18th to August 16th. Several prominent speakers have been invited, including Mr. F. A. Harrison, Canadian Immigration Vice-Consul, Mr. J. B. Champion, manager of the Standard Bank of Canada. As this meeting is being held in Charlottetown, the local Board of Trade is making arrangements for the entertainment of the visiting delegates. Members of the Farmers' and Women's Institutes will also attend the gathering, so that, as far as representation is concerned, it will be one of the most important meetings of the year. It will deal with the subjects of health, education, transportation, and good roads.

A sample of the Disease Free Seal, furnished free by the Associated Board of Trade for use on business letterheads, was also forwarded. It is both artistically and neatly designed, and should create a good deal of favorable publicity for the Province.

Mr. R. E. Mutch made reference to the sitting to be held in this city of the Maritime Rights Commission, at which any one having any complaints in regard to the relationship of Dominion and Province would be heard. Mr. Mutch said Mr. Hyndman had been spoken to on the subject by Mr. Cyrus MacMillan, one of the members, and he thought that steps should be taken to have the case for this province fully presented.

Those taking part in the discussion that followed were: Messrs J. O. Hyndman, S. A. McLeod, Nelson Rattenbury, P. W. Clarkin, Alfred Pickard, John McPhee, W. M. Rowe, W. L. Higgins and R. H. Jenkins, and the result was that the committee already referred to was appointed.

A letter was read from the men's institute supervisor expressing hearty thanks of that organization for the entertainment that had been given them by the Charlottetown Board of Trade. Mr. S. A. McLeod, chairman of the entertainment committee, said in his report that the sum of \$141 had been paid to each of the orphanages in connection with the Women's Institute banquet.

Mr. Hyndman said that the Board owed a debt of gratitude to you, Mr. McLeod, for his work as chairman of this committee, and on motion, the thanks of the Board were extended to Mr. McLeod by the chairman.

Mr. K. J. Martin was elected a member of the Board at this meeting.

## Financial Crisis In Belgium; King Given Full Powers

BRUSSELS, July 14.—Three virtual dictatorships loom in Europe as a direct outcome of the financial crisis. The Belgian Chamber of Deputies last night adopted on first reading a bill which would give King Albert full powers to issue such decrees as he may see fit for stabilizing the exchange.

The French Minister of Finance, M. Caillaux, will submit a similar bill to the finance committee of the French Chamber Friday.

Meanwhile Italy is discussing whether Premier Mussolini and his cabinet should be made responsible to the King and not to the legislature, thus vesting them with extreme authority to deal with the situation. The French financial crisis apparently has been outdone only by that of Belgium, whose franc is rapidly declining in value.

HIS MAJESTY SENDS HEART-FELT SYMPATHY TO ALL RANKS OF U. S. NAVY

WASHINGTON, July 14.—A cablegram from King George expressing grief over the Lake Denmark explosion was received today at the White House and acknowledged in the name of President Coolidge.

"I am grieved to hear of the serious explosion caused by lightning yesterday at the United States ammunition depot at Lake Denmark," His Majesty's message said. "I am sure that the United States Navy and all my heartiest sympathy and feeling go to the families of those who have lost their lives or others who were injured in this disaster."
