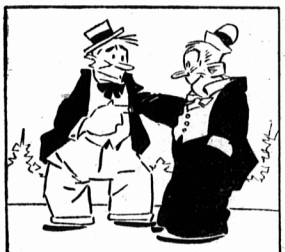

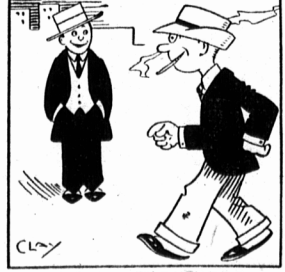

BENNETT TELLS AIM OF PARTY

Conservative Leader Begins Summer Tour With Speech in Quebec. Rights of Minority Must Be Protected, He Declares to Audience.

LA PRAIRIE, Que., June 25.—Facing the first audience of his summer speaking tour, Hon. R. B. Bennett on Saturday afternoon submitted the policies of the Conservative party. The new opposition leader was enthusiastically received, and throughout his speech there was no interruption.

From all the parishes of Naperville-La Prairie and surrounding counties citizens massed in Kempton Park to hear the Conservative chief. Loud speakers were installed for the occasion. Two official addresses of welcome were presented to Mr. Bennett in French one from Mayor Longtin, for the town of La Prairie and the other from Alexis Suprenant, on behalf of the farmers of the riding.

It was late in the afternoon when Mr. Bennett arose to speak. He paid tribute to the work of French Canadians in building up Canada and regretted he could not deliver his speech in "the beautiful French tongue."

"We must respect the rights of the minority whether in this province, Prince Edward Island or any other province," Mr. Bennett declared in recalling that the Conservative party under Sir John A. MacDonald had suffered defeat in protecting the rights of the minority. "This Canada of ours must go forward on a broad, undivided line of race, creed or religion and in this course lies our salvation."

The British North America Act, which protected the right of the French minority, could not be lightly set aside. On the St. Lawrence waterway project Mr. Bennett made a brief comment. "The party with which I am associated," he declared, "will maintain its traditional paths and will not for one moment sacrifice one jot or tittle of our rights or interests in the great waterway that stretches to the sea, in any circumstances."

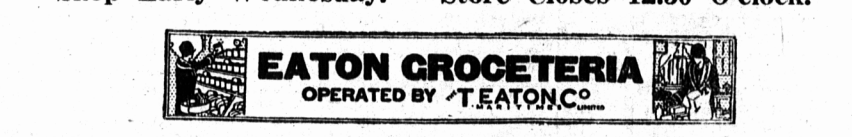
Mr. Bennett touched on the question of Canada's imperial relations. "For my part and the party I am associated with believe that the future of Canada can best be developed as part of the British Empire," he stated. The Conservative leader deprecated any suggestion that the Conservative party would have Canada's policy "dictated by some one else."

Tariff protection for farmers, as well as manufacturers was essential. "We of the Conservative party believe that Canada must be developed as a whole, its manufactures, its industries, its agriculture and its minerals," he exclaimed.

Miss Mildred Bennett, sister of the Conservative leader and Mrs. Arthur Brossard, wife of the Opposition candidate in 1925, were presented with bouquets of flowers by women admirers. On Monday morning, Mr. Bennett will leave for Cowansville, Swoetsburg and Garby in the eastern townships where he will continue his trip. Mr. Bennett in opening his speech said: "He realized that unless Canada had a prosperous farming community there could not be happy and contented people in this country. The duties of an opposition leader made a difficult task, but encouraged by reactions such as he had just received Conservatives would confidently go forward and do the best we can."
