"I just want you to know, Madam," said the shopkeeper, "that these regulations are directed not against you Americans, but against the Germans."

An Italian whom Massock knew only slightly stopped him on the street, shortly before he left on an exchange ship, kissed him on both cheeks and said, "my greetings to President Roosevelt."

Such were the signs and portents by which Massock judges that the Italians are fundamentally friendly to the United States. Fundamentally hostile to the Nazis.

In his newly published book, "Italy from Within," Massock sets forth his impressions of the Italian people during four years as chief of the AP bureau in Rome, and the sum total should horrify the Germans and encourage the United Nations in any plans to get at Germany through Italy.
