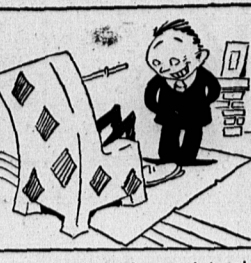

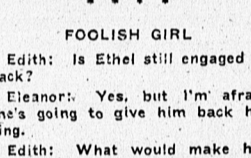

Wedding Bell Rumor Is Heard In The Capital

MONTREAL PAPER REPORTS WHISPERS CONCERNING BENNETT AND KING—NAMES OF TWO PROMINENT CANADIAN WOMEN MENTIONED

MONTREAL, May 17.—Canada's leading bachelors may, a Montreal paper reports, shortly become two of the country's most popular husbands. Parliament Hill is a-buzz with the news that originated, no one seems to know whereabouts, that Premier R. B. Bennett and Rt. Hon. W. L. Mackenzie King, former premier of the Dominion, may answer the call of Cupid.

Rumor has it that Mr. Bennett's name will be linked with that of Mrs. Effie Rowley, widow of the late managing director of the E. B. Eddy Company, of which the premier was and perhaps is the largest shareholder. Mentioned as the future wife of Mr. King is Mrs. Jessie D. Dunlap, owner of the famous Donalds Farm at Toddmorden, and reputed to be one of Canada's wealthiest women.

When Premier Bennett started out in life he started alone. With the family fortunes at a low ebb, Richard Bennett put himself through public and normal schools by doing odd jobs. Later he was a school teacher, but not satisfied with this he began to study law at night in the offices of L. J. Tweedy, Chatham. Some years after Mr. Bennett graduated in law at Dalhousie University.

He was elected to the Chatham town council and became assistant secretary of the Methodist Sunday school. In this town he made two friends who were to affect his future fortunes: Jenny Shireff and her brother, Joseph.

In 1897 Mr. Bennett was called to a law firm in Calgary. There he went into politics, going into the Legislature of the new Province of Alberta in 1906. He resigned his seat in 1911 to participate in the federal election, where he was returned as a member for Calgary in the House of Commons at Ottawa.

Later on Miss Shireff became the wife of Ezra B. Eddy, whose wife had died some time previous. When Mr. Eddy died in 1906, Mrs. Eddy called on R. B. Bennett, whose ability she had always admired, to become a factor in the business. Mr. Bennett became one of the trusted advisers and a member of the board of the Eddy Company. Mrs. Eddy died in 1921 and in her will her brother and Bennett were designated as trustees of the property. The brother was left 1,007 shares and Mr. Bennett, 500 shares. This gave them control of the firm, as there were only 3,000 shares outstanding. When Joseph Shireff died in 1927 he bequeathed all his shares to Mr. Bennett, giving him the controlling interest.

Mrs. Dunlap, Mr. King's rumored bride-to-be, and the late Mr. Dunlap, who was 61 when he died, were childhood friends. Shortly after Mr. Dunlap made his first strike he married the girl with whom he used to walk to school. They had one son, Moffat, who is now living in Toronto.

Mrs. Dunlap owns one of the most beautiful farms and country estates in Canada—Donalds Farm. There the visitor's book holds names from every corner of the world. Mrs. Dunlap has acquired wide fame as an exhibitor of horses and fowl, all of which have been raised on the spacious farm.
