(A. P. by Guardian's Special Wire) PORTLAND, England, June 20.—The King came to this naval base today to see Great Britain's developments for sea warfare in action during a two-day inspection of the Home Fleet.

Tomorrow, from the battleship Nelson, the King will watch eight-barrelled anti-aircraft guns use wireless-controlled airplanes as targets. Called the world's most powerful anti-aircraft gun, this ordnance fires 500 shells a minute.

On Wednesday the King will test a listening device which is said to be able not only to locate a submerged submarine within a radius of several miles but even to tell whether it is British or foreign.

The King left London for his tour of Kent, both have served as officers in the navy. The occasion marks His Majesty's first visit to the fleet since the Coronation naval review in May of last year.

### Premier De Valera Adds To Majority in Ire Elections

DUBLIN, June 21—(Tuesday)—(CP Cable)—Prime Minister de Valera was swept back into power in Ire with the clear majority he demanded. The standing at 12.30 A. M. BST today (8:30 P. M. ADT Monday) showed his Fianna Fail Party with 76 seats against 56 for all other parties and only six seats still to report from Friday's general election.

Party leaders were awaiting full returns in Cork and Limerick, where the six missing seats are located, before giving their opinions on the result.

To say Mr. de Valera and his colleagues are gratified would be putting it too mildly. They are astonished because not even the most optimistic cabinet minister expected the country would give the Government such an overwhelming vote of approval.

All that had been expected was a majority of one or two, but apparently the electorate was convinced of the necessity of a stable government for the next five years, and disapproved the harassing attacks of the Labor Party which formerly was an ally of the Government.

### DEATH TOLL IN DISASTER REACHES 29

#### Search For Bodies Continues — Injured List Placed At 65.

(A. P. by Guardian's Special Wire) MILES CITY, Mont., June 20.—Known dead in the worst United States railroad wreck in recent years rose to 29 today as exhausted searchers located 13 additional bodies in the twisted debris in Custer Creek where the Milwaukee road's "Olympian" train plunged through a flood-weakened bridge early Sunday.

Of the 29 bodies, 16 were identified tonight. Twenty eight of the bodies were in Miles City mortuaries. The other was at Glendive, Mont., 50 miles away, where it was washed by the flood torrent.

J. R. Regan, divisional freight and passenger agent for the railroad said he believed more bodies would be recovered from a mud-filled tourist sleeper which was submerged for almost 36 hours, and from the nearby wreckage.

Continue Search

Crews continued searching the wreckage tonight. The car was so choked with mud and wreckage that it could not be moved. The Montana State Highway Patrol reported sighting a body late today in the water nine miles below the wreck, but it had not yet been recovered. This report led to the belief that some bodies swept away in the torrent may not be recovered for days.

Five of about 65 injured, taken to hospital in Miles City, were in serious condition. Most of the others were released after being treated for minor injuries.

Sleeper B was more deeply submerged than sleeper A, and several cars that plunged into the flooded creek, and the workers were not able to reach it until today.

Only two of the seven victims recovered from sleeper B today were identified immediately. Official said identification of the others would be difficult because of the 36 hours in the water, and because of bruised features.

Describes Disaster

Mr. Bernard Maguire of Milwaukee, one of the few passengers in Sleeper B to escape gave a vivid account of what occurred.

"I went into the women's lavatory to put on my hat, as the train was approaching Miles City, where I was going to get off," she said.

"The first I realized there was anything serious was when water started pouring into the car after a sudden jolt.

"I tried to open the door and couldn't.

"There I was—trapped like a rat in a hole, being put deeper and deeper into the water.

"Soon it was up to my waist.

"I tugged at the door, but it was no use. Then I tried the window.

"Finally it gave a little. I threw all my weight on it and then it squeezed through the small opening.

"For a moment I clung to the side of the sleeper, which was the middle one of three tourist sleepers on the train.

### Mediation Move In Conflict Seen By Developments

#### France Seals Frontier Against Arms Shipments — Rome Seeks To Bring Anglo-Italian Accord Into Effect.

LONDON, June 20—(CP)—Developments in Paris tonight were taken here as implying there might be a mediation effort in the Spanish civil war by major powers.

France sealed her frontier against all shipments of arms into Government Spain and at the same time was reported to have decided to send a diplomatic mission to the Spanish insurgent regime.

This came on the eve of a meeting of the sub-committee of the International Non-Intervention Committee where tomorrow Great Britain will press for a start of evacuation of foreign fighters from Spain and where the question of mediation of the conflict is expected to be raised.

The Spanish war was the focus of two other developments.

Britain announced a neutral commission of British, Swedish and Norwegian experts would try to determine whether air raids in Spain had definite military objectives.

In Rome, Italian Foreign Minister Count Ciano conferred with the Earl of Perth, British Ambassador, in an effort to discover means of bringing the Anglo-Italian Easter Accord into effect before the end of the Spanish conflict.

### PREBYTERIAN CHURCH HEAD DIES SUDDENLY

#### Rev. Donald MacOdrum Succumbs To Heart Attack At Brockville.

BROCKVILLE, Ont., June 20—(CP)—Rev. Donald MacOdrum recently elected Moderator of the Presbyterian Church in Canada, died suddenly at his home today of a heart attack. Minister of First Presbyterian Church here since 1925, Rev. MacOdrum was 74.

Mr. MacOdrum was in his pulpit at the Manse Street Church as usual yesterday and was apparently in good health until this afternoon when he suffered the heart attack from which he died 30 minutes later.

Born in Mira, N. S., he received his education at Sydney and Pictou Academies, Dalhousie University, from which he graduated in arts in 1887, and the Hallifax Presbyterian College at which he completed his studies in 1889.

Before his ordination Rev. MacOdrum taught school in Nova Scotia and his first charge was at Marion Bridge, N. S., after which he went to Moncton, N. B., and then in succession to Pembroke, Ont., St. Andrews, N. B., Halifax, and Brockville. He submitted his resignation from the Brockville Church early this year, effective at the end of September.

He served as chairman of the Brockville Presbytery and as moderator of the Ottawa and Montreal Synods. Rev. MacOdrum also occupied many important posts within the Presbyterian Church.

Mr. MacOdrum visited the Presbyterian missions in Trinidad, British Guiana, Japan, Korea, Manchuria and India and toured Palestine in 1928. He was president of the Brockville General Hospital Board in 1924 and was a Free-Mason and Oddfellow.

His widow, formerly Martha Jane Macdonald, of Halifax, survives with three sons, Rev. M. M. MacOdrum, Sydney, N. S., Alastair MacOdrum, Charlottetown, and a son, Rev. M. M. MacOdrum, Charlottetown.

### Japanese In Retreat From FLOODED ZONE

#### Tokyo Charts "No Man's Land" For Foreigners In China.

(By The Associated Press) SHANGHAI, June 21—(Tuesday)—Boats and rafts today carried Japanese forces in a retreat from the flooded battle zone of Honan Province where a few weeks ago they had advanced in tanks and trucks against wavering Chinese resistance.

The Japanese withdrawal was regarded as evidence that the expensive campaign against Chengchow and the Peiping-Hankow Railway as an avenue to Hankow had failed.

Reports from Hankow, provisional Chinese capital, said the Japanese forces, blocked by a disastrous flood of the Yellow River, were dividing some provinces southward to join the Yangtze River offensive against Hankow and others north into Shansi Province for a new try at penetrating the Chinese Communist stronghold, adjacent Shensi Province.

Hope To Cut Supplies

Only by an invasion of Shensi could the Japanese hope to cut off the Soviet Russian supply of munitions to General Chiang Kai-shek's armies.

Japanese troops from the washed out battlefields of Honan and from other sectors were reported concentrating in central Anhwei Province while Japanese planes bombed Yangtze River defenses to open the way for the drive up the Yangtze valley toward Hankow.

Heavy fighting was reported directly east of Luan, about 80 miles northwest of Anking, fallen capital of Anhwei. A Japanese column drove closer to Luan as part of a big manoeuvre to flank Chinese defenses upriver from Anking.

### Relations Between Germany And United States Strained

(A. P. by Guardian's Special Wire) WASHINGTON, June 20.—Relations between the United States and Germany are strained as at any time since the Great War and are giving cause for concern on both sides of the water.

Public speeches of mutual recrimination, a series of sharp diplomatic notes and a pronounced lack of cooperation indicate the tenseness between the two nations.

The United States has addressed four diplomatic communications to Germany in less than two months. Germany has not answered any of them.

Three of the communications dealt with Austrian debts. There was a note April 6, an "aide memoire" May 16 and a note June 9. But United States requests for a quick answer have, up to now, been ignored.

On May 11 the United States sent a note to Berlin protesting against the enforced registration of the property of American Jews in Germany. This registration decree was interpreted in many quarters as a preliminary to expropriation.

Three communications were sent on the subject of Austrian debts. Austria's obligations to the United States government and American citizens amount to only \$64,000,000, a comparatively small sum, and of this total, more than half has been bought back by Austrians.

But Secretary of State Hull is seeking to drive home a principle. The American note emphasized that, under international law, a nation which absorbs another should take the burdens with the particulars.

### Canadain Candidate In Nassau By-election

NASSAU, Bahamas, June 20—(CP Cable)—Harry Oakes, Canadian mining magnate and M.L.A. in Ontario, today announced his nomination to contest a by-election July 4 for a seat in the Nassau House of Assembly.

The candidates are offering in the western district, which is 85 per cent colored but which has about 300 persons on reclamation schemes for which the government of the island often planned but could not provide funds. He has been repeatedly honored by government of the island where he is generally popular.

The Japanese withdrawal was regarded as evidence that the expensive campaign against Chengchow and the Peiping-Hankow Railway as an avenue to Hankow had failed.

Reports from Hankow, provisional Chinese capital, said the Japanese forces, blocked by a disastrous flood of the Yellow River, were dividing some provinces southward to join the Yangtze River offensive against Hankow and others north into Shansi Province for a new try at penetrating the Chinese Communist stronghold, adjacent Shensi Province.

Hope To Cut Supplies

Only by an invasion of Shensi could the Japanese hope to cut off the Soviet Russian supply of munitions to General Chiang Kai-shek's armies.

Japanese troops from the washed out battlefields of Honan and from other sectors were reported concentrating in central Anhwei Province while Japanese planes bombed Yangtze River defenses to open the way for the drive up the Yangtze valley toward Hankow.

Heavy fighting was reported directly east of Luan, about 80 miles northwest of Anking, fallen capital of Anhwei. A Japanese column drove closer to Luan as part of a big manoeuvre to flank Chinese defenses upriver from Anking.

On May 11 the United States sent a note to Berlin protesting against the enforced registration of the property of American Jews in Germany. This registration decree was interpreted in many quarters as a preliminary to expropriation.

Three communications were sent on the subject of Austrian debts. Austria's obligations to the United States government and American citizens amount to only \$64,000,000, a comparatively small sum, and of this total, more than half has been bought back by Austrians.

But Secretary of State Hull is seeking to drive home a principle. The American note emphasized that, under international law, a nation which absorbs another should take the burdens with the particulars.
