GERMANY IS CALLING FOR MONEY HELP

RECORD SHIPMENT OF APPLES

HALIFAX, Sept. 17.—The record for the biggest single shipment of apples from a Canadian port is now held by Halifax, the Kanawha having taken 34,000 barrels of apples in her holds when she sailed Saturday for London. Nearly all were gravensteins. So full were the holds that the hatches had to be fastened down with special fastenings. Last week the Queen Wilhelmina took 29,700 barrels of apples for London. Nearly all these were gravensteins. They were for Hamburg and London. The Queen Wilhelmina held the record for Halifax up to Saturday. Last week nearly 100,000 barrels of apples, a record number for this port, were shipped.

Lieut Governor Rogers Officially Opens Annual King's County Fair.—A Good Showing in the Different Branches Receives Favorable Comment—The Prize List

Notwithstanding the unfavorable weather of yesterday. There was a fairly large attendance at the King's County Exhibition at Georgetown. Inside the Exhibition building, the showing of roots and grain was somewhat short of last year owing to the dry season in this section of the county. The floriculture exhibit was excellent, equally as good, if not better than that of previous years. In the Household Science Department there was a splendid exhibit of bread, cakes, and preserves. The fancy work exhibit was also good. There was a good showing of stock which was fully up to the mark in quality shown. The Exhibition was formally opened at 11 a. m. by His Honor Lieut. Gov. Rogers, who was introduced by the President of the King's County Exhibition Association, W. W. Jenkins.

Gov. Rogers in his address remarked that the exhibits of roots and grain were perhaps not up to last year, owing to the exceedingly dry season and agriculture consequently suffering from the long draught. Owing to the dry summer, the cut worm, potato bug, tussock moth and weevil were against the farmer, some of which evils it was impossible to provide against. He showed how the bread exhibitions were of more advantage than if centred in Charlottetown, because in competing with neighbors, there is a chance for every farmer, and the opportunity to compete with neighbors has a capital effect on the productions. He was glad the Department of Agriculture is doing its best to help the people in this work of Agriculture. From end to end of this Province, Gov. Rogers remarked, people have grown to much oats and then it is a mistake to sell away the fertilizer of the farmer. In conclusion he complimented the people of King's County and the Directors of the Annual Exhibition.

Prof. Ross, the next speaker, gave the regrets of Mr. Richards, Com. of Agriculture who was unable to be present. Mr. Ross concurred with the opinion of Gov. NATIONALS PLAYED LIKE HUMAN BRUTES

MONTREAL, September 16.—The lacrosse season closed here this afternoon on the National grounds with one of the most brutal exhibitions that has ever taken place in this city. The contending teams were the Nationals and Montreal. Montreal recently beat the Nationals on the Montreal grounds in a hard struggle and by doing so ruined their chances for the league championship. The Nationals were out for revenge and played for the man and not for the ball. The game finally resulted in their favor by a score of 3 to 6, the winning goal being scored in the last quarter, after three Montreal players had been knocked senseless and carried from the field. The Montreal twelve played lacrosse right through and seldom attempted to retaliate. But the French-Canadian twelve welded their sticks like bludgeons and cut down man after man. The officials handed out a number of penalties, but these were not enough to check the carnage and any severe measure would probably have resulted in a riot, the stands being crammed with thousands of French-Canadians cheering for the National team. So partisan was the crowd in fact that every time a Montreal player went down and from a blow from a National stick, Montreal players received a perfect ovation as he wended his way to the timers' box to serve a quite inadequate penalty. It was the west end of the city against the east end, and the extent of grounds, and the result of the exhibition will prove a bad blow to lacrosse in this city.
