Workers Received \$50,000 in Year

(Montreal Gazette) Approximately \$50,000 was paid to workers throughout the Dominion by the Canadian Handicrafts Guild during the past year, was the statement made yesterday at the annual meeting of the Guild held at the Mount Royal Hotel under the chairmanship of F. Cleveland Morgan, honorary president. More valuable work was done through the efforts of the education committee, activities were extended in every direction and the result as shown achieved a record year financially as in every other respect, it was reported. The guild participated in several exhibitions held in various centres, in addition to holding a highly successful exhibition of Canadian crafts at the Art Association where the record attendance of nearly 8,000 visitors was achieved. Examples of work were sent to the British Empire Exhibition at Wembley and to the Herbert Symonds' Parish House during the Diocesan Synod meeting, the Great Eastern Exhibition at Sherbrooke in August, Quebec Provincial Exhibition at Quebec in September. In addition, a Canadian Handicrafts Day was held under the auspices of the American Women's Club, at which Miss M. Phillips spoke on Canadian craft work, and an address was given by Lucien Barsalon on French-Canadian handicrafts from the economic point of view. The annual prize competition exhibited samples of work from 478 competitors, a lecture, being given by Professor William Carless having added considerably to the interest shown by visitors. Judging of handicraft exhibits was performed by Mrs. Hughes Charles at country fairs held during the year at Stanstead, Granby, Sherbrooke and Brome.

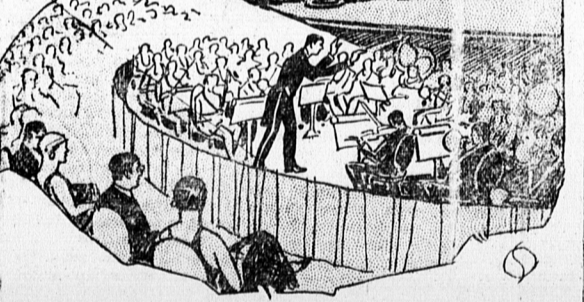
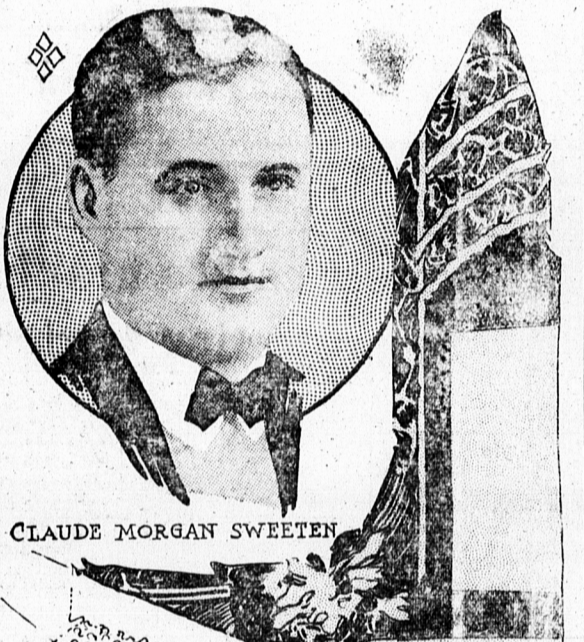

HOCKEY

The Nationals, the hockey sextette representing the town of Borden, invaded the dominions of the Cape Traverse Royals on the night of the 26th and carried away with them the long end of a 2-1 score. The game was fast in flashes and the result was in doubt until the last half-minute of play, when from a scrimmage the disc slipped over to A. Howatt, who was maneuvered on right wing and his deliberate shot beat the Royal goalie for the deciding tally of the evening. At intervals, the match developed unmistakable symptoms of pugnacity, but owing to the unerring vigilance of the referee who kept the game well in hand at all stages, those who came to exhibit their prowess in rough-house tactics, remained to cool their heads and their heels in the penalty box. Clever stickhandling, brilliant rushes and accurate and deadly shooting all played their parts to keep the promenade rooters inspired, but good, effective combination was scarce as Eskimos in Ecuador. For the winners, C. Howatt, the "Paper Tornado," though a trifle too anxious to exchange "teints" and "leads" with anything wrapped in purple and gold, played a whale of a game and was always dangerous. His back-checking was effective. A. Howatt, though not so fast as his teammate, kept his position well, and was always to be reckoned with around the net. The rest of the Nationals played a hustling, bustling game, and the victory, which finally crowned their efforts, though a trifle lucky, was not altogether undeserved. For the losers, the work of G. Waddell, the net guardian, stood out. He did not have a great many stops, but most of them were difficult. The shots that beat him came through the defence, and would have tested some of the goalies higher up. D. Irving, on the outer defence, gave all he had, which was plenty. His solo rushes were beautiful to see, but the defence usually bottled him up, before he could get his shot away. D. Bell, the other defence man, though favoring a badly bungled-up knee, was effective, his gatling gun shot notching the Royals' lone goal, and at other times serving to impress on the opposing custodian's mind that tending goal was no afternoon tea. Clint Howatt, the "Mighty Mite" played tricky hockey all the way, his dodging, twisting, backtracking style of play fooling the opposing forwards time and again, but he was unable to break through the rugged defence. W. Gardner, on the wing, displayed his scintillating speed only in flashes and could not seem to strike his proper stride. C. Waddell, the other wing man, worked hard and was particularly effective in pouncing on loose pucks in the vicinity of the opposing net. But his shots were not accurate and no damage resulted. On the whole, the game was well worth watching and provided many thrills to the raving partisans on the sides. Frank McFarland was the thirteenth man on the ice.

Larger Membership

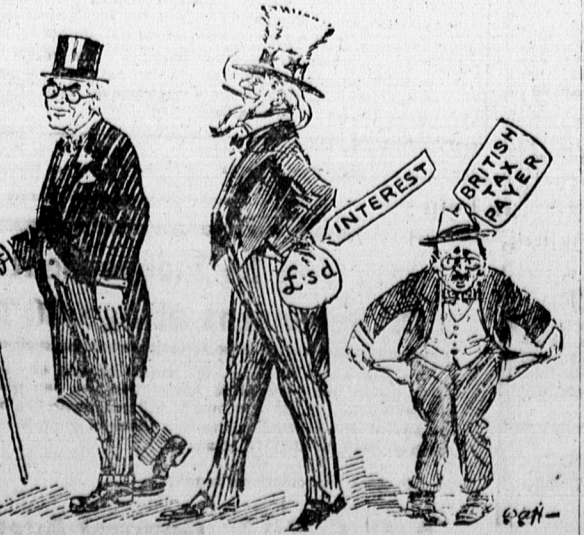
Great increase in membership was reported the enrolment numbering 102 new members. Five different children's classes are being conducted, many visitors having attended during the year and observed the various handicrafts fostered among foreign children under the supervision of the guild. The enrolment in these classes was reported to have increased, while a new class has been instituted among the English children, at the Iverley Settlement.

Great interest was manifested in the report of the extension committee, which described the fostering of craft work among the foreign colonies in Alberta and Saskatchewan and in rural districts in this province and in the east, many valuable examples having been acquired from centres in the Maritime Provinces. Reference was made to the large amount of craft knowledge coming into the country through immigration including metal and woodwork, pottery, leather, weaving and rug work which the guild is encouraging to the fullest possible extent in order to safeguard the artistic contribution of these foreign settlers to Canadian crafts.

Votes of thanks were passed to all who had interested themselves in the work of the guild and rendered assistance.

The property is known as the Anpeke Jan's and includes Trinity church, the Singer building, the New Stock Exchange and a large section of New York city property. Fortune In Silver Foxes But Bubble Exploded

PARIS, Feb. 4.—Tempted by what looked like rosy prospects of making fortunes a large number of gullible speculators invested in an alleged bucket-shop concern for breeding silver foxes, the promoter of which was Gaston Fontanille, but the bubble burst and there was a sequel to it in court here today when the shareholders in the concern were awarded 180,000 francs damages. Fontanille had disappeared in default of his presence in court he was sentenced to prison for eight years. Madame Keturneau, an alleged accomplice of Fontanille, who believed to have accompanied the promoter when he disappeared was sentenced to prison for three years. Several smaller fry in the silver fox breeding enterprise, including two men who are described as small bankers were each sentenced to prison for four months.
