TRURO WOMAN COMMITTED TO SUPREME COURT

Mrs. Arthur Fielding Faces Charge of Occasioning Actual Bodily Harm to Two Year Old Child.

(C. P. By Guardian's Special Wire) TRURO, N. S., Sept. 27.—Mrs. Arthur Fielding was committed today to stand trial in Supreme Court on two counts of occasioning actual bodily harm to two-year-old Buddy Dewey, at the conclusion of a preliminary hearing before Magistrate Harold Putnam.

On the witness stand a school girl, Freda Bartlett, 23, told the magistrate that the child had been kicked and beaten with various objects while he was being cared for by Mrs. Fielding.

Mrs. Minnie Dewey, mother of the baby, watched the proceedings closely, a sa crowd in the court room, mostly women, heard Magistrate Putnam commit the accused.

Fielding was admitted to bail of \$900 and was given the right to have her case added to the docket of the court which opens here next Tuesday.

Mrs. Dewey, a Truro factory worker, had boarded the two-year-old with the accused and had been cruelly and maltreated.

Freda Bartlett who also boarded at the Fielding home, said that she saw the child beaten with a stick. Later, she said, Buddy went to Mrs. Fielding asking for a kiss and the woman met the childish request with a "slap across the mouth."

In summing up the case for the defense, G. H. Vernon, Truro barrister, referred to the decision given by Mr. Justice L. D. Audette following the punishment of 10 Indian boys at the Shubenacadie Indian reservation school. Mrs. Fielding's punishment was not nearly as severe as that given some of the Indians, who would carry marks for the rest of their lives, according to physicians' testimony, Mr. Vernon argued.

Once when Buddy soiled his clothes, Miss Bartlett testified, Mrs. Fielding "struck him with a stick all down the body, and then hit him over the face and body with her hand. Once, she said, she saw the accused kick the baby and again had seen him thrown on a pile of brush.

A sister, Marion Bartlett, told of seeing bruises on Buddy's face and body when she undressed him and the next morning they were clearly discernible, she told the court.

Magistrate Putnam said he believed the evidence disclosed the occasioning of actual bodily harm and committed the woman to stand trial on the two charges as in the original indictment.

PUNISHMENT OF INDIAN BOYS JUSTIFIED

Commissioner Investigating Alleged Mistreatment at School Upholds Principal.

(C. P. By Guardian's Special Wire) OTTAWA, Sept. 28.—Nineteen Indian boys who were strapped at a school at Shubenacadie, N. S., deserved the punishment for lying and stealing, it was found by Commissioner L. A. Audette, former Judge of the Exchequer Court of Canada in a report to the Department of Indian Affairs.

The commissioner found the Indian pupils "undoubtedly and richly deserved the punishment to which they were subjected" and commended the principal's "minute inquiry which brought out the admission of guilt, theft and untruth."

In a philosophical mood, Commissioner Audette asked: "Where is the man who has gone to school in his boyhood and managed to get through without a taste of the strap? If he did, he must have been a true saint or a clever hypocrite who has been able to deceive his teachers."

Dotting the 54,000 word-report of the commissioner were comments which reviewed briefly by the commissioner. More than once, he said he favored strapping or caning. "There is no harm in punishment by the infliction of physical pain. All human governments rest, in the last resort, upon physical pain and it is mere cant to pretend it does not. Spare the rod and spoil the child has never been truer than in the present day when children are allowed to assume too much independence and do as they bid and care."

The testimony of each witness was reviewed according to the commissioner. Each of the 19 Indian pupils appeared before Judge Audette on subpoenas and gave evidence, under oath, in a most satisfactory manner, going so far, in telling the truth, as to admit untruthfulness and theft.

"The evidence abundantly and clearly establishes that these 19 pupils—as admitted by them—were guilty of both telling untruths and of stealing," Commissioner Audette sets out in his report.

For the good administration of an institution of the kind in question, it is obviously necessary to mix rewards with punishments, one being as necessary as the other. It is necessary and expedient to reward success and the pupil who does as well as he can. It is also absolutely necessary to punish the pupils who transgress the rules and regulations of the institution and who commit any breach of their moral and lawful duties. The punishment must be measured according to the gravity of the offence and not overlooking the complex intelligence of these boys who have all been brought up in the life of Indians (P. 13 of evidence).

Discipline might be maintained by thrashing with hand, cane and birch, as has been practised in England. There is no harm in punishment by the infliction of physical pain. All human governments rest in the last resort upon physical pain and it is mere cant to pretend it does not. It does no good to realize through experience this ineluctable fact.

The report continues: "It is quite lawful in Canada to punish a pupil by using physical force. R.C.C. CH. 36, sec. 63, provides as follows: '63. It is lawful for every parent, or person in the place of a parent, schoolmaster or master, to use force by way of correction towards any child, pupil or apprentice under his care, provided that such force is reasonable under the circumstances.' The strap, or what it represents, is an absolute necessity in the school."

The punishment to pupils for telling untruths and for stealing must be consistent with such serious offence and one that will be remembered. A weak punishment to these Indian pupils would have had no effect, would have been turned into derision and they would have laughed at it. It was necessary to give the strap in a reasonable manner, as was done and not in a way excessive when compared with the practice in England, where the strap, the cane and the birch are used. Reading the biography of the big man who moulded the destiny of the British nation, we invariably find a reference to these corrective punishments to which they were subjected in their school days.

Moreover these Indians, in terms of civilization, are children, having human minds just emerging from barbarism.

If strap, cane and birch are used in the white man's schools, as a fair human expedient, why can it not be resorted to with the Indians?

The law of the land has changed the environment of the Indians and they must be taught to adjust themselves to the new environment.

There was some endeavour, by un-fair practice, to undermine the reputation of the institution, to make a storm in a tea cup, by spreading the false news that the strap had been dipped in vinegar before using it. The evidence abundantly establishes that it was absolutely false. There was a prejudicial and malicious mind behind it all "cat en-fer" to hurt the school.

Commissioner Audette proceeds: "I suppose that the spreading of such false rumour, and enabling it to be published in the press, has realized its aim and conveyed the idea, with some people, that the punishment was excessive, but it was all the result of pure imagination. A famous French author has truly said,—Lie, lie, and something will always remain of it in the mind of the people."
