depended on many things which Sir Henry specified including golf courses, highways, country clubs, hotels and railway service. The Canadian National was doing its share. The Canadian Pacific Railway has been distinguished, Sir Henry said, "for the wisdom and sagacity of its management and as a railway man I believe that to be true." He therefore proceeded to compare the capital expenditures on hotels by the railway companies since 1923, explaining that it should furnish a yard stick as to the wisdom of the Canadian National in this matter. From 1923 to last December the C. P. R. had spent \$45,000,000 on new hotels and additions. The Canadian National had spent \$16,680,000, including the following sums, Pictou, N. S., \$200,883; Nova Scotia, Halifax, \$2,358,418; Charlottetown, P. E. I., \$689,460.

COMPETITORS, OTTAWA, Ont., June 5.—The time has come when the railways must recognize that the automobiles, freight trucks and passenger buses are competitors. The only way to deal with a competitor is to compete. This view was expressed by Sir Henry Thornton, President of the Canadian National Railways today before a committee of the House of Commons. The competitors should be under similar restrictions, Sir Henry thought.

TORONTO, June 4.—Rev. W. G. Brown of Saskatoon was unanimously elected Moderator of the Presbyterian Church in Canada on June 2nd. He succeeds Rev. Dr. Frank Baird, of Pictou, N. S., who was elected at Hamilton a year ago. Mr. Brown's election is regarded as a tribute to his own missionary enterprise and to the growth of the Presbyterian Church in Saskatchewan. Ever since his ordination in 1902 he has taken an active part in home missions, particularly in Saskatchewan, where the number of Presbyterian congregations has increased from 20 in 1925 to 110 at the present time. The new moderator began life on a farm in Huntingdon township Quebec. He was educated at Huntingdon Academy and McGill University from which he graduated in 1899 with first class honors in philosophy. At the Montreal Theological College he was trained for the Ministry, winning a B. D. degree in 1902. After ordination Mr. Brown spent five years as a missionary among the lumbermen of northern Ontario and the miners of British Columbia, and one year of post-graduate study at Glasgow and Edinburgh. In 1908 he was called to Red Deer, Alta., where he remained 10 years. Mr. Brown took an active part in the Church union controversy, touring Canada from coast to coast in 1923 as a leader of the anti-union cause. In July, 1925, he was called to lead a minority group in Saskatchewan, which formed St. Andrew's Presbyterian Church. Since that time he has also acted as convener of home missions for the Synod of Saskatchewan, superintending its rapid growth. He has been a member of the board of missions for 15 years.

THE NEWS of the death at his home in Georgetown yesterday morning of Hon. Paul A. Scully, will be learned with deep regret throughout this province. Mr. Scully had been in failing health for about a year and in January last, on the advice of local physicians, went to Montreal, where he underwent an operation in the Montreal General Hospital. He returned home about three weeks later. It was hoped that he would in time be restored to his former health, but the nature of the disease was such that it was a case of "hoping against hope" and despite the most devoted care and attention he steadily grew weaker until the end came yesterday. Mr. Scully was born at Souris West forty-six years ago, the son of the late Mr. and Mrs. Thomas Scully. As a boy he spent his mercantile career as a clerk with Stierns, Son & Company, Souris. Later he was employed by the late Archibald Currie, and about sixteen years ago joined the staff of J. J. Hughes & Company. He proved so efficient and dependable that in 1919 he became manager of the branch store of the firm in Georgetown. Here he conducted the business with marked success and also took an active part in own affairs and became a prominent member of the Board of Trade for King's County. In 1927 he was elected as Liberal candidate for the Georgetown district. He took a prominent part in the debates and the proceedings of the Legislature and was very highly esteemed not only by his fellow Liberals, but by all the members of the House. On August 4th last Mr. Scully was appointed a member of the Executive as successor to Hon. T. V. Grant. He leaves to mourn, a widow, nine children, four sons and five daughters, namely, Stephen, with J. J. Hughes and Co., Georgetown; Gerald, Joseph and Adolphus at home; Lucy, Agnes, Geraldine, Constance, Bernadette, also two brothers and two sisters in the United States. His sisters, Miss Mary Ellen and Miss Annie, arrived in Georgetown from Boston this week and were present with him during his last hours. JURY DISAGREES IN THEFT CASE AT S' SIDE

(Special to the Guardian) SUMMERSIDE, June 5.—The case of the King vs Frank Richards was continued at the sitting of the Supreme Court at Summerside on Friday before the presiding Judge, Mr. Justice Arsenault. The prisoner took the stand and testified in his own behalf, denying any complicity in the offence charged. He accounted for the watch by saying that he had bought it from Joseph Blanchard at potato digging time last fall and had kept it and given it to Mrs. Hope Corstain in February as a birthday present. He denied having been with Joseph Blanchard on the night of January 5th. He was cross examined by Mr. C. D. McCallum at some length. This closed the case for the defence. Mr. Lloyd G. Lewis then addressed the jury on behalf of the prisoner. The Attorney-General, Mr. Thane Campbell, K. C., summed up for the Crown, putting before the jury the chief points in the evidence. His Lordship, Mr. Justice Arsenault charged the jury and complimented Counsel on the manner in which they had conducted the case. Mr. Lewis, although a young lawyer had performed his duty in a very creditable way. In regard to the case His Lordship stated that it was not concerning the quantity of goods stolen that they would have to deal with, but whether the watch in question had been stolen. That was the strong point in the evidence for the Crown. In regard to the evidence of the alleged accomplice, in the first place you must dismiss from your minds that the fact that Joseph Blanchard had been given a suspended sentence, would have any bearing on this case. That was a matter entirely at the discretion of the Judge who had tried the case, who was a Judge of very high standing in the Province. The boy was young and had confessed to the crime and the court had no doubt taken these things into consideration. What concerns this case is whether his evidence can be considered as corroborated evidence or not. Whether he is telling the truth or the prisoner. He did not think Blanchard had anything to gain in implicating the prisoner in connection with the robbery. He had given a detailed account of what took place that night and the prisoner denies being with him. His Lordship stressed the point that evidence of an accomplice must always be regarded with suspicion unless corroborated with material evidence outside that of accomplice. In this case the evidence of Blanchard is corroborated by Mr. Shelton, who is a man of long business standing. He identified the watch as the one stolen from his store on January 15th and which Blanchard says was taken by him and the prisoner. The prisoner says he got the watch in October from Blanchard, if you come to the conclusion the prisoner got the watch from Blanchard then Blanchard's evidence is not corroborated. In that case it would be dangerous to convict. On the other hand if you consider the prisoner was lying, when giving his evidence, you must believe the evidence of his accomplice. Shelton identifies the watch as his, but there is just a possibility of there being two identical watches at that time. The jury retired at 12:51 p. m. When the court opened at 2:30, the jury returned and disagreed 7 to 5. The case of George Gallant, Daniel Gallant and Roy Grady then came before the court. This is a case of robbing with violence. The Attorney-General, Mr. Thane Campbell and Mr. Calvin D. McCallum are acting for the Crown and Mr. J. J. Johnston, K. C., and Mrs. L. G. Lewis for the prisoners. The jury were sworn in, after which the court adjourned until Monday at 11 a. m. Following is the jury in this case: George McKay, foreman; William Moffat, Kair Ramsay, Bruce Paynter, John A. RECEPTION Continued from page 1 reaches seventeen, he seeks a pal, boy or girl. One must deal with the individual, not with the gang in order to influence the gang. Any man that is dealing with boys must deal with the gang, must recognize the corporate spirit. "My advice to you is becken with the gang and treat them with cookies and apples," the speaker said. Do not always be dignified. Be a boy. One very interesting thing about boy psychology is that if the father and mother are sincere, the boy will not only attempt to be what the father is, but also what the father wants to be. Mr. Stiles asked all parents to assist the Scout programme. The Sunday School is more important than the Scout movement, Mr. Stiles believed. The home comes first, the Church comes next, and the school comes next in importance as regards child training. To the scout leaders, Mr. Stiles said that often scout leaders ask themselves if they are successful in connection with their group. "From Sunday unto Sunday" would be the subject on which he would address one leaders. Imagine meeting a boy on Sunday and ask him what he meant by "On My Honour?" Honour is one of the most important words in the English language. On Monday one asks his boy "Are you doing your good turn?" On Tuesday the leader asks himself "Am I using the patrol system in my group?" Scouting is not military. In scouting the training is that of teaching the boy how to lead the reverse of military training. The scouts are broken up into little groups of six or seven, called patrols. On Wednesday, the question should be "Am I teaching the boys to get out of doors, putting the "out" in scouting?" The people are too eager to get inside. Everything is now artificial. The scout movement has the objective of getting away from artificiality. "Are you using the investiture ceremony, the going-up ceremony in the group?" There is nothing like giving the boys their instruction, and taking from them his scout promise. On Friday ask "Am I giving the boys an opportunity for advancement?" On Saturday, the leader asks himself "Am I and my boys living up to the scout law?" Scouting is really applied Christianity. The hope of this world lies in Jesus Christ. We translated the command "Love ye one another" into co-operation. The result has been lighthouses, hospitals and many other things. "Can we get past group selfishness?" Socialization is another step in following Christ.
