The following was the President's address:

Rev. Chaplain, Officers and members of the Catholic Women's League:

Export Warehouse
Clauses In Act To Be Withdrawn?
Committee Again "Reports Progress" On Second Reading Of Prohibition Act In Legislature.

The Legislature met yesterday at 9 p.m.

Mr. Trainor gave notice that he will ask the Premier the following questions:

(a) In view of the widely different opinions expressed, concerning the liquor traffic in this province, through the press and otherwise, and in view of the representations made to the Government by the physicians of Summerside and Charlottetown, and in view of the statements contained in paragraphs 31, 32 and 33 of the Royal Canadian Mounted Police report; has any consideration been given to the advisability of ascertaining the will of the people of this province by referendum?

(b) If so has any decision been reached?

Mr. Trainor gave notice that he will ask the President of the Council to lay on the table the following information:

(a) Did the Government make any guarantee to any Bank in this province on behalf of the Potato Growers' Association in 1935?

(b) If so, in what amount? Table copy of guarantee.

(c) Has any reduction been made in the amount of guarantee?

(d) Has the Government any control over the management of the Association?

Hon. Mr. Allen presented a petition to incorporate Morris Bernard and Company Limited. A bill in accord with the petition was received and read.

The following bills were introduced and given first reading: The Constable and Fence Viewers Act (Hon. Mr. Dennis); The Division Fence Act (Hon. Mr. Dennis); The P.E.I. Fish and Game Protection Act 1937 (Mr. Cox).

The following bills were read a third time and passed: An Act to incorporate North American Property Corporation (Premier Campbell); an Act to further amend the Summerside Incorporation Act 1903 (Hon. Mr. Allen); the Varnishes Act 1937 (Premier Campbell); the Agricultural Encouragement Act (Hon. Mr. Dennis).

Premier Campbell moved that the House go into committee on further reading of the Prohibition Act.

Mr. Wright said the House had been assured by the Premier that the prohibition bill contained no new provisions and was merely a consolidation. The Guardian had made statements to a different effect, publishing clauses with the evident purpose of persuading the public that the Government was endeavoring to destroy the Act. There should, he thought, be "a law" against publishing statements of that kind. When a case was before the courts, any comments that would prejudice the trial were punishable, and it was "even more important" to ward against "false statements" regarding measures before the Legislature. He also referred to a broadcast by Mr. Harding which he said had given a wrong impression of the bill. He was blaming Mr. Harding but he should have known that the clauses he referred to were in the old statute, and they have apparently done no harm.

However, he could understand how Mr. Harding was misled. At the time of the passage of the Act these clauses were necessary, which have since been negated by the Dominion regulation. This matter had been taken up with the Premier and he understood the clause in question would not appear in the Premier's bill. Mr. Harding had been unable to review the bill before it went into committee, but these clauses had been allowed to stand over. His own attitude Mr. Wright said, was always in support of Prohibition. He would not sit silent if he thought the Act was going to be destroyed.

Mr. Saville indorsed "nearly all" of Mr. Wright's statements. He believed no change should be made in the law without consulting the people. In his opinion the present bill from the prohibition standpoint is "more drastic than the one it supersedes or any previous law we have had in this province." He commended Mr. Bentley's letter in the Guardian warning against re-enacting the export warehouse clauses, as deserving of very serious consideration. If it ever was the intention of the Government to do away with prohibition he would do all in his power to protest against it.

Premier Campbell said he wished to state "for the fourth time" that the bill was designed merely to consolidate the existing Act and amendments thereto. He objected to the headlines and article in The Guardian of Friday last, and to the omission in that issue of an explanation he had made as to the consolidating purpose of the bill.

On motion of the Premier, the House went into committee with Mr. Stewart in the chair, on further reading of the legislation.

Sec. 121 provides that "notwithstanding anything in this Act, the Court or Magistrate making the conviction may, instead of adjudging imprisonment for default in payment of any penalty, order that distress be levied on the goods and chattels of the defendant and in default of distress that the defendant be imprisoned for the term mentioned in such conviction."

Mr. Saville: "Has that ever been put in practice?"

Premier Campbell: "Not to my knowledge."

The section carried.

Sec. 129 provides that "any inspector or other officer authorized by him or by the Attorney-General as aforesaid, if he believes that any person is about to be kept for sale or otherwise in contravention of this Act, is contained in any vehicle on a public highway or elsewhere or is concealed upon the land of any person, may enter and search such vehicle, and may enter and search land in which the same is kept; or if he finds either upon the public highway or elsewhere any trunk, box, valise, bag or other receptacle whatever which he believes contains liquor for sale or otherwise in contravention of this Act, he may forthwith seize and remove the same together with the package or packages in which such liquor is contained, and the wagon, automobile, motor boat, row boat, sail boat, or any other conveyance whatsoever in which the said liquor is being carried to be forfeited and dealt with by the Attorney-General in any way or manner as may be ordered by a Magistrate having jurisdiction in the place where such liquor is found."

Mr. Saville said complaint was made to him by a man who never handled liquor, that on two occasions his wagon had been stopped and searched. "I think the inspector should make sure that the information was right," he said, "because it makes for a certain amount of resentment against the law."

Mr. Saville: "No, these things were done in broad daylight."

Premier Campbell: "I quite agree

Mr. Dennis is new to Charlottetown audience as a Chorus instructor and director. Mr. Potter Interviews Hon. W. H. Dennis
Hon. W. H. Dennis, Minister of Agriculture, had a conference in his office on Monday with Mr. H. S. Potter, representative of the Hornby Plan, well known British Family Settlement Policy. Mr. Dennis invited the Hon. W. H. Dennis to be present at the conference.

The conditions of this scheme have to a very great extent been published in the press already. The Minister, however, states that the parties behind this movement are willing to buy farms outright, paying cash for same. They will undertake to supply livestock and equipment to successfully carry on the farming and will, where necessary, erect buildings. The immigrant coming out will be stationed on the farm for five years, after which period, if he has succeeded and made good on said farm, the settlement policy provides for securing another farm for him and will enable him to pay for same on a long period of credit. Should the immigrant at any time be unsuccessful in his operations and become for any reason a charge to the province, they guarantee that they will immediately take charge and return him to his home at their expense.

These parties are willing to buy from fifty to one hundred farms in this province to be used as above described.
