Jury Fails To Reach Verdict In Liquor Case

A trial jury last night, for the second time failed to reach a verdict in the case of John (Tommy) Galt and conspiracy to sell alcoholic spirits. This case has been proceeding in the Supreme Court at Summerside since Tuesday last week.

Yesterday morning the jury was addressed by Mr. P. J. Hughes, K. C., for the prosecution and by Mr. J. Johnston, K. C., for the defence. The whole afternoon was taken up by address of the Chief Justice and at five o'clock the jury withdrew and court adjourned till seven o'clock. The jury returned at seven and asked a question of the foreman at 7.10 they again filed in the request of the court in an endeavour to reach a verdict. They finally returned at 8.10 and the foreman said he saw no possibility of agreement being reached. The final standing of the jury was 10 for conviction and two for acquittal.

At the conclusion of the address to the jury by the Chief Justice, the jury was asked to consider two questions. First, was there, according to the evidence, an agreement to manufacture illicit spirits? Second, if the answer to the first question was yes, was the accused a party to the agreement? When the jury foreman first reported a disagreement, he said the jury was unanimous in reply to the first question which was, yes. His Lordship then said, "if there was as you have found an agreement for the manufacture of illicit spirits, the question that remains for you to decide is if the accused was one of the parties to the agreement. To me the evidence that conclusion would not be difficult to reach because the evidence seems to indicate that the accused was the director of the operations. However, that is only my opinion, you gentlemen are final judges of the fact."

When the jury again returned without decision the court said that he felt they had answered the difficult question. The real substance of the case was whether the accused was implicated or not but whether the whole thing amounted to a conspiracy. The defence did not contend that the accused was not implicated but that the whole thing was a conspiracy. You have found that there was a conspiracy, my interpretation is that if there was the accused was the instigator."

The Chief Justice then asked the jury to retire again and when they returned they announced their inability to reach a decision. A number of counsel for the prosecution then asked that the jury be polled but this was refused by the court. The court then gave counsel for the

Three million cases is nearly one hundred million dozen eggs which is one-third of Britain's pre-war total imports and equals the quantity shipped annually by Denmark to Britain in pre-war days.

Canadian producers must therefore themselves to meet that competition, said an official of the Dominion Poultry Producers' services yesterday.
