**LONDON LETTER**

By Pantou House.  
(By mail.)

LONDON, Nov. 22.—Canadian and other overseas visitors in London on Oct. 29 during polling hours (8 a.m. to 8 or 9 p.m.) were asking what had happened to the General Election which they had understood was in progress. The fact is that the London best known to the visitor—that is, the City and West End—takes elections with great calm, even in those constituencies where a contest is being held; and this year the members for the City were returned unopposed. If one is looking for flags, favors, posters, slogans, loud-speakers (the mechanical kind) or decorated motor cars, it is necessary to seek in the "boroughs" and suburbs.

From about 10 p. m. onwards, however, there was not much doubt as to what was going on. Practically all the big hotels and restaurants had made arrangements to let their visitors know the state of the poll, as results came in from the constituencies. Of the 615 seats, about 30 had been already filled without a contest, and about 200 of the remaining districts knew their fate during the evening, and early morning. One hotel had the outlines of the Houses of Parliament sketched on a canvas seat, and up the walls the figures of the three party leaders were seen to be climbing.

In Trafalgar Square, Oxford St., and a number of other roomy streets and places, the results were announced by moving electric signs, by lantern screen, or by powerful megaphones, as they came in in batches of two or three. Huge crowds stood for hours with the usual British good humor; enjoying the proceedings with the music of whistles, rattles, concertinas and tin cans.

The British Broadcasting Company's election bulletin was relayed to all provincial stations, and heard in at least a million homes all over the country. Great numbers of people are said to have purchased wireless sets within the last few days, in order to share the pleasure of receiving their election news "hot" and comfortable.

Over one and a half million people have paid sixpence at Wembley to see the wonderful dolls-house presented to Queen Mary by the artists and craftsmen who decorated and furnished it. This means that Her Majesty will have \$180,000 to distribute to her favorite charities.

"The success of the Queen's Dolls' House in the case of charity, has inspired a large public men interest in the hospitals (which, we may remind Canadians, are run on the voluntary system in this country) to have a model of the Houses of Parliament prepared for exhibition. The work has been given to a famous wood-carver, to be carried out in oak.

Although the model is to be only on a half-inch scale, it will be 40 ft. long, 31 ft. 6 in. wide, and 15 ft. in height. "Big Ben's" clock-face will be 1 1/2 inches across. The carver estimates that the work will take him about five years, and that the cost will be somewhere about \$225,000. Twenty-two men will be engaged upon it. The walls are to be made of oak blocks, 6 in. by 2 1/2 in., faced up to imitate the joints of the original stonework.

If Wembley is opened next year, the model will go there, and visitors will be able to watch its growth. When completed, it will be first shown in London, and will then make a round of the big provincial cities. The local hospitals will benefit by the entrance money wherever it is shown.

On Oct. 29, 1463, Sir Walter Raleigh was executed in Old Palace Yard, Westminster, now the wide open space which separates the west end of Westminster Abbey from the House of Lords. He was buried only a few yards away, in the church of St. Margaret's.

Canadian visitors who wish to see something of the London that Raleigh knew will go to the splendid old Hall of the Middle Temple, hardly changed since his time. No trace is left of Durham House, near the Strand, lent to him by Queen Elizabeth until he fell into disgrace for marrying her maid of honor an almost unforgivable crime in the eyes of the elderly sovereign, whose "lovesick" swain he continued to call himself. He expiated it, more or less, by some months of imprisonment in the Tower in 1592.

Early in the reign of James I. Here he prepared a hand made balsam of Gambia, which was a specific against all human ills, and contained, among its 29 ingredients, ground pearls, musk, mint, mace, red roses and viper's hearts. Later, all these privileges were withdrawn by a new Lieutenant of less kindly nature.

**Strict Regulations For Dance Halls**

WINNIPEG, Nov. 22.—Sentimental couples may well reserve their embraces for places other than dance hall floors. Furthermore, keeping moving is an important part of the proceedings. These two deductions are drawn from a regulation which has been recently sent out to proprietors of city dance halls by the license department, which deals in very specific regulations, and outlines in close detail exactly the kind of motions dancing couples may engage in, the extent to which they are allowed to stand still and where their hands must be placed at the middle of his partner's waist and her left arm must not encircle his neck.

The regulation was sent as a from letter written by F. Kerr city license inspector, as a result of complaints received by him improper dancing in certain city dance halls. The adherence to the code of action set out, he contends, will keep all dancing up to a high standard of morality.
