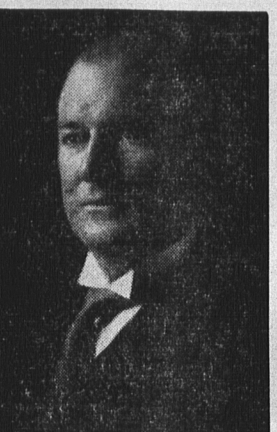

Col. G. Peacock Gov't asked To abolish Liquor tax

"I was tremendously impressed with the fine bearing of the Canadian Army in England," Col. George Peacock, Chief Secretary of the Salvation Army in Canada, Alaska, Bermuda, and Newfoundland, declared in an address in the Salvation Army Hall last night.

The subject of his address was "England as I saw it." The speaker returned from the Old Country several weeks ago after an extended tour in connection with the Army War Work.

A large number of citizens gathered in the Hall last night to listen to the talk His Worship Mayor B. Roy Holman, presided and welcomed Col. Peacock to Charlottetown. The welcome on behalf of the province was extended by His Honor, Lieutenant-Governor B.W. LePage.

Col. Peacock, who is visiting this province for the first time, referred to it as a "sacred spot" because of the events which were shaped here. He prefaced his remarks with the following tribute to the province: "Prince Edward Island, although the smallest province geographically, has been mightier in its influence on the nation than any of the other provinces in Canada."

He then went on to recount his experiences on his recent visit to England. The ship he was to sail on was delayed a week in an East Canadian Port. They sailed on a Monday and on the previous day he heard Lord Haw Haw, broadcasting from Germany, announce that the ship had been sunk. The names of well-known passengers were listed by Lord Haw Haw and the location given for the sinking was about the exact spot the ship would have been had it sailed on schedule. Somebody at the East Canadian Port had sent information to Germany but the Germans were fooled by the delayed sailing.

Incidents of this sort, encountered by the speaker, supplied evidence for the necessity of maintaining secrecy. For this reason he was not free to mention some things which would be of interest.

Col. Peacock briefly told of the hardships endured on the trip across the Atlantic. The coldness experienced on the liner, which was built for warmer climates, was especially in the North Atlantic, was intense. Then there was the constant threat of submarines, and later the bombers, then later still the mined waters near the other side. He made the return trip in a small steamer which was not accompanied by a protective convoy.

While in England, where he had gone primarily to see the work being done by the Canadian Salvation Army workers, he saw a great deal of the Canadian troops and their leaders. On all sides he heard the Canadians lauded by the English.

Referring to the criticism here that the Canadians are not in action, he said that both the Canadian and English are in action. They are protecting England from the threat of invasion. If any invaders visited the Old Country the first to meet them would be the Canadian soldiers and he felt satisfied that if this took place the Canadians would write another splendid chapter of achievement.

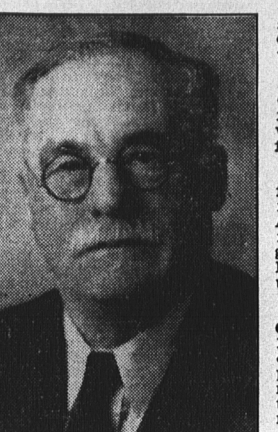

Temperance Federation Presents Resolution At Meeting With Executive Council. Prohibition Enforcement Discussed.

A delegation of the P. E. Island Temperance Federation waited on the Premier and the Executive Council yesterday morning and discussed among other matters the taxation of liquor for revenue purposes. The delegation presented a resolution passed at a recent meeting of the Federation, asking for the abolition of the "Health Tax", a ten per cent tax on liquor. It was contended that a tax on liquor was a "vicious principle" which could not fail to fasten the liquor business in the Province, and that the tax might momentarily reduce the sales of liquor through increasing the price the eventual result would be the undesirable condition which prevails in other provinces. Ontario and Nova Scotia were cited as cases of provinces which depended on liquor revenues, and which could scarcely continue without them. Ontario had opposed national liquor restrictions, fearing the loss of revenue, despite the existence of a crisis which calls for drastic restriction. The Premier pointed out that the matter was one which the legislature alone could deal with. The sales from the vendors' shops showed a decrease in the province, as compared with those of a few years ago, whereas all other provinces had greatly increased sales.

Inquiry was also made of the Executive Council as to the use made of the ticket of leave. It was stated that old offenders were not allowed tickets of leave, and none were ordinarily considered until the prisoners had completed half his sentence, and then only in rare cases, where there was some unusual circumstance.

The delegation discussed with the Attorney General matters of law enforcement, and urged the strictest and most thorough enforcement possible. It was asked if the force charged directly with prohibition enforcement could be increased. Possible amendment of the section of the law regarding the padlocking of bootleggers' premises was also mentioned as a way to make the Prohibition Act more effective.

The Federation promised full support of every effort, put forth with a spirit of initiative, and voiced the assurance that the people of the province were desirous of seeing the Prohibition Act strictly enforced.

Regarding law enforcement the Premier intimated definite action would be taken on certain suggestions.
