**HOTTEST THIS SUMMER**—Monday besides being one of the warmest Labor Days ever experienced in this province, was one of the hottest days this summer—a summer unusually hot—the thermometer registering as high as 84 degrees in the shade. Gormley escaped from the Queen's County Jail more than a year ago, was arrested in Halifax on a charge of robbery, and, on release from jail there recently, was again arrested and brought back to Charlottetown.


