MANY HOCKEY RUMORS IN CIRCULATION

When the next international Hockey League season rolls around there will be many new players in Pittsburgh and Syracuse, it reports now in circulation are not unfounded. Manager Mickey Roach states frankly that he will retain only four of the players who were Syracuse colors last year, and that he is determined to assemble a contender for the title. The Pittsburgh situation is different.

In the campaign which closed recently Pittsburgh qualified for the championship play-offs, and then lost every game—six in a row. It is said that there was a complete lack of harmony in the ranks, and that President Roy Schooley has decided to retain only three players—Tony Gregg, Gordon Fraser, and Goalkeeper Abbie Cox.

"Shorty" Green, one of the smartest players hockey has produced was in the city yesterday, and was non-committal when asked if he intends to return to Duluth, where he has been manager for two years. He, however, said that he was perfectly satisfied with conditions in the Lake Superior city, and he is confident that the American League will make great progress.

Frank Carroll, who led the Springfield Indians to three Canadian-American League championships in five years, has not made known his plans for next season, even if the announcement has been made from Springfield that Carroll has resigned. This capable pilot should have little trouble getting located. His record stands favorable comparison with the best ever established.

Herb Mitchell's name has been prominently mentioned in connection with the appointment of a manager by the Montreal Maroons. It is said that he would work in conjunction with "Buck" Boucher, last year's coach, and that Duncan Munro is not anxious to take charge again. In Mitchell's four-year managerial regime at Windsor the Bulldogs won two titles.

SECESSION

If the Maritime Provinces disregarded the Allan Cup and handled their play-offs in the old way, which was in effect before C. A. H. A. methods were introduced, there would be fewer deficits and a longer hockey season for all clubs and with a more sustained interest generally in hockey, the writer believes. As things are run now the clubs that stay in the play-downs prosper and the others have their season's play curtailed to such an extent that deficits are almost inevitable. With artificial ice rinks and the Maritime Championship the ultimate goal of the clubs, the hockey season in the Maritimes would extend from November 15th until the last of March, with from fifteen to twenty home games for each team exclusive of the play-offs which could be handled in the same manner as those of the National Hockey League—the greatest producing system yet evolved.

SUNDAY EVENING SERVICE — On Sunday evening at nine o'clock, a religious service of unique impressiveness will be held in the Canadian National Hotel, at which the Gideon Bibles, to be placed in the guest rooms, will be formally presented and dedicated. The Gideons are an Association of Christian commercial travellers, who have set themselves the task of placing a Bible in each hotel guest room. Already 1,125,000 have been placed in the hotels of America and since the foreign work was begun three years ago, several thousand more have been placed in India, China, Japan, Korea, Egypt, Palestine and South America. In Canada, 70,000 have been placed, 7,000 of these being in the Maritime Provinces. When Bibles are put in a new and important hotel, a formal service of presentation and dedication is held, and such an occasion will be held in Charlottetown's new hotel on Sunday evening. Premier W. M. Lea will preside and to illustrate the interdenominational character of the Gideons representatives of the various churches will take part. Rev. Dr. A. C. Vincent will offer the opening invocation, and the prayer of dedication will be offered by Rev. Dr. Ramsay. The Bibles will be presented by Rev. H. D. Raymond, the Scripture lesson will be read by Rev. Moorehead Legate and Adl. A. W. Martin of the Salvation Army will pronounce the benediction. Mr. J. Green, of Toronto, the Canadian Secretary of the Gideons, will speak briefly of the work of the Gideons, and the musical features will be presented by Mrs. Keith Rogers, pianist; Miss Thelma Teed and Robert Hyndman, violinists; and Miss Margaret Sterns and Charles Earle, Soloists.

man to fill the position of Attorney General. PREMIER LEA: That has been done.

HON. MR. STEWART: I am asking when was that Order-in-Council made?

PREMIER LEA: He received his commission of appointment, but I can't tell you the exact date.

HON. MR. STEWART: I assume his employment would begin from the time of his defeat in the by-election. Is that correct?

PREMIER LEA: Yes.

HON. MR. STEWART: Then my hon. friend was far astray when he said last May.

PREMIER LEA: I thought you said when he was sworn in first.

RADIO HEARING

HON. MR. STEWART: There is another matter that relates to the office of Attorney General about which I wish to make some inquiry. I would draw the promoter's attention to a Canadian Press despatch, dated March 7 last, which reads as follows:

OTTAWA, Ont., March 7.—C. L. Moyer, Barrister, who appeared in the Supreme Court of Canada a few days ago on behalf of the Province of Prince Edward Island, at the time a date was set for hearing the radio reference, stated he had been retained by Hon. T. A. Campbell, Attorney General for the Province. Mr. Moyer had been asked to comment on a statement made yesterday in Charlottetown by Premier W. M. Lea in which the latter said the Province was represented without the authority of the Government.

I would like to get some information with regard to that despatch. Was this statement made by Mr. Moyer or was it not? Was he engaged by the Attorney General on behalf of the Government, or was he not?

PREMIER LEA: When that notice first appeared I was just called by phone and asked if the Government had engaged any person to act in our capacity. Mr. Campbell, I think, was in Ottawa at that time. The report was correct that the Government had not asked any person to appear. I learned afterwards that the Attorney General, knowing it would be necessary, perhaps, for the Government to have an opportunity of pressing the case of the Government, asked Mr. Moyer to put in whatever notice was necessary so that there could be a hearing for the Province later.

HON. MR. STEWART: Then I assume that Mr. Moyer appeared on behalf of the Province?

PREMIER LEA: Well, he was there, appearing for some other Province, and he did what was necessary.

HON. MR. STEWART: Does my hon. friend know what other Provinces he was appearing for?

PREMIER LEA: I don't know.

HON. MR. STEWART: My information is that this same Mr. Moyer happened to be acting as Ottawa agent for Mr. Campbell in the Supreme Court of Canada in a case which he had there personally. Does my hon. friend know whether that is correct or not?

PREMIER LEA: I don't know anything about the private matter.

HON. MR. STEWART: That is the information I had. It is always necessary, as my hon. friend may know, when an attorney here has a case in the Supreme Court of Canada that he empower an agent at Ottawa to do the necessary filing, etc. Has any money been paid to Mr. Moyer by this Province?

PREMIER LEA: Approximately \$25.00.

HON. MR. STEWART: I noticed recently that the hearing is now going on with regard to this radio controversy. Is this Province being represented?

PREMIER LEA: Well, as far as I know the Attorney General is looking after that. I asked him about that matter, to put in whatever clearances will be necessary so that we could have a hearing.

HON. MR. STEWART: Then my hon. friend cannot tell me whether we are being represented now by counsel at the hearing?

PREMIER LEA: Not without consulting the Attorney General. I could get the information.

HON. MR. STEWART: It is rather an important thing for us, don't you think?

PREMIER LEA: I will get the information before the House rises.

SHERIFF'S FEES

HON. MR. STEWART: There is another matter that I will refer to under this heading. I have here a return in answer to questions on the order paper with regard to the expenditure at the last November term of the Supreme Court at Summerside. The amount was \$1,284.17. (Mr. Stewart read the itemized list.) There is one expenditure there that I would like to draw attention to. That is: Sheriff, \$164.02. The items are not given, but I think an ex-

penditure of that kind is quite unjustifiable. My hon. friend is aware that the Sheriff is paid a salary of \$600 a year. In addition, for all the legal work that he does, such as serving writs or levying executions, he is paid over and above his salary. I have always understood that the \$500 was for his attendance at the Court and other incidental things; for, of course, this Province is not wealthy enough to make him a present of \$500 for nothing. He is supposed to earn his salary in some way, and I have always understood that this is what it was paid for. Why, then, should he be paid \$164.02 extra?

PREMIER LEA: I have spent most of the afternoon trying to get details of these items, but that is one that I haven't gone into. I will get the information for you, though.

FALCONWOOD SKELETON

HON. MR. STEWART: There was another matter referred to last night in the Budget debate about which I wish to make some enquiry. I refer to the unfortunate affair that happened near East Point. It was stated that the coronor's jury instructed that a further investigation should be held. I would like to ask whether anything has been done along that line.

PREMIER LEA: The jury made its recommendation after the investigation had been made as thoroughly as it could be done.

HON. MR. STEWART: Then, of course, they could not have been satisfied with it.

PREMIER LEA: I know they made a recommendation, but my hon. friend knows that his body was found a few years after, and when the investigation was held at that time, further evidence would be impossible.

HON. MR. STEWART: My hon. friend knows that one like himself or myself cannot answer that question. For my own part I have never gone into the evidence. I do know, however, that in many cases of such a kind evidence comes out years afterwards, by which even a murderer has been detected and convicted and made to pay the penalty. Even when the crime was fresh it was impossible, perhaps, to get the evidence. We have been placed before the jury in this case, but knowing the people of that vicinity as I do I am convinced that the intelligent men who formed that jury would not have made that recommendation unless they had some grounds for it. I would like to know whether any steps have been taken to follow that up, to see whether or not there was anything in their recommendation.

PREMIER LEA: Well, it was the opinion of the Attorney General that all the investigation that was possible under the circumstances was taken at that time. It would only be repetition unless new evidence could be thrown upon it, and it would put the country to a lot of expense.

HON. MR. STEWART: The cost would be very small. We waste money very much more readily than that, and in a matter of that kind it is not so much the cost that should be considered. You say that was the Attorney General's opinion; but unfortunately it seems to have been his earlier opinion that they should simply bury the remains on the spot, without any other kind of burial or investigation at all. That, I would say, shows bad judgment, to say the least.

PREMIER LEA: That was all right.

HON. MR. STEWART: It was not all right. It was a very serious mistake.

PREMIER LEA: I am not defending the judgment at that time. There was an error there.

HON. MR. STEWART: Precisely. And that makes one question the judgment that would do a thing of that kind. I am simply asking for this information. Does my hon. friend know whether any attempt was made to carry out the further investigation recommended by the jury?

PREMIER LEA: There was not any public investigation made.

HON. MR. STEWART: I presume the jury's investigation was a public one, but they recommended that something further should be done. That is what I am asking about.

PREMIER LEA: There was no further investigation held.

HON. MR. STEWART: Were any of the Provincial Police officers sent down afterwards, with instructions to investigate it further?

PREMIER LEA: They were put on the case. I can't remember at the moment just what their instructions were from the Attorney General, but they certainly were down investigating the case.

HON. MR. STEWART: After the jury brought in its verdict?

PREMIER LEA: I can't tell you about that, but I know they were investigating it as well as they could so long after that regrettable accident took place.

BURIAL CERTIFICATE

DR. A. A. MACDONALD: I would like to ask the Premier if there was

a burial certificate made out when the man was buried? PREMIER LEA: That can be ascertained, but I can't tell you off-hand.

DR. MACDONALD: Do you think there was?

PREMIER LEA: Well, there always is.

DR. MACDONALD: I know the law demands it; but I would like to know under whose name these remains were buried.

PREMIER LEA: Well, a clergyman really couldn't bury without that, could he?

DR. MACDONALD: But I would like to know, if possible, who it was. What name went on the certificate of death?

PREMIER LEA: Well, I could get the information, but that question could have been asked on the floor of the House.

DR. MACDONALD: The reason I am asking the question is because there is grave doubt in the minds of many people whether that man was from Falconwood or not. They do not know. The evidence was against that, to some extent. He may have been murdered; his remains may have been carried there.

HON. MR. LEAPE: Was there anybody missing?

DR. MACDONALD: There may have been somebody missing from Rustico, though, of course, some of them wouldn't be missed at once.
