Hume Will Get Six Months If He Shows Up Today

Charged with taking away Joseph C. Murphy, a child of eleven years from his father, Austin Murphy, and depriving him of the possession of the same, Geo. S. Hume, appeared yesterday morning before Stipendiary Magistrate K.F. Martin. In adjourning the judgment until today His Honor enlivened all details of the case with a broad hint, which created a surge of laughter in the courtroom, for Hume to take a foot in each hand and "beat it" while the beating was good.

The attorney general appeared for the Crown, the defendant having no counsel and pleading "not guilty."

Mrs. Mary Murphy, wife of the plaintiff, testified that Hume had rented a room at their house, No. 10 King St., for about three months. He was working pretty steadily all summer and paid \$2 a month for his room. He bought his food and witness cooked for him and witness cooked for him for him without charge. Hume left the house on Monday a fortnight ago after Murphy had told him he wanted the room. Woman Kills Clergyman and Then Herself

(Special to The Guardian.)
HAVER, Mont., Oct. 30.—The death of the Rev. Leonard Jacob Christler, widely known clergyman of Montana, and Mrs. Margaret Carleton in the Christler home yesterday were so plainly a case of murder and suicide by the woman that no inquest probably will be held, so the coroner and sheriff's office last night announced.

The pistol with which the two were killed was still clasped in Mrs. Carleton's hand and her finger was still on the trigger when he arrived in response to Mrs. Christler's call, so Dr. MacKenzie told the coroner.

Will Wear Dresses No Longer Than Seven Inches From Ground

NEW YORK, Oct. 30.—The ankle length skirt was officially and permanently removed from the wardrobes of three hundred thousand New York women yesterday by the action of delegates to the convention of the New York City federation of women's clubs, in voting unanimously to wear dresses no longer than seven inches from the ground. The resolution sounding the death knell of the long skirt, urged women everywhere to free themselves from apparel now being introduced and having edges that nearly swept into the ground, to carry germs laden into the home. The club women also urged that the garments be made sufficient material to permit perfect freedom of all parts of the body.

Two Castles in Ireland Burned

BELFAST, Oct. 30.—Antrim Castle, near Londonderry, the home of Viscount Massereene, parliamentary secretary of the prime minister of Northern Ireland, was completely destroyed by fire this morning.

Viscount Massereene is a descendant of the speaker of the old Irish house of commons. A maid servant perished in the flames, and others of the household had narrow escapes.

Mrs. Grace D'Arcy, daughter of the Most Rev. Charles Frederick D'Arcy, Protestant primate of Ireland, was forced to leap from a window to escape the flames. Among other guests of Viscount Massereene was Major General Cameron, commanding the forces in Ulster.

Sir Auckland Geddes Arrives in Ottawa

(Special to The Guardian.)
OTTAWA, Oct. 30.—His Excellency the British Ambassador at Washington, Sir Auckland Geddes arrived in Ottawa today, one of the Government's private cars being attached to the Grand Trunk train from New York. He was met at the station by Captain Balfour, Military Secretary to the Governor General.

He will be the guest of Lord Byng during his two days stay in Ottawa. This evening Sir Auckland will be honored at a state dinner at the Government House and tomorrow night at another dinner by the Government.

There is no pre-arranged program of official discussion, but while the Ambassador will confer with the Prime Minister. One subject is the proposed substitution of a treaty replacing the Rush-Bagot arrangement, the situation in regard to that being that the British Government has expressed its concurrence and the next action will be by the United States Senate.

It is stated that by its provisions armed vessels will practically disappear from the Great Lakes.

Soviet Soldiers Aid in Hunt for American

SIMBIRSK, Russia, Oct. 30.—Soviet soldiers have joined in the search for Philip J. Shield, the American relief worker, who has been missing from his quarters here for ten days. While the red troops are seeking traces of him along the valley of the Volga, the government authorities are seeking to interest the populace in the hunt for the young American.

His disappearance is being impressed upon the residents by announcements flashed on movie screens here and in nearby cities. These tell of the reward for finding Shield, give a description of him and ask anyone knowing of his recent whereabouts, to volunteer the information. Never before has this method of searching for a missing person been put into effect in Russia. It was done this time at the request of Joseph Dalton, district supervisor of the relief organization at Simbirsk.

Ex-Kaiser's Wance Evidently Has a Will Of Her Very Own

LONDON, Oct. 30.—Princess Hermine of Reuss, who is soon to become the bride of the former German emperor, seems to feel that while his secluded home at Doorn is a nice restful place and all that, she would not want to live there every day in the year. She is reported to have told William that she will be unable to stay at Doorn for more than four or five months each year.

The former kaiser is worrying a good deal over complying with her wishes for certain alterations in his home, according to despatches to the Daily News.

Recently the princess gave him some rather comprehensive indications of her views as to how the place should be changed. Accordingly William is doing his utmost to make the residence as agreeable for her as possible.

The Daily News correspondent says the wish of the former kaiser to have the bells of the neighboring countryside rung on his wedding day is not likely to be gratified.

\$300 License Fee Enforced Upon Trader by the City Yesterday

For non payment of his city tax of \$300 for a license for transient trader Philip Carter, a Jewish merchant from Halifax, appeared yesterday before the Stipendiary Magistrate, pleaded not guilty, but later paid a portion of the tax, promising the full payment at or before 11 a.m. this morning.

In the evidence taken in the case yesterday morning, Mr. J.F. Reardon, sample room proprietor, Queen Street, explained that he had rented his lower front shop, 26 Queen St. to Mr. Carter last week on monthly payment plan. The defendant had taken possession on Tuesday and had moved in his goods. He said he was going to run a dry goods store and that if business was good he would remain permanently. Business seemed to be rushing on Friday, but witness had no personal knowledge of any sales being made.

Shown a printed poster with his name at the bottom, advertising the sale of a bankrupt stock of high class ready to wear goods, Mr. Reardon said he knew nothing about it. He gave no authority to use his name and he did not understand how it came to be there. He did not himself sell merchandise of any kind. He had complained to Mr. Carter that the poster was creating a lot of talk and that it might get him into trouble. Mr. Carter said it had been printed just to show people where his place of business was. He might also have said something to witness about a printer's error, and that the poster should have read "J.F. Reardon's store" instead of "J. F. Reardon."

Evidence was given by Miss Constance Worth, employed on Friday and Saturday as saleswoman to the effect that business was very brisk Friday and that she had sold general merchandise, including women's clothing, blankets, children's wear, trousers and overalls. She had been paid off and had been told that if business continued good, she might come back Monday and there was a chance of being employed permanently. There were four or five other clerks in the store.

The plaintiff in this case was the City of Charlottetown, law Mr. Carter was obliged to take out a transient trader's license as he was not on the assessment list. This he had not done, though warned before the sale commenced. As Mr. Reardon disclaimed all responsibility for the poster his name to it carried no weight so far as evading the tax was concerned.

After a discussion of the matter in the afternoon between the defendant's counsel, Mr. Donald McKimmon, K.C., and the Attorney General who appeared for the City, Mr. Carter guaranteed the full payment of the license fee.

The city by-law (Cap. xxix, Sec. 4) under which the case came up, reads as follows:—

"No transient trader or other person who occupies premises within the said city for a temporary period, and whose name has not been duly entered in the Assessment Roll of the said City of Charlottetown in respect of personal property for the then current year, shall offer goods or merchandise of any description for sale by auction or in any other manner, conducted by himself or by a licensed auctioneer, or otherwise, within the limits of the said city, without or until he shall first take out a license from the said city and pay a fee of three hundred dollars for that purpose; provided always that this section shall not affect or apply to or restrict the sale of the stock of an insolvent estate which is being sold or disposed of within the said city where the insolvent carried on business therewith at the time of the execution of an assignment."

Red Government Is Established in Vladivostok

(Special to The Guardian.)
TOKIO, Oct. 30.—In Vladivostok, red flags are flying everywhere. A new government has been formed by Chairman Nitzelien of the People's Revolutionary Party, in the Maritime Provinces. He formerly was a municipal guard.

Observance of Armistice Day

OTTAWA, Oct. 30.—The "two minutes of silence" will be the express wish of His Majesty the King, he observed throughout the British Empire on Armistice Day, November 11. The Prime Minister received a cable to this effect from the Duke of Devonshire, secretary for the colonies, incidentally the cable is practically the first official message sent to Canada by the former Governor-General by virtue of his post in the Bonar Law cabinet.

OTTAWA, Oct. 30.—A telegram congratulating Captain Angus Walters and the crew of the Canadian defender Bluenose was despatched to Gloucester tonight by the Prime Minister, Right Hon. W. L. Mackenzie King, on behalf of the people of Canada.

Premier King congratulated the victorious cup defenders upon their victory, and also upon the fine spirit of sportsmanship they had shown during the contests.

OTTAWA, Oct. 30.—Alderic Bourgeois, 185 Montcalm street, Hull, son of a Hull city official, was convicted on four charges today in Hull Police Court, and sentenced to terms in jail that will aggregate one year, for violating the Quebec Liquor Act. Bourgeois had boasted that no officer had courage to prosecute him. He is believed to be one of the first of the big "men in the bootlegging business around here" to be convicted.

De Valera Calls Secret Session Of Dail Eireann

DUBLIN, Oct. 30.—Eamon de Valera has just made a new move by summoning the second Dail Eireann, which constituted itself the Republican Government and nominated the Council of State.

De Valera always has contended that the second Dail had never been formally dissolved. He refused to recognize the Provincial Parliament as replacing it, especially challenging the Parliament's capacity to interfere with political funds in the United States. His captured correspondents revealed his doubtful of his ability to establish a Republican Government, mainly because he could not count on support from the army.

Tonight, however, the publicity department issued an official statement, which showed that he changed his decision, and that the second Dail met in secret session. The following is its official report:

"The Dail Eireann parliament and government of the republic met yesterday in secret session, the former Deputy Speaker presiding. A clerk of the House was appointed. The following resolutions were passed:

"Whereas the Speaker and other appointed legislative officers, in disregard of their duty and in open disobedience to a mandamus of the Supreme Court, have refused to summon the Dail Eireann the duly elected president and government of the republic.

"And, whereas, notwithstanding their oaths and pledges to maintain the republic, these officers, abetted by other members of the Dail, have in this and diverse other ways endeavored illegally and unconstitutionally to serve the republic, and with foreign aid have joined in traitorous conspiracy and armed revolt with that intent, pretending to establish a so-called Free State and a provisional parliament, creatures of the illegitimate and despotic government, and purporting to destroy the independent sovereignty of the nation and the integrity of the nation.

"We, faithful deputies of the Dail for the whole of Ireland, and on behalf of all loyal citizens, by express wish of the soldiers fighting in its defence, call upon form President De Valera to resume the presidency."

The manifesto adds that the president appointed to council of state, the members of which are Austin Stack, Robert C. Barton, Count Plunkett, Laurence Ginnell, Sean O'Kelly, Mrs. O'Callaghan, Mary MacSwiney and several others.

Eamon de Valera, the Irish republican leader, in an excellent health, the publicity department of the Irish Republican organization today declared in contradiction to a report that Mr. de Valera was here in Dublin ill in a hospital.

There are no indications here of Mr. de Valera's present whereabouts.

A large force of irregulars attacked a National post at the Upper Bridge, Ballina, County Mayo, last night. After several hours' firing the irregulars withdrew. There were no National casualties.

Red Government Is Established in Vladivostok

(Special to The Guardian.)
TOKIO, Oct. 30.—In Vladivostok, red flags are flying everywhere. A new government has been formed by Chairman Nitzelien of the People's Revolutionary Party, in the Maritime Provinces. He formerly was a municipal guard.

The Chita army, a well disciplined organization; is guarding the immense stores of arms left by the Allies. The Far Eastern Republic Red army came with a vanguard of cavalry followed by infantry and artillery. The people met the invaders by waving red flags at them and showering them with flowers.

A supporter of the deposed Markulov government, who arrived in Kobe, declared that General Dietrichs, the defeated White commander, has established a base on the coast of Bay, which was considered impracticable, but that if the general was driven from there, he intended to retire to Kamchatka.

The Japanese papers congratulate their government on completing the evacuation of Siberia. They advocate the establishment of good relations with China. The report that such negotiations already are impending is denied by the foreign office.

Observance of Armistice Day

(Special to The Guardian.)
OTTAWA, Oct. 30.—The "two minutes of silence" will be the express wish of His Majesty the King, he observed throughout the British Empire on Armistice Day, November 11. The Prime Minister received a cable to this effect from the Duke of Devonshire, secretary for the colonies, incidentally the cable is practically the first official message sent to Canada by the former Governor-General by virtue of his post in the Bonar Law cabinet.

Liquor Laws in Quebec No Respector of Persons

OTTAWA, Oct. 30.—Alderic Bourgeois, 185 Montcalm street, Hull, son of a Hull city official, was convicted on four charges today in Hull Police Court, and sentenced to terms in jail that will aggregate one year, for violating the Quebec Liquor Act. Bourgeois had boasted that no officer had courage to prosecute him. He is believed to be one of the first of the big "men in the bootlegging business around here" to be convicted.
