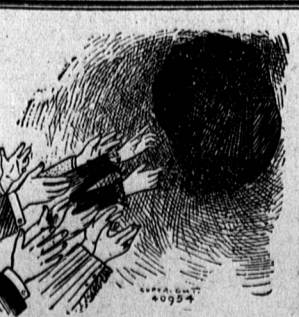

SENTIMENT OF LLOYD'S

That the outstanding characteristics of John Bull are pre-eminently hard-headed, practical and mercenary, appears to be the general conception of all outside his little island. As a nation of shrewd statesmen the English have left their mark upon the rest of the world. Equally true, however, although not so readily recognized, is the fact that no nation is more appreciative of sentimental customs or conservative of time-honored institutions than the English people. An illustration of British conservatism is found in a custom extant to-day in the headquarters of London. Lloyds, away back in the year 1791 was captured by Admiral Lutine, and added to the British navy as the contraband of war. Subsequently she entered the service of the mercantile marine, and while on her way to Hamburg with a cargo of bullion, sank with all on board. Some sixty years after the event, Lloyds undertook to salvage the cargo, and as a result of their efforts over £20,000 was recovered, and incidentally the ship's bell which bore the arms of Bourbon of France, and the ship's rudder. And if one is lucky enough to gain entrance to the underwriter's room at Lloyds to-day, one may see a great arm-chair fashioned from the under of the old Lutine, and perchance listen to the sound of the bell that for over half a century rested a hundred fathoms beneath the waves. This bell is always used to precede the announcement of special news concerning shipping. The announcer taking his place upon a small platform, when the loud tones of the bell has attracted attention, gives out the tidings, good or bad, and the men of Lloyds are never deaf to the brazen summons of that ancient bell, for as its vibrations cease, the chances are that some will shout for very ratification at a financial arrest reaped, or wilt and smoulder as they huddle down to figure out the loss that must be met.

THE PHILANTHROPY OF LLOYDS.

So much for sentiment, but there is another side of Lloyds that calls for notice. Fortunately or unfortunately, but nevertheless true, the mercenary Englishman demanding his pound of flesh cannot somehow run his business without allowing patriotic impulses and beneficent and philanthropic ideas to enter into the reckoning. Of course no credit is due to him for this sign of weakness toward which competitors charitably turn the blind eye. And in the vast avalanches of criticism hurled against Lloyds from time to time, one is led to wonder at the lack of appreciation of an element of that institution to which the whole world is debtor. It was Lloyds that established the first

Lifeboat service, subsequently adopted by every civilized country. It was Lloyds that headed the list of subscriptions to purchase the first boat that put out through the storm-torn wreck to rescue imperilled lives, and for over a quarter of a century Lloyds maintained the only life-saving service in the United Kingdom. It was Lloyds that originated in the year 1803 the great philanthropic and patriotic fund which for a century has provided homes and orphanages for the widows and children of men who lose their lives fighting the nation's battles on sea and land. It was Lloyds that initiated and supported in royal fashion the refugees, that have since become endowed, for the care of the maimed and crippled in the service of their country. It was Lloyds that, more than any other factor, brought wireless telegraphy to common use in the ocean marine from selfish motives no doubt you will say, and admittedly so, but nevertheless one of the most beneficent elements in diminishing the waste of human lives on the great deep. Only the history of to-morrow can tell the story fully of appalling disasters averted and catastrophes side-tracked by reason of the general adoption of wireless on ocean-going ships. Enough has been said to prove that in a large measure there is a heart that beats even in Lloyds Association. Outside of its efficiency as a business instrumentality, past history proves that the golden thread of finer impulses is closely intermingled with the duns and greys of its charter obligations.
