IN MEMORIAM

MR. ROBERT JENKINS

In the passing away on Saturday last of Mr. Robert Jenkins at his home in Mt. Albion, this province has lost one of her outstanding men who was widely known and greatly respected, not only in his own community but in this city and in other sections of the Island as well.

He was born at Mt. Albion on June 3, 1849, and was therefore in his 83rd year when he was called away to the Home Eternal. He was the son of Henry Jenkins and Hannah Jones, both his parents being worthy descendants of the splendid pioneers of this province.

Mr. Jenkins spent the greater part of his life in farming but was also engaged in other activities from time to time.

When a young man he conducted a store at Mt. Albion as well as attending to his farm. Later, in partnership with his eldest son, R. Harold Jenkins, he took over the grocery business formerly conducted by the late J. D. MacLeod at the corner of Queen and Grafton Street, Charlottetown, the new firm being known as Jenkins & Son. Subsequently Mr. Jenkins disposed of his interest to his son, who carried it on alone in that stand until the building was sold to the Canadian Bank of Commerce when he removed to a location further east along Grafton Street.

The late Mr. Robert Jenkins for many years was the very efficient secretary and salesman of the Cheese Board.

He was also for some time prohibition inspector for Queen's County, discharging his duties fearlessly, impartially and capably.

As one of the valuers for the Soldier's Settlement Board and the Canada Permanent Mortgage Corporation his business ability and sound judgment proved of great value.

The late Mr. Jenkins was a very ardent angler and sportsman and always took a keen interest in game conservation. He realized especially what a great asset the Island had in its trout waters, not only for the benefit of our own people but for tourists as well. This led him to take over O'Keefe's Lake stock it with rainbow trout and establish here as a resort the Rainbow Inn. This he conducted for three years until failing health obliged him to give up the enterprise about a year ago.

The need of preserving our feathered game also occupied his attention and a number of years ago he was instrumental in having pheasants brought to this province.

He also had a number of beavers placed on a stream in Queens County.

Mr. Jenkins, was in every respect a true Christian gentleman of high personal character, and more than average intelligence, being straightforward, earnest and sincere, a kind neighbor, and a warm and sympathetic friend. For many years he was a deacon in the Baptist Church at Hazelbrook. A sturdy God-fearing man, he put into practice the principles of the great Master whom he devotedly served.

As a temperance worker his name will go down in the history of Prince Edward Island, and despite great personal sacrifice, he never wavered in working for the great cause. To every movement tending for the moral and material welfare of the community he also gave his active support. He has set an example that can be emulated by the present generation.

Mr. Jenkins possessed a splendid physique and abounding energy and vitality, but about a year ago his health broke down and he had been bedfast since Easter. For the past few weeks he steadily grew weaker until just before dawn on Saturday his spirit passed to Him who gave it.

Mr. Jenkins was twice married first to the late Miss Jessie Currie of South Shore, and again to Miss Margaret Louise Young, of Emscliffe, who survives him.

Of the first family the following sons and daughters survive: R. Harold, of Charlottetown, formerly Mayor of this city and Liberal federal member for Queens County, Ludlow of Marshfield, J. Daniel of Charlottetown, Henry M., of Calgary, Parkman of Hillsboro, Frederick of Edmonton, Earl of Cross Roads; also two daughters, Winnifred, wife of Mr. J. H. Seelye of Panama, and Margaret J., wife of Russell Bell, West Royalty.

Two children died in infancy. Of the second family the following survive: J. Spurgeon of Mt. Albion Arthur and Chrystie of Calgary; Gilbert, William Robert, and Edna at home; Hannah Belle, wife of J. W. Ballew, Mt. Albion and Victoria, wife of Roy Howlett, Annapolis.

Mr. Jenkins also leaves two brothers, Boswell of Mt. Albion, and George at Mt. Herbert; and three sisters, Mrs. Henry Smallwood of Summers, Mrs. W. J. Carver of Hazelbrook, and Mrs. Mary Dingwell of Durell, also 38 grandchildren and 8 great grandchildren.

To the bereaved family who mourn the loss of a loving and generous husband father, the Guardian extends its sincere sympathy.

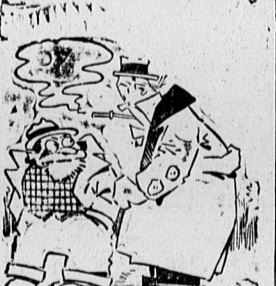
