Kensington Celebration Of Remembrance Day

The citizens of Kensington turned out en masse on Remembrance Day for the morning memorial service held in King George Hall. The members of this branch of the Canadian Legion, headed by President H. L. Howard paraded from their rooms to the hall and occupied the front seats. On the platform the school children were grouped, taking their part by giving the flag salute and singing. Mr. W. H. Darrah, acting Mayor in the absence of Mayor Cooke, presided and in a few terse and appropriate remarks welcomed the gathering and introduced the speakers. He especially accounted it a signal honor and great pleasure to welcome Major F. F. May, the principal speaker on this occasion. Major May was listened to with much attention, as he spoke very impressively of the state of the Empire now and the part rendered by the loyal soldiers in the Great War. His address might be divided under three headings, "Peace of the strong man armed," the peace of "Service" and the peace of the "Loyal Citizen."

Rev. B. C. Salter followed, paying a tribute to the memory of those who made the supreme sacrifice. Remembrance Day is fittingly named, as it is meet we should pause and pay our tribute to the memory of those gone before, to heroes all who answered the call and gave themselves so freely and courageously. The ranks of the Canadian Legion are growing thinner each year. We must not forget to pay a tribute to the mothers of the men of the Legion. They too are rapidly becoming fewer. Rival Factions Clash On Floor Of Chamber

Blum and Defence Minister Edouard Daladier strongly defended their cabinet colleague before the House. Salengro also denied the charges.

Fists Swing
Socialists left their benches and started through the upper aisles of the semicircle for the Rightists. Both sides clashed in the centre of the House and for 10 minutes the struggle lasted, with the mass of fist-swinging deputies packed so tightly it was impossible to see who was fighting whom.

The veritable riot broke out despite the recent clearing of Salengro by a special court of honor presided over by the army chief of staff, General Marie-Gustave Gamelin. Deputy Bequart failed to win consideration of his proposal that a new court of honor be formed.

Defence Minister Daladier, chiding the Rightists for bringing up facts 20 years old, declared the judgments of the court martial and the court of honor were definite and conclusive.

Recalls Incident
Premier Blum recalled how Salengro was captured by the Germans after he disappeared into No Man's Land to retrieve papers on the person of a wounded soldier.

Salengro's battalion chief and the General in command at that time decided there was no question of desertion, the Premier said. Later, however, the battalion commander saw an entry in Salengro's military identification papers which labelled him a militant Socialist, and ordered a court martial at Verdun, which decided by three votes to two on acquittal.

Urge Expulsion Of Rebel Unions

TAMPA, Fla., Nov. 13—The metal Trades Department of the American Federation of Labor proposed today to expel John L. Lewis' 10 rebel unions. Simultaneously President William Green predicted the Lewis revolt would collapse completely.

The department convention instructed J. P. Frey, its president, to introduce in the A. F. of L. convention next week a resolution calling for revocation of the rebels' charters. This would cost the Federation about one-third of its membership and, labor leaders say, would result in a long and bitter labor war.

Institute rendered services to 2,050 prevention cases. These received examination, treatment, glasses, and in many cases transportation at Institute expense.

The Institute sends home teachers into the homes of the blind to teach reading and writing of Braille, Braille music, typewriting and handicrafts. These services are free. Material such as read, yarn, etc., is provided free while instruction is being given and afterwards sold to the home worker at cost. The Institute also endeavors to assist the home worker by selling any finished work sent in to the salesroom.

The one who learn to read the Braille are then listed for library services if they wish them. Books, magazines, music and talking book records are loaned free of charge. Last year the total circulation from Institute libraries was 33,866, with a reading list of 1,243 names. In addition to this about 3,800 records were loaned for talking books for the blind. These are low speed gramophones. A record takes from 17 to 25 minutes to play one side. A book of ordinary size can be recorded on from 8 to 15 records.

Last year the Institute had 176 placements in Canada. These are canteens, cafeterias, lunch stands and newsstands operated by the blind. 21 of these are in the Maritime. A new one erected in the Halifax Infirmary this fall is now being operated by Mrs. Ruth Connors of Charlottetown.

Institute income from the Provincial Government for the fiscal year ended March 31-36 was \$1,000.00. The Institute spent on Island work \$1,555.64 and the amount earned, received or paid to the blind on the Island was \$2,238.00. In other words, for every dollar received, the blind earned, received or were paid two dollars.

A blind person wishing to travel by train, if accompanied by a sighted person may purchase two first class one-way, or return tickets, for the price of one by first obtaining a certificate from the superintendent of the Maritime Division of the Institute, Mr. H. B. Campbell, 172 Almon St., Halifax, N. S.

Free radio licenses are granted the blind and Braille watches, specially designed chess-boards, checker-boards, typewriters, games, puzzles, playing cards, and other articles used by the blind may be bought at cost price by those registered with the Institute. White canes may be bought for 50 each. Replacements 25.

The Institute has been earnestly endeavoring to obtain a pension for the blind. On March 9th last this matter was again thoroughly discussed in the House of Commons. Member after member from all parts of Canada, and representing all parties, spoke in favor of the resolution, but the Minister of Finance, Hon. C. A. Dunning, when giving his report stated that while the resolution was being given careful consideration, and the Government was favorable to it, he felt immediate action was doubtful in view of the present state of the country's finances. However, now that the principle has been endorsed by the Government itself, it is fair to assume that, within a comparatively short time, pensions for the blind will be an actuality, and the blind may rest assured that the Institute is doing and will continue to do everything in its power to bring this about.

TESTIFIES IN SHIP TRAGEDY

Captain of The Sand Merchant Heard At Inquiry.

TORONTO, Nov. 13—(CP)—Still showing effects of the disaster which claimed his ship and 19 lives, Captain Graham MacLellan of Cape Tormentine, N. B., testified today at the inquiry into the sinking of the Sand Merchant in Lake Erie on the night of Oct. 17.

At one point in the probe Mr. Justice Errol McDougall asked the ship's master if he would like a recess.

"No, I can carry on," he replied.

It was said that Captain MacLellan was present against doctor's advice.

In the witness box at the Federal Court of Inquiry at Toronto's City Hall, he testified there had never been a life-boat drill on the Sand Merchant, and admitted that one of the barometers on the ship had been faulty but that he had informed his firm about the fault a month before the tragedy.

He told of efforts to save the ship by heading her into the gale that swept the lake. He was on the bridge when she went down.

Remembrance Day At Belfast

Notwithstanding the rather uninviting weather of the morning of the 11th, a few hundred people gathered around the Soldiers Monument which stands out so prominently, within the grounds adjoining St. John's Church.

The local Legion men were on parade on time, accompanied by Piper Groom and Bugler Carr, both of Charlottetown, when the Rev. D. L. Griffiths, who conducted the proceedings announced that the Rev. Mr. Skinner would open the ceremony with prayer, after which the hymn "O God Our Help in Ages Past" was sung. Preceding the two minutes' silence, which was most reverently observed, Major Jenkins, Vernon, read an appropriate address.

Then followed the placing of wreaths at the base of the monument, the "Last Post" having been already sounded by Bugler Carr.

The number of wreaths on this occasion exceeded that of any previous Remembrance Day, and while as usual, that of the Legion itself was the largest, and occupied the central position, yet the wreath offerings of the local schools, mission societies, Women's Institute, and those of individuals were as rich and chaste as ever, the total number being seventeen. During this part of the proceedings Piper Groom played the "Lament" quite effectively.

At the close of the outdoor ceremony the "Reveille" was sounded by the bugler.

Proceeding to the historic church edifice, the brief but most devotional service was opened with singing of the doxology, followed by prayer by the pastor Rev. D. L. Griffiths, who also, after the singing of an appropriate hymn, gave a most fervent and illuminating address on a subject which he said was being brought to the front, more and more the last few years, that is "The Church and War."

Among many striking remarks, he said that a great war would not be possible without the cooperation and blessing of the Christian Church. Therefore it was perfectly possible for the church to prevent war if it had the will to do so and if Christ would not be soon reigning in the life of the nations there would be no one left to reign.

Mr. Griffiths quoted many leaders of today, in many lands, to prove that the trend of thought toward permanent peace was on the ascendant.

The Rev. gentleman was followed by the Rev. Mr. Skinner, who also pointed out that the only way out of the world wide conditions was the way of repentance on the part of the nations, and to allow themselves to be ruled by the spirit of Divine revelation.

A very edifying meeting closed with the singing of "The King", and the pronouncing of the Benediction.

In the evening a very fine supper and entertainment was held at the Eldon Hall under the auspices of the Legion and was attended by a very large number, and turned out to be quite a success.

gent bombers reloaded, darted back on Madrid and bombed the Morana barracks, housing thousands of troops. Then they blasted a long line of fortifications.

Barracks Hit

Fourteen large bombs streaked to earth in the second raid, five of them crashing through the barracks buildings. Ten government pursuit ships took the air against the invaders—three bombers and six fighting ships—and drove them off after a spectacular dog fight.

The earlier aerial battle left the government leaders exultantly proclaiming they at last had "supremacy" in the air.

A dozen Fascist attacking planes apparently intent on repeating previous deadly bombardments of Madrid proper, suddenly ran into a roaring formation of nine government ships.

Clipping volleys from machine guns in the government ship brought down two Fascist planes in full view of the house-top watchers.

The government announced their pilots pursuing the fleeing Fascists dived on the tails of four other ships, and shot them down behind their own lines.

Claim New Planes

Officials in Madrid, halting their pilots for saving the capital from another deadly bombardment, announced 70 new and up-to-the-minute fighting planes were in a secret airbase near Madrid.

Each ship carries from two to four machine guns, the government said.

In contrast to their earlier warnings that citizens of Madrid might have to fight in their homes to save their city, the Madrid Defence Junta tonight warned their fighting forces against "over confidence."

The government received a large number of tanks today.

SEVILLE, Nov. 13—(CP)—Eleven planes were shot down in the Madrid sector today, but they were Government craft and not insurgent as the Madrid Government claimed. General Gonzalo Queipo de Llano asserted in his broadcast tonight.

General Queipo de Llano also confidently predicted that Madrid will now be easily taken. The capital's defenders have no food, he said, and their last source of water supply will soon be cut by the insurgents.

The Madrid Defence Council threw every available man into today's offensive against General Varela's "impregnable" positions encircling the capital, the Insurgent General said. More than 300 Government dead were left on the field when the Government troops finally withdrew, according to his version of the day's fighting. Hundreds of other militiamen were reportedly taken prisoner.

Premier Francisco Largo Caballero has been shamed into returning to Madrid from Valencia, General Queipo de Llano asserted.
