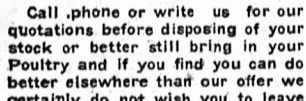

the mouth.
4. Your Poultry must be dry plucked
and work of all feathers.
5. If convenient hang the birds for
two hours after they are
plucked to allow them to be
thoroughly cooled.
6. Be sure that any blood is re-
moved from the birds' mouths
and their feet are clean before
packing.

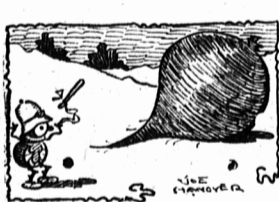

said Doris distinctly.

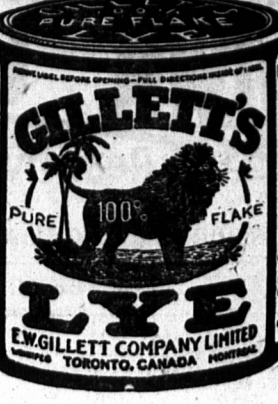
"You don't trust me?" he inquir-

Mutuels Pay
680 to 1 On
French Tracks

PARIS, Dec. 9.—A new high re-
cord for prices paid by the mu-
tuel at Paris race tracks was estab-
lished at Auteil Tuesday when Jean
Destort's York XI, won the Prix de
la Valse steppe chase and reward-
ed its backers at odds of more than
680 to 1.

Twenty-one persons who backed
York XI, by purchasing ten franc
tickets before the horses left the
paddock, received 6,822 francs
each, while the horse paid 880
francs for each five franc "pelouse"
ticket.

The previous record for Paris
tracks was 6,000 for 10, paid by La-
manche at Maisons Laffitte.

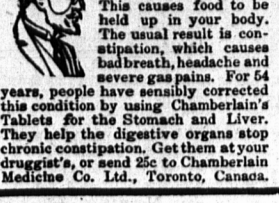

Interesting Paper on
Francis Thompson,
His Life and Work

Francis Thompson, his life and
works, was discussed at "The
Forum" Tuesday evening. His
greatest poem, "The Hound of
Heaven," was read and discussed.
The paper given by A. Dorothy
Duchemin, reads in part:—

Life.
Francis Thompson was born in
Lancaster, Dec. 18, 1859. It was
the desire of both his parents that
Francis should be devoted to the
priesthood of the church, and his
early education had this end in
view. A certain lack of application,
perhaps a tendency to the "artistic
temperament" brought such hopes
to nothing. As his father then ur-
ged upon him the study of medicine,
he entered Owens College, and be-
gan a study which he disliked pro-
foundly. Finding at the end of six
years the impossibility of embrac-
ing it as a life profession, he left
college and went to London. He
had no trade or knowledge of a
practical kind; his literary powers
were as yet undeveloped. Any work
he obtained did not last long, and
he was soon swallowed up in the
abyssal life of London's under-
world. The horror of these days
remained with him through life,
and was expressed later in some of
his most graphic writings.

The singular beauty of an article
on "Faganism" which he had sent
to a magazine attracted the atten-
tion of the editor, Mr. Wilfred
Meynell, who took measures to lo-
cate the author. After much diffi-
culty he was found, selling matches
on the street and brought to Mr.
Meynell's home. The remaining
years of his life, which were spent
there, were productive of many es-
says and poems.

As an Essayist.

Thompson is the most eloquent
of recent essayists. His principal
prose work is his essay on Shelley,
not published until after his death
in 1907. Most of his prose, like
this essay, is critical in nature.
"Darkest England," a social
criticism.

"Maestriat Enconium," and the
most intimate of all his essays;
"Health and Holiness, a Study of
the Relations between Brother
Ass the Body, and his Rider the
Soul." More than anything else
he has written in prose, it is a re-
velation of the soul of Thompson.

As a Poet.

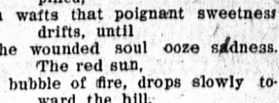
Thompson is to be remembered
chiefly for his poetry. A great sen-
sation was made by his poem "The
Hound of Heaven," which is per-
haps the work by which he makes
largest claim to a place with the
immortals. Here Divine Love is
seen like a bloodhound, scenting
his quarry from afar, tracing it pa-
tiently along every possible path,
and persevering in its search until
at last it is rewarded. And as the
lost sheep might be imagined list-
ening for the footfall of the Good
Shepherd, so the Soul hears the
approach of the Saviour.

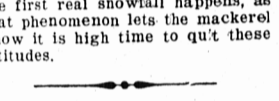

DR. HAROLD C. STEEVES

he had been in perfect health and
the news of his sudden death came
to Mr. Lea this morning as a stun-
ning blow.

in Dover, N. H., where two brothers
of Dr. Steeves, Lloyd and
Merle, also live. Hazen Chapman,
of Dorchester, Blair Chapman of
Gunn'sville, near Moncton, and
Clifford Chapman of Moncton, are
uncles, being brothers of Dr. Steev-
es' mother. Albert Wilmut of the
C. N. R. offices and Mrs. F. N.
Steeves and Miss Lottie Steeves
of Moncton are cousins, and there
are many other relatives in this
province.

Dr. Steeves' wife was formerly
Miss Helen Anna Lea, and a host
of friends will be shocked by her
sudden bereavement. The children
are Lea Chapman Steeves, aged 9,
and Marion Steeves, aged 5.
Mr. Lea is anxiously waiting for
further particulars, and he and his
daughter may leave at once for
British Columbia.
