WELL KNOWN BICYCLE RIDER WAS KILLED.

NEWARK, N.J., April 20.—Floyd A. MacFarland, general manager of the Cycle Racing Association and one of the most widely known bicycle riders in the country, received a fractured skull and other injuries about the head which caused his death, in an altercation with David Lantinger, a confectionery dealer in the Velodrome here. Lantinger was arrested, charged with murder.

Several bicycle riders were going around the track in practice for races and a number of their friends were watching them when MacFarland and Lantinger became engaged in an argument. MacFarland, who is manager of the track, objected, it is said, to a number of signs which Lantinger in the building, had placed over his stand. Lantinger, it is declared, refused to take the signs down and a heated argument ensued, which resulted, according to witnesses, in Lantinger stabbing MacFarland in the heart with a screwdriver. Riders stopped and the few spectators rushed to the spot.

MacFarland, unconscious, was hurried to a hospital, where he died several hours later without regaining consciousness.

HARSH TREATMENT OF PRISONERS.

Some of the latest phases of life in the internment camp at Ruhleben, near Berlin, are given by Frank Houvenagel, one of the crew of the Wilson liner Castro. Being a Hollander, he has been permitted to return to this country after being detained in Germany for some months, and he has just arrived in Hull.

Houvenagel spoke with some feeling of the harsh treatment meted out to the British prisoners. He said that when the soldiers went round to wake up the sleepers in the morning they shouted, "Rouse, you English swine!" If a man was found not to have got up he was subsequently put into a cell with a concrete floor, was given only one blanket to wrap himself up in, and was kept there for seventy-two hours. A number of men were having their constitutions undermined by the bad food and insufficient food served out. The bread allowance was now cut down, and a loaf of black bread, made largely of potato flour, weighing 3 lbs., was given out periodically. This had to be made to last, for no more could be had. Every morning they had to march the quarters of a mile to the cook-house and fetch black coffee without sugar or milk, and sometimes cocoa, which was a wretched concoction. For dinner there was soup, which tasted very much like cabbage water one day, turnip soup another day, and rice soup on yet another, and if one were lucky he might get a little bit of meat. The British prisoners had been very much heartened by the British Relief Fund, through which everyone received four marks (\$1) a week, with which to buy clothing if he were in real need. All who got these marks noted signed a paper that they would repay the money to the British Chancellor of the Exchequer when in a position to do so.

Houvenagel said that he was among some English prisoners who refused to perform some objectionable tasks, but they were forced to do so, with armed soldiers standing over them. The British prisoners were full of spirit and refused to believe the news of disaster to England which was recited to them.

FAST EXPRESS WRECKED.

MELBOURNE, April 20.—The Melbourne-Sydney express, the fastest train in Australia, collided with a mail train at Dinalong early to-day. One man was killed and twenty-four injured, including several members of the Federal Parliament.

ANARCHISTS SENT TO PRISON.

NEW YORK, April 20.—Frank A. Barne and Carmine Carbon, anarchists who made and set a bomb in St. Patrick's Cathedral on March 2, when hundreds were worshipping in the edifice, were sentenced to-day to serve not less than six years nor more than twelve in Sing Sing prison.

GERMAN PRISONERS INCLUDE MANY CLASSES.

The Amherst News, commenting on the internment of the German prisoners there on Saturday night says: "No excitement of any kind, occurred in the few hours run to Amherst (from St. John). The Teutons were far from downhearted when they passed through the I. C. R. Station at Amherst, German songs and cheers were plainly heard. Thoughts of the prolonged imprisonment were distant from their minds.

"The greater majority of these men are Naval or Army reservists, although quite a number are regular sailors. Sixty officers from various vessels are with the men. Their quarters in the quite distinct from their confines of imprisonment. These officers have a separate mess, baths, and sleeping quarters. Again there are civilians of a high walk of life. Taken in all, a conglomeration of classes is found with these prisoners. In the place where they are upon a common footing, barbed wire entanglements surrounding the building. Both officers and men would find some difficulty in making their escape from the quarters."

SKILLED WORKMEN MAY BE RECALLED.

LONDON, April 20.—The Government has made arrangements under which skilled workmen, now at the front fighting, can be recalled to England to work in the factories producing munitions of war.

Lord Elphinstone made this announcement yesterday at a meeting of the Birmingham manufacturers which had been called by George MacAulay Booth, chairman of the munitions committee. Lord Elphinstone outlined the government's plan for organizing the supplies in the midland counties and said what was known as release committees had been appointed and in special cases where a particular man who had enlisted was wanted back in a factory, he could be got back if named, and properly identified.

A local committee under the government's organizing scheme was appointed in Birmingham and another has been appointed in Glasgow.

PROMINENT C. P. R. OFFICIAL DEAD.

MONTREAL, April 19.—Lt. Col. Lacey Johnson, who was recently appointed general welfare agent of the Canadian Pacific Railway, died on Saturday night of peritonitis, after three weeks' illness. He was born at Abington, Berkshire, England, and was in his 60th year. Lt. Col. Johnson at the time of his appointment to the position of general welfare of the C. P. R. was general superintendent of the Angus shops and had been connected with the C. P. R. since 1882.

SENDS FAMILY AND ARCHIVES TO VIENNA.

PARIS, April 19.—Baron Von Machlo, Austrian ambassador to Italy, has sent his family and the archives of the embassy to Vienna from Rome, according to a despatch from the Italian capital to-day.

This and other developments indicate that Italy is on the brink of war. While reports of clash between Italian and Austrian troops at the frontier are unconfirmed, it is understood that war may come from just such an incident.

BRITISH LIFE WAR CLAIMS ALMOST \$10,000,000.

LONDON, April 20.—British Life Insurance Companies have paid war claims of almost \$10,000,000 to relatives of soldiers and officers killed during the first seven months of the war. One company alone has had to meet eight thousand claims.

SOLDIERS TO BE PUT ON HONOR.

LONDON, April 20.—In order to relieve the hard worked censor, soldiers writing home letters from the front are now being left on their honor as to the contents of their letters. A special envelope has been issued to the troops in the fighting line for this purpose. It is green in color and headed: "On active service." On the flap is this declaration, which must be signed by the writer: "I certify on my honor that the contents of this letter refer to nothing but private and family matters."

PADEREWSKI PLEADS FOR THE POLES.

NEW YORK, April 19.—Too depressed by the war to play in public, Ignace Jan Paderewski, the famous pianist, is here to organize several committees to work for the relief of war devastated Poland, his native land. Mr. Paderewski arrived with Mme. Paderewski on board the White Star line steamship Adriatic. They will remain in this country for a month.

"The devastation that has been wrought in Poland is inconceivable," said Mr. Paderewski. "An area seven times greater than Belgium has been laid in ruins and its population reduced to starvation. We know much about the conditions in Belgium, but very little in regard to Poland beyond a general idea; but the scant details now at hand are sufficient to show that unless immediate help is obtained thousands will die of starvation."

He said three great armies have gone over the country and are still operating there. There have been no atrocities committed against the Jews, he said, despite reports to the contrary published in this country.

"War is horrible enough of itself, to beggar, description, without discussing atrocities," he added. "I do not mean to discuss the ethics of the situation, as it would be imprudent for me to hurt anybody's feelings. My mission to this country is a humanitarian one and wide co-operation, irrespective of racial creeds, is essential."

Mr. Paderewski's great estate at Rzeszow, Poland, has felt the ravages of war. Not a stone has been left in place, he said. He has been living in Switzerland since the war started, and the Polish relief work now is being carried on at Lausanne, where he largely was instrumental in starting the movement.

DISAGREEMENT OF THE JURY IN ALBERT COUNTY POISONING CASE.

HOPEWELL CAPE, A. Co., April 20.—The Downing alleged poisoning case was completed after midnight. The jury were out three and a half hours and failed to agree. It is understood that nine were for conviction and three for acquittal.

Mr. Mullin, acting for the attorney general, moved that the prisoner be remanded, and also asked that the court be adjourned to a date for a second trial of the case.

Mrs. Johnson was then brought into court and arraigned on the six counts in the indictment on which the jury found a true bill. She pleaded "not guilty" on all the counts, and she was also remanded for trial.

Court was then adjourned to May 13th at 10 o'clock.

Downing finished his evidence under cross-examination in the morning and three witnesses were called in rebuttal.

Mr. Fowler, for the defence, spoke about two hours, and Mr. Mullin about three hours, Judge Crockett following with a thoughtful charge to the jury.

This was the longest criminal trial on record in this country.

Mr. Fowler left for Fredericton in the afternoon, and Judge Crockett and Mr. Mullin leaves for home this morning by train.

DUAL MONARCHY HAS PUBLISHED AN AMAZING RED BOOK.

LONDON, April 19.—The Morning Post publishes the following from Budapest:

"The Austro-Hungarian Foreign Office has published the second Red Book. This volume is compiled from documents, statements and a great number of photographs relating to atrocities and breaches of international law alleged to have been committed by Serbia, Russia, France and England.

"The book is drawn up in four sections, the first of which gives documents about the treatment of Austro-Hungarian diplomatic representatives in enemy countries and details of ill-treatment of officials and consuls in Russia and Serbia. It asserts that in some cases the arrest and expulsion of these functionaries took place even before the state of war existed.

"The second section treats of infringements of international law, and asserts that there is not one small article which has not been violated by the Allies repeated ly. To the violation of the laws of land warfare and of the Hague Convention can be added, according to the 'Red Book,' innumerable atrocities committed by the military forces and civil population of Serbia and Montenegro. Thousands of Austrian and Hungarian citizens are still interned and detained in enemy countries and countless illegal acts have been committed against Austrian citizens in Austrian territories under enemy occupation.

"The third section of the Red Book accuses Russia, France and Great Britain of being responsible for lawlessness and atrocities committed by uncultured and barbaric troops. They have brought such forces to the European battlefields without having any power to restrict such half-wild elements to the obligations of international law. These powers are blamed for barbaric and inhuman behaviour of such troops, as well as for their neglect in enforcing European discipline upon them. It also is regarded as an infringement of international law on the part of Great Britain that she attempts to subject to starvation the population of great and cultured states.

"The book contains 145 documents in all. Document 25 tells how the Austrian vice-consul was arrested in Petrograd and taken to Volodye and ill-treated. It records that the Austrian vice-consul in Kiev was arrested with all employees of the consulate and taken to Kursh, where he was brutally treated. Documents 33-73 refer to cruel treatment of interned civilians in Belgium, France and Russia. There are also letters saying that young girls have been attacked even in France.

"A document signed by the doctor of a physician about a riot in Douglas, Isle of Man. The physician asserts that he was present at the time of the riot, when two men were killed and twenty-five seriously and ten slightly wounded, and contains a statement previously made that the guard in the Douglas concentration camp used dum-dum bullets when firing at the interned rioters.

"The fourth section of the Red Book describes Serbian atrocities. According to one of these documents, in one case, Serbian civilians cut off the fore arms and legs below the knees of a Hungarian Hussar and placed him on a horse which was chased around amid the applause of the people. In another case they are declared to have bored a hole in a soldier's chest; then drawn a rope through it, and hanged him in this way on a tree, afterward lighting a fire under him.

"Other documents speak of brutal and unnumberable tortures inflicted on the wounded by Serbian women and even children and the mutilation of wounded and dead soldiers."

SIGNS IN SKY PRESAGE VICTORY

PARIS, April 17.—Meteorological phenomena have been observed so frequently of late that the question is raised whether there is any relation between them and the continual artillery firing on the battlefield. Abbe Moroux, director of the observatory at Bourges, says that his attention has been called every few days to singular phenomena in the sky, such as halos, crowns and luminous crosses. Many devout persons see in the latter manifestations, he says, a mystic sign of approaching victory.

Abbe Moroux says that these crosses are reflections produced by humidity in the atmosphere and probably are due to depressions originating over the North Atlantic. He asserts that they have no connection with the artillery firing.

TURKS SHOOTING GERMAN OFFICERS.

PARIS, April 20.—German officers have arrived at Constantinople within the past fortnight to take places of others who have been killed, says the Temps correspondent at Dedeagatch. The Germans have induced the Ottoman Government to pass a special law authorizing superior officers to shoot at sight any officer of inferior grade or private disobeying orders. "But," the despatch continues, "the Turks have succeeded in killing a number of their German masters during battle."

PURSES FOR GRAND CIRCUIT RACING AT SYRACUSE

SYRACUSE, N. Y., April 19.—Forty thousand dollars has been offered as purses and prizes for the annual Grand Circuit races to be held in connection with the New York state fair here next September. Of this sum twenty-four thousand dollars is reserved for six early closing events, entries for which will close on May 10th. The events will be headed by the Empire State \$10,000 stake for 211 trotters.

BRITAIN APOLOGIZES FOR SINKING DRESDEN IN CHILEAN WATERS

LONDON, April 20.—The British Government has offered a full and ample apology to the Chilean Government for the sinking, on March 14, in Chilean territorial waters of the German cruiser Dresden, the internment of which has already been ordered by the maritime governor of Cumberland Bay when the British squadron attacked and sank her.

This fact was made public tonight in a White Paper, giving the texts of the Chilean note protesting against the sinking of the Dresden and the British government's reply.

The note delivered by the Chilean Minister to Great Britain says that the Dresden anchored in Cumberland Bay (Juan Fernandez Island) March 9, and asked permission to remain eight days for the purpose of repairing her engines, which were said to be out of order. The Governor refused the request as he considered it unfounded, and ordered the captain to leave the bay within twenty-four hours.

DRESDEN IGNORED ORDER

As the order was not complied with, the captain of the Dresden was informed that his ship was interned.

When the British squadron appeared on March 14, the Governor was proceeding to the cruiser Glasgow to inform the British officers of the steps he had taken, but he had to turn back as the British ships opened fire on the Dresden on which a flag of truce had already been hoisted, and called on the captain to surrender. The captain then gave orders to blow up the magazine of the Dresden.

This act of hostility committed in Chilean territorial waters by a British naval squadron says the Chilean Minister, "has painfully surprised my Government. Continuing, the Minister says that had the officer in command of the British squadron received the Dresden was interned, he would have been ordered to land on shore and not have opened fire on her and brought about a situation which constrains the Chilean Government in defense of its sovereign rights to formulate a most energetic protest."

BRITAIN'S APOLOGY

The British Government, in its reply, expresses regret that a misunderstanding arose, and adds:

"On the facts as stated in the communication by the Chilean Minister, the British Government is prepared to offer a full and ample apology to the Chilean Government."

It is, however, pointed out that according to the British information the Dresden "had not accepted internment and still had her colors flying and her guns trained." If this is so, and if there was no means available for enforcing the decision of the Chilean authorities to intern the Dresden, she might obviously, had not the British ships taken action, have escaped.

It is added: "The captain of the Glasgow probably assumed, especially in view of the past action of the Dresden, that she was defying the Chilean authorities and abusing Chilean neutrality as well as only waiting for a favorable opportunity to sail on and attack British commerce again. In view of the circumstances and because of the Chilean communication, the British Government do not wish to qualify the apology they now present to the Chilean Government."

GERMANY TO BELGIUM.

AMSTERDAM, via London, April 19.—The Rome correspondent of the Tidu says the German Embassy in Rome has asked the Belgian Government, through the Belgian Legation to the Quirinal, whether, in the event of the German armies evacuating Belgian territory, Belgium would remain neutral during the remainder of the war. The correspondent adds that Belgium's answer is unknown.

CHURCHILL DENIES STORIES ABOUT NAVAL ACTIONS.

LONDON, April 19.—Winston Spencer Churchill, First Lord of the Admiralty, has issued the following denial of recent rumors:

"There has been no naval action of any kind in the North Sea during the past month, nor any action of any kind in the Dardanelles, other than local bombardments and reconnaissances by single ships.

"Since March 18, only two or three men have been hit in the Dardanelles, and there has been no loss or injury to French or British ships."

HUERTA HOLDS 'SECRET' OF MADERO'S MURDER.

NEW YORK, April 19.—Vehemently asserting that he had nothing to do with the death of Francis Madero, Victoriano Huerta, former Provisional President of Mexico, made a lengthy statement tonight setting forth what he termed his side of the Mexican question. General Huerta declared that he knew who was responsible for Madero's death, and that he was keeping it as a "professional secret." He was in no way responsible for it, he said.

General Huerta's statement reviewed the history of the Madero revolution, his own accession to the Provisional Presidency, and concluded with the assertion that "my country cannot be conquered." Sixteen millions of men, women and children would have to be killed before Mexico would submit to an invader, he asserted.

The heads of the Washington Administration had not been fair to Mexico, had been misled by false statements, and if they had been in Mexico for thirty days "they would have changed their theoretical, erroneous ideas." Had it not been for the embargo on the exportation of arms from this country, General Huerta indicated that his army would have prevailed over those opposed to it.

HOPEWELL CAPE, April 20.—After being out three hours and a half in the Downing poisoning case, the jury returned at 2 o'clock this morning and reported a disagreement.

On the first count—causing poison to be administered—the jury stood eight for conviction and four for acquittal, and on the other six counts, nine for conviction and three for acquittal.

On being told by the foreman, Chas. Ayer, that there was no possible hope of an agreement, his honour dismissed the jury. Downing was then remanded until Thursday, May 13, when a new trial will be commenced.
