LONDON, April 11.—The British torpedo boat destroyer Blackwater was sunk at midnight last night off Dun- gness as a result of a collision with the British steamer Hero. The crew of the Blackwater was saved. The Hero had her bow stove in.

The Blackwater had a displacement of 550 tons and was 225 feet long. She had a complement of 70 men and was capable of steaming 25 knots an hour.

BANK TO COLLECT FROM SHAREHOLDERS

TORONTO, April 10.—The mode of procedure in the Bank of Montreal suits to collect from shareholders of the Ontario Bank, under the double liability clause, is well known to the public. The Bank of Montreal, which advanced about sixteen millions of dollars, and which did not collect the total of its claim in the disposal of the Ontario Bank assets, has come upon the shareholders and directors for as much of the balance as their liability allows. Some of the shareholders are resisting the claim under the double liability clause, and it was argued that before proceeding, the Bank of Montreal should first make sure of the amount of the deficit. Wallace Nesbit, K. C., for the Bank of Montreal, made some suggestions as to procedure, and the institution of the test case. Adjournment was made to give counsel an opportunity of considering the suggestions.

3 On Church Street east side from Richmond to Grafton and on Grafton St. south side from Church to Prince and on Richmond Street north side from Church to Prince all 4 feet wide.

10 On Kent Street south side from Hillsborough to Weymouth Street 4 1/2 feet wide.

11 On Grafton Street south side from Prince to Cumberland Street 4 feet wide.
