**HALF A PROMISE**

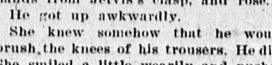
Doris looked down at Dick Jervis, kneeling beside her.

**Quarterly Meeting Of P. E. I. Presbytery**

The P. E. I. Presbytery met in quarterly session in Zion Church Hall on Tuesday the fifth at the hour of eleven a. m.  
The Presbytery was constituted by the Rev. George Millar of Clinton, Moderator.

The following Elders, members of Presbytery were also present:—  
James Gillespie, New London, Hector Marchison, North River, William MacFarlane, South Melville.  
M. R. MacLeod, Caledonia, Malcolm Nicholson, Bradabane, Revs. W. A. Ross of Milltown, N. B. and W. H. Spencer, members of St. John Presbytery and Rev. Alexander MacKay of New Richmond, Quebec, member of Miramichi Presbytery and formerly pastor of Bedouque Congregation, being present were invited to sit with the Moderator. The minutes were duly read and approved.  
Rev. E. Lockhart was elected Moderator for the ensuing six months.  
A committee consisting of Revs. D. K. Ross, convener and A. J. MacNeil, George Millar and W. O. Mulligan was appointed to make nominations for Synod's Committees.  
In regard to Cardigan Church a committee consisting of Messrs. S. Aitken, L. Webster and Isaac Beers was appointed as assessors to act with the Cardigan session.  
A call was presented from Princeton or Malpeque congregation in favor of Rev. A. N. Gillis of Waterville, Nova Scotia. Owing to the illness of Rev. A. W. Robertson, Moderator of Malpeque Congregation, Rev. D. K. Ross was instructed to moderate in this call on the evening of July fourteenth which came out unanimously for Mr. Gillis. The call was signed by one hundred and fifty members and one hundred and three adherents. It was accompanied by a guarantee of eighteen hundred dollars to be paid monthly and four weeks' vacation. There is also free use of Manse and Glebe. Commissioners from the congregation were heard in support of the call. Mr. Howard Ramsay representing the session, Mr. Archie Woodside the board of managers and Mr. Thomas MacNutt the congregation. On motion it was agreed to sustain the call and authorize the Presbytery of Halifax and Antigonish, Mr. MacGlasheen to support the call on behalf of Malpeque congregation.  
In view of the acceptance of the call by Mr. Gillis, provisional arrangements were made for his installation, the date to be decided by Moderator and Clerk.  
The Moderator of Presbytery was appointed to preside, Rev. E. M. Aitken of New Glasgow to preach, Rev. George Millar to address the Minister and Rev. D. K. Ross the people.  
Rev. A. N. Gillis who is under call to Malpeque is a native of Brookfield, P. E. I. and is well known in Charlottetown where he and his bride were recent visitors. For the past two years he has been preaching in Waterville, Nova Scotia. It is understood he will likely accept the call.  
At the afternoon session Presbytery nominated Rev. John MacIntosh, D. D., of Sydney, as Moderator of the Maritime Synod. The present Moderator is Rev. J. M. MacLeod of St. Peter's Bay.  
The Rev. B. H. Penwarden of Mount Stewart called the attention of the Presbytery to the fact that the first Presbyterian Minister to P. E. I. was the Rev. Peter Gordon who ministered for three years to the large district of Covehead, Mount Stewart and St. Peter's. He died in young manhood about 115 years ago and his mortal remains lie buried in a neglected cemetery at St. Peter's Harbor. A small slab marks the spot but the fence is dilapidated in condition and visitors to our Province and our people should remember this historic spot. On motion of Rev. M. J. MacPherson, seconded by Rev. J. MacLeod it was unanimously agreed to commend the efforts to preserve and mark the burial place of our pioneer minister and suggest that the surrounding congregations endeavor to look after the cemetery. A committee consisting of Rev. B. H. Penwarden as Convener, Rev. J. M. MacLeod and Messrs. Judson Webster and J. J. MacGowan was appointed to take up this question. Considerable time was given to discussion of Home Mission problems. Some co-operative arrangements with the Methodist Church of the York Circuit and Covehead and Marshfield have been tried during the past year.  
After June, 1925, rearrangement of circuits and congregations of Methodist and Presbyterian congregations will likely be effected, according to recent legislation in Ottawa, the United Church of Canada consisting of Methodist Presbyterian and congregationalists will probably function. When routine matters were disposed of Presbytery adjourned to meet in regular quarterly session in November.

**THE CLUTCH**

The clutch in your car is for the purpose of forming connection between the engine and the rear wheels.  
There are different types of clutches. Namely: Cone, plate, disc and electric. The operation of these clutches will be explained within the next four articles, but the general utility of a clutch is to release the power from the engine to the back wheel whilst the transmission is in gear.  
If clutches were not installed in a car, it would be impossible to change gears, and just as impossible to start the engine without pulling the car along.  
It is more or less sensitive in operation, but modern engineering has developed to such an extent that clutch troubles today are very few, if it is kept greased and clean and not abused by slipping or "pedal riding"—driving with left foot resting on clutch pedal.  
Ques.—I have a knock in the motor of my car at all times. It is not rods, pistons, bearings or timing gears, as I have had these replaced and fitted. Can you tell me what is likely to be knocking?  
Ans.—It is common in this particular car for the mechanic to miss a very essential bushing in the front end of the motor.  
It would be well for you to inspect the ignition shaft bushing and ignition shaft for end play or wear. This travels at a good speed and wears decidedly quicker than a crank shaft bearing.  
This trouble is checked to this part, assuming that there is no other parts wrong, that you have stated to be correct. Namely: end play in crank shaft, cam shaft, offset of pistons on wrong side, and set of rods on wrong side and timing gears not fitted properly and the crank shaft gear bedding into the two contiguous gears through excessive wear on the block babbit and the shaft having been clamped up too high and running out of line.
