CELEBRATION WILL OPEN SUNDAY, AUGUST 14TH.

As already intimated, the first diocesan Eucharistic Congress, Diocese of Charlottetown, which opens on Sunday, August 14th, promises to be a most impressive celebration.

The service on Sunday and Monday will be held in every parish of the diocese. On Tuesday the Diocesan Assembly will start at the Parish Church, Misouche, continuing on Wednesday.

Address of welcome, Rev. Dr. Monaghan, pastor. Sermon—"Meaning and development of Eucharistic Devotion," by His Excellency Most Rev. G. Courchesne, Bishop of Rimouski, P.Q., Pontifical Benediction of Blessed Sacrament.

Wednesday, August 17—Low Masses from 6 a. m. to 8 a. m. Children's Congress Mass and Holy Communion at 8:15 a. m. The whole congregation of little children will answer the response and recite the Gloria, Credo, Sanctus, Benedictus and Agnus Dei together with the celebrant. der consideration. And proceeding by the path of compromise, Great Britain is further understood to be ready to discuss preferences on wheat and other natural products indicated in Canada's offer.

A "bagful of agreements" was the way one member of the British delegation tonight smilingly summed up the expected outcome of the conference. And linked with the Empire conference, although not included in its agenda, have been conversations between representatives of Great Britain and the Irish Free State. There has, as yet, been no settlement of the dispute over land annuities which, on the eve of the conference, plunged the two countries into a bitter tariff war. But conversations during the trip to Niagara Falls last week end are said to have carried negotiations much nearer success than they were carried during previous conversations in London and Dublin. It was a result of the Niagara conversations, it is understood, that Dr. Ryan, Free States Minister of Agriculture, left Ottawa for Dublin at the beginning of the week.

Negotiations between Great Britain and Australia, which had almost touched the point of absolute agreement are reported to have struck some difficulty over foreign meats. Australia prefers procedure by way of tariff preference, Great Britain, by some other system of restriction. But there is confidence on both sides that the difficulty will be removed.

and from Congress. "Citizens of Seville: A movement was fully blocked in Madrid this morning, and the government authorities have arrested General Godeo and Calvo and Fernandez Perez, who were among the leaders of the movement," the proclamation said.

"All Spain has reported to the government that it is faithful to the present regime. The country is awaiting your answer." The principal leader of the Royalist revolt appeared to be General Jose Sanjurjo, commander of the civil guard when the monarchy was overthrown in April, 1931. His loyalty to the Republic frequently has been suspected. It was General Sanjurjo who escorted former Queen Victoria to exile when she followed the ousted Alfonso XIII out of Spain.

Alfonso apparently was not connected with the movement at least not directly. (The former King was hunting near Koengswang, Czechoslovakia, while the Spanish authorities were moving against the rebels. His spokesman said he would not comment.)

Political observers expressed the belief that the object of the movement was to enthronize Prince Juan Carlos, third son of Alfonso, who is now a cadet in the British navy. Spain has been seething with political unrest for months while the Cortes indulged in debate over the momentous problems presented by Catalonia's insistence on autonomy and by agrarian reform measures which would parcel out of great estates among the peasants. This unrest reached a climax at dawn this morning when rebels and loyalists met in battle, before the Ministry of War, in which Prime Minister Manuel Azana has his office.

Government authorities had been informed in advance that an attack was imminent, and the attackers were met by bursts of machine gun fire from detachments of the Madrid police under the command of director of public safety Mendez.

The action started when two automobiles loaded with rebels drove up in front of the Ministry. These men were soon dispersed by the fire of the defenders under the personal command of director Mendez. In a short while they returned with reinforcements and the action which followed took in not only the War Ministry building but also the headquarters of the telephone company and the communications building. The fighting lasted more than an hour. The Cibeles Plaza and adjoining streets were raked by machine gun bullets. In addition to the eight men killed, seven were wounded. A few hours later people were passing on their way to work as usual and only the fact that Madrid was under heavy guard signified what had happened earlier in the morning. But elsewhere in Spain things were different.

General Sanjurjo seized the government offices in Seville and also took control of the smaller town of Jerez De La Frontera to the south, where he set up rebel headquarters. The naval garrison at Cartagena on the southeast coast was reported to have mutinied. Civilians of the southern provinces including Cordoba and Algeiras, threw their strength behind the rebel movement.

Reports from Seville were that General Sanjurjo, who had proclaimed himself Captain General of Andalusia, was prepared to resist all efforts by the government to dialogue him. It also was reported that regular army troops at Cautas and other Andalusian points had declared themselves against the Republic and for Sanjurjo.

Premier Azana informed the Congress that the movement was Monarchist in origin and that it resulted from efforts to suborn the soldiers. The Premier asserted that the rebels would be punished by all measures within the law.

Labor appeared to be standing by the Republic. The syndicalists announced that if the Monarchists gained would start a general strike throughout Spain.

The Socialist General Workers' Union called a mass meeting for the purpose of declaring a 24 hour strike protest against Monarchist rebellion. Delegates were sent to working class districts to urge workmen to have nothing to do with the rebel movement.

Second Heat. Chestnut Dillon took the lead in the second heat, Golden tucking in. They raced that way to the three-quarter pole with Peter Dawes trailing Golden. From there home Golden showed the most speed, passing Chestnut Dillon at the turn when on a break and winning by half a length from Tease who came very fast through the stretch, Peter Dawes third, Dillon fourth and Dora Mac fifth.

Third Heat. They got away on the second score, Peter Dawes sprinting fast into the lead which he held until turning into the stretch when he was passed by Tease and Chestnut Dillon who had an exciting fight for positions. Golden seemed tired from his efforts in the previous heats while the others seemed fresh and equalled the time made in the first heat.

This was another ripper of a race. They went at it hammer and tongs right from the word Go. It took about six or more scores before Starter Acorn could get them away. All were anxious and he was doing his best to give them a square deal. Hush grabbed the lead with King Spruce tucked in behind, The Willys back in fourth position to the half. From there home it was a hummer of a race. As they struck the stretch it looked as though King Spruce would outbrush Hush to the wire, but "Pomp" had something left and spoke to his steed giving him new energy and he draw away to win by half a length to win from King Spruce. The James E. Officers and crew are still able to relate thrilling stories of adventures and experiences in strange places, not usually the lot of "land lubbers," and therefore all the more entertaining.

Hon. H. H. Stevens, Minister of Trade and Commerce for Canada, presided. He is chairman of the Privy Council committee on scientific and industrial research, and, as such, has had much to do with the completion of the new building. Speaking briefly, he called upon the Prime Minister, Rt. Hon. R. B. Bennett to address the assembly. After a short address from Mr. Bennett, His Excellency, upon whom fell the duty of declaring the building open, spoke.

He told of the enormous natural resources in Canada awaiting development. To the problems arising in connection with these, scientifically guided intellectual effort should be applied. He referred to the benefits which Canada had already received from modern science. He touched briefly on the part which has been played by eminent Canadians in the scientific field.

And His Excellency indicated one field in which he thought the national research council might be of great value to Canada. He spoke of the importance of retaining the services of successful Canadian students in the work of developing the natural resources of this Dominion. Much scientific work had been done "by Canadian men of science who have found it necessary to leave Canada." Their contributions to science had been made while living in foreign lands. The council could perhaps make no greater contribution to the future of Canada than to secure and retain the services of "the best products of Canadian schools."

After the Governor General had declared the building open, Dr. H. M. Tory, president of the National Research Council, spoke briefly on the work of the laboratories. Mr. Stevens followed with a brief word of thanks to the Governor General and other speakers for their assistance, and the formalities were over.

Later he became a commissioned officer in the Royal Army Ordnance Corps, was promoted to Deputy Assistant Director of Ordnance Services, 63rd and 99th Divisions, and returned to the Front in 1916, where he distinguished himself, being mentioned four times consecutively in despatches. In 1918 he was appointed Assistant Director of Ordnance Services, 67th Army Corps, with rank of Lieutenant Colonel. After the War, in 1919, he received the freedom of the City of London, and was decorated with the Order of the British Empire, Military Division. From 1923 to 1928 Colonel Dodds was president of the Provincial Council, Boy Scouts' Association for the Province of Manitoba. He is a member of the Boy Scouts' Dominion Council, and is a past president of the Royal Society of St. George, Winnipeg Branch. He also served as vice president of the Canadian Club, Winnipeg, and as director of the Knowles School for Boys.

Colonel Dodds is a member of the Canadian Advisory Board of the Northern Assurance Company, of London, England, and its allied Company; also a director of the London and Scottish Assurance Company (Fire Department); a member of the Business Committee and of the National Council of the Canadian Chamber of Commerce, a vice president of the Montreal District, Boy Scouts Association, a fellow of the Royal Empire Society, and is prominently associated as a layman in the activities of the Anglican Church in Canada.

EFFORTS TO RE-OPEN NEGOTIATIONS FAIL

DUBLIN, Aug. 10—(Canadian Press Cable)—Fresh efforts to re-open negotiations with Great Britain were made by opposition members in the Senate just before adjournment tonight, but without success. On a motion to adjourn, the opposition drew attention to recent "overtures" by two British Cabinet Ministers, Sir Thomas Inskip, the Attorney-General, and Sir John Simon, the Foreign Secretary, and challenged the Free State government to make some response.

It was clear from Sir Thomas Inskip's statement, said one opposition member, that the real question at issue was not so much the payment of land annuities as the future attitude of President D. Valera's Government toward Great Britain and the Empire. If the Free State really wishes to get rid of the new British tariff, he argued, the government must frankly decide whether to continue in the British Commonwealth of nations or not.

Speaking for the government, Senator Joseph Connolly, Minister of Posts and Telegraphs, said he did not think it would be wise to deal at short notice with such important matters as the British Minister's statements. "The situation is being awaited day by day," he added, "and our line of policy is being followed."

The Senate then adjourned for an indefinite period. The Dail is not scheduled to meet again until October 19.

Sir Thomas Inskip's statement was made at Stranraer, Scotland, on August 4. He emphasized the British government was still willing to submit the land annuities dispute to the arbitration of an impartial tribunal. "Does Mr. De Valera want to remain a partner in the Empire or is he pursuing a will-of-the-wisp republic?" he asked. He praised the conduct of Free State delegates at the Imperial Economic Conference.

Speaking at Barnsley, England, on August 6, Sir John Simon declared it was the earnest hope of the British government that either arbitration or negotiation would be speedily adopted to settle the land annuities dispute.

The Free State senate itself, swayed by an opposition majority, had already carried a resolution, August 3, urging the government to re-open negotiations with Great Britain. The dislocation of trade since July 25 was attributed to the new tariff walls erected by both countries as a result of the land annuities dispute.

President De Valera's measure provides that the control of manufacturing concerns in the Free State shall be vested in citizens of the Free State. The opposition moved today that the senate adhere to its amendment allowing an Irish "born" person to enter the Free State and establish an industry, but this motion was lost 21-20.

On a later division the senate turned about and rejected a government motion that the upper house should not adhere to another amendment. This time the count was 24-17. The reverse means the bill must go back to the Dail, and if that body should again reject the amendment, further action will be automatically delayed for 19 months.
