I. O. D. E. War Memorial—1946

In order to perpetuate the memory of the men and women who gave their lives in defence of the Empire in the Great War, the Imperial Order of Daughters of the Empire established a War Memorial, of which the leading features are Bursaries in Canadian Universities, Post-Graduate Scholarships, (Overseas), and the placing of Historical Pictures in Schools.

Post-Graduate Scholarships (Overseas)

Nine post-graduate scholarships—one in each Province of the Dominion—are offered annually, to enable students to carry on studies at any University in the United Kingdom, in British and Imperial History, the Economics and Government of the Empire and Dominion, or any subject vital to the interests of the Empire. These scholarships have been awarded not only for History, Politics and Economics, but also for such varied subjects as Mathematics, Forestry, Law, French, English, Classics, Physics, Chemistry, and Applied Science. The scholarship may be awarded for a second year to the same candidate, providing his or her record and promise are satisfactory. Reports of the work done during the tenure of the scholarship will be asked for from the holder of the scholarship is studying.

Each scholarship is of the value of \$1,500 a year. The payment will be made in three instalments, payable at the London branch of the Dominion Bank, the first (\$500) on or after October 1st, the second (\$400) on or after March 1st, and the third (\$400) on or after June 1st. Payments will be made in sterling at the rate of exchange prevailing in any year, in any Province, there be no first-class candidate, the scholarship shall not be awarded.

The Order expects that all who hold the scholarships will return to Canada and work there after the completion of their work in a British University. The United Kingdom will give any assistance in its power to help a returned Scholarship-holder to secure a position in Canada.

The scholarships are awarded under the following conditions: (a) Candidates may be men or women and unmarried, and must be of legal age at the time of the award. They must be British born, or naturalized allies, or naturalized citizens of the United Kingdom, or of any Dominion of the British Empire, and must have passed their 19th but not their 27th birthday in October of the year during which they first held the scholarship. In the case of Ex-Servicemen, they must have passed their 19th but not their 34th birthday in October of the year during which they first held the scholarship. But any candidate who has applied for and held the scholarship in one year, and who was then eligible, may apply in the following year. Each candidate must hold a degree from a recognized University or degree-granting College in Canada and must have done, or be doing, post-graduate work. A candidate shall apply to the Province in which the University is situated from which he or she has graduated, or to another such candidate may apply either in the Province where he or she attended a University or in the Province where he or she has taken his or her degree. Where there is no University in a Province the Committee of Selection in that Province shall award the scholarship to a man or woman from that Province, who has graduated from any Canadian University or College and has done, or is doing, post-graduate work. Candidates from a Province, having no University may apply only in that Province, not in the Province where they have taken a degree.

In awarding the scholarship, the Committee of Selection will consider academic attainments and promise, and also personal character and physical fitness. Other conditions being equal, preference will be given to a returned soldier, brother, son or daughter. Another specific purpose of the Memorial Fund is to establish bursaries in Canadian Universities of sufficient value to provide or assist in providing a university education for a recognized or disabled son or daughter of a man or woman who served in the armed forces of the Empire during the years 1914-1918, or who served in the armed forces of the Empire during the years 1939-45, and who suffered permanent injuries or disabilities as a result of such service, or who provided a university education or its recognized equivalent for a son or daughter of such a man or woman.

To Succeed De Havilland

Well Known Hotel Doorman Retires

OTTAWA, October 8.—Thirty-one years ago Saturday in the midst of the dignity and charm of Canada's capital city, William A. Holtz, an imposing figure in uniform descended the steps of the Chateau Laurier Hotel to open the door of an approaching hansom cab. He had begun his duties as doorman at that hotel, made famous by the visits of crowned heads and state dignitaries from all over the world. Today, after three decades in the centre of history making events, Mr. Holtz retired on pension and crossed the threshold of his 66th year and he greeted

ed his retirement with the same vigour and smile that has won him the friendship of Canada's prime ministers from Sir Wilfrid Laurier to the Rt. Hon. W. L. Mackenzie King.

From the steps of the Chateau Laurier Mr. Holtz, a native of Ottawa, has seen his capital grow and become renowned throughout the world; met the leaders of all walks of life and witnessed the evolution of urban conveyance from the horse drawn carriage to the modern streamlined taxicab. Counting among those to whom he has rendered service are King George and Queen Elizabeth; the former Prince of Wales and the Queen of the Netherlands. OTTAWA, Oct. 8.—(CP)—A trial within the conspiracy trial of H. C. Gagnon, recently promoted from the job of directing criminal investigation, testified from an easy chair in the living room of his home because an operation yesterday left him in a condition that precluded an appearance in Ontario's Supreme Court.

He had been subpoenaed by A. W. Beaman of Ottawa, defending Gerson on a charge of conspiring to give confidential information to Russia. Bottlenecks Cut Amount To Be Spent

OTTAWA, Oct. 8.—(CP)—Industrial bottlenecks—strikes and manpower and material shortages—have cut by \$187,000,000 the amount which Canadian business enterprises had planned to invest this year in durable physical assets, the reconstruction department said today.

In a review of the investment intentions of Canadian industry, the department reported that 13,430 firms had indicated they intended to invest \$1,187,000,000 in 1946 but added that it did not expect this figure to exceed \$1,000,000,000 because of shortages arising from reconstruction difficulties and strikes.

The department's report, based on a survey among the business establishments, said that even at a reduced figure of \$1,000,000,000 the investment level would be 30 per cent above the 1945 total and 80 per cent in excess of the amount expended in 1938. It added—

"This increase will compensate in part for the decline in public expenditures which has followed the conclusion of the war. If investment plans involving comparatively large private expenditures can be realized, a high level of employment and income for the remainder of the year is indicated."

The report estimated that approximately \$450,000,000 of the \$628,000,000 which the canvassed firms expected to spend on new capital goods would be realized this year. Additional expenditures by firms not covered by the survey were expected to total \$305,000,000.

It said that in all Canadian businesses were expected to spend \$1,170,000,000 this year on new construction, machinery and repairs and maintenance. Public utilities indicated they planned to spend \$57,000,000, manufacturing industries \$543,000,000, mining enterprises \$42,000,000, woods operations \$13,000,000 and banking \$5,000,000.

Mar. Strike Will Continue

WASHINGTON, Oct. 8.—(AP)—A West Coast union leader bolted the United States maritime strike conferences here today, and Labor Secretary Schwelienbach personally intervened in an effort to end the tie-up at least on the Atlantic and Gulf coasts.

Ladue, head of the west coast branch of the A. F. L. masters, mates and pilots, announced he was leaving for San Francisco by plane and told reporters—

"We will fight it out on the west coast." The deck officer said he would report to a union meeting in San Francisco tomorrow that the Pacific operator representatives at the government conference here would not negotiate on the union demand for preferential hiring of union members for deck and engine room posts. This is the major issue in the strike of A.F.L. ship officers and C.I.O. engineers.

In an effort to save the conference between the A. F. L. union and Atlantic and Gulf coast shippers, Mr. Schwelienbach intervened in mid-afternoon, making a personal plea for agreement. Accord was within grasp for a
