

MCNAMARA TRIAL

IS HALTED BY LEGAL HOLA

LOS ANGELES, Cal., Oct. 12—James B. McNamara, of Cincinnati, was placed on trial for murder here yesterday before Judge Bordwell, in the Superior Court.

THE SPECIFIC INDICTMENT

Not only did Mr. Frederick elect to try James rather than his brother, John J., Secretary of the International Association of Bridge and Structural Iron Workers, but he decided to go to trial on the indictment charging the prisoner with the death of J. Hager, a machinist, whose body was found close to the spot at which the explosion is alleged to have occurred.

The McNamaras were brought into court together and remained until James B. McNamara was selected for trial, when John J., was returned to his cell in the County Jail.

INTENSE INTEREST

LOS ANGELES, Cal., Oct. 12—Manifested in the case of the McNamara Western Federation of Miners for the alleged assassination of Senator Steuneger of Idaho, has a trial in this country excited the intense interest in labor circles and among the public generally as is manifested in the case of the McNamara brothers, who are brought to the bar to answer for alleged complicity in the dynamiting outrage that resulted in the destruction of the Los Angeles Times building and the death of twenty-one men working there, on October 1, 1910.

THE LINE OF BATTLE

The lines of battle planned by Clarence J. Darrow, chief counsel of the defense, and District Attorney John D. Fredericks, who will conduct the prosecution, already have been pretty clearly revealed. The prosecution will first seek to establish that the Times building was destroyed by an explosion of dynamite. Then will come the testimony of relatives to establish the number of victims, corroborating evidence and the confession of McManigal. This will be followed by the identification of witnesses who will swear that they knew J. E. McNamara as J. B. Bryce in Los Angeles and in San Francisco during September and October of last year. An endeavor will be made to trace the accused almost to the Times building, where the explosion occurred. The case against J. J. McNamara will be centered upon correspondence furnished by McManigal, and books found at McNamara's not

office and the clocks and wire wound in Indianapolis. In this matter Detective William J. Burns will be called as a witness.

The defense will attack the allegation that the building was destroyed by dynamite, will assert that the explosion was caused by gas and will call experts. In attacking the McManigal confession the defense will call witnesses to establish an alibi for the McNamara brothers. In every instance where the McNamaras are identified by McManigal at a certain time and place the defense is expected to call witnesses to show that the men were in other localities. Experts on handwriting will be called to prove that letters alleged person who attempted to stimulate by J. J. McNamara were not written by him, but were written by some of the writing of the union leader.

Unless all signs go astray the trial will occupy many weeks. The defense alone will subpoena 350 witnesses. These will come from all parts of the United States, about 150 of them from San Francisco and vicinity. District Attorney Fredericks estimates that the prosecution will summon a similar number, bringing the total up to 700. The cost of service on these witnesses and the expense of bringing them to Los Angeles probably will make the trial the most expensive that the country has ever known. Mr. Darrow estimates the probable expense of the defense at \$400,000, while it is believed it will cost the prosecution not less than \$500,000.

INVESTIGATOR TELLS STARTLING STORY

ALBANY, N. Y., Oct. 12—The scord details of an investigation of Albany's tenderloin were related today before the Senate Committee which is delving into the affairs of the city and county, by Robert S. McClelland, a New York city investigator. McClelland, an employee of James James W. Osborne, counsel to the committee told of arranging to open a disorderly house in the Red Light District, and of having been sent by E. C. Roche, a former city official to see Howard C. Coons, Republican leader of the Fourth District of the Fourth Ward, who in turn introduced him to a man named McNamara, from whom he leased a house on Division Street, which he proposed to open under the name of "The Temple of Beauty".

The witness also testified that he had been directed by Coons as to where he should purchase his furniture, liquors and other supplies and bills were introduced in evidence as showing the purchases. Three women who came to Albany from New York to assist McClelland in opening the house, are still in the city and probably will be called to corroborate his story. The investigator told of the various alleged disorderly places he had visited, and of having purchased beer bottled by E. C. Roche in almost every place.

MARQUIS MADLY IN LOVE. LONDON, Oct. 12—British society is profoundly interested in the romance of the 23-year-old Marquis of Stafford, heir of the Duke of Sutherland and his millions. The Marquis has fallen madly in love with an East Indian Princess, Pretiva, daughter of the late Moharajah of Cooh-Behar. The Cooh-Behar family stayed all summer at Bexhill, where young Stafford was an almost continuous visitor, paying attentions to the Princess. The lovers are now temporarily separated, for the Princess has gone to India with her mother, the Maharajah of Cooh-Behar, carrying the Maharajah's ashes. The Marquis of Stafford's family hope the youth's ardor will cool during the Princess's absence, for they are utterly opposed to the marriage. The only instance of a marriage between representatives of great English and Indian families was that of Lady Anne, the youngest of the Earl of Coventry's third daughter and sister-in-law of Viscountess Deerburch, who was Virginia Bogue of California. Lady Anne married nearly four years ago Prince Victor Albert Jay Duleep Singh, the eldest son (born in London) of the late Maharajah Duleep Singh of Lahore. The Prince is an officer in the English army, a captain of dragoons. Princess Pretiva, known to her intimates as "Princess Pretty," is one of the most beautiful debutantes of the season. She is slightly dark, though her features have a strong Oriental cast. Her sister is almost as fair as that of an English girl. She has been educated in Europe with the utmost care. Her mother, the Maharajah, is one of the most enlightened of Indian women. Princess Pretiva excels in outdoor sports. She is an accomplished skater and celebrated as such at St. Moritz. She loves England, where she has spent the greater part of her life, and has declared herself a bitterly opposed to an alliance with an Indian potentate. Stafford has sworn that he will follow her to India, making the Durbar there a pretext for his visit. He is an amiable youth, but has not inherited many of the intellectual gifts of his brilliant mother.
