relief. The specific or special drug effective in stopping an attack of asthma is adrenalin or ephedrine, which usually brings relief within five minutes after 10 to 15 minims (drops) have been injected under the skin. Sometimes inhaling either, or amyl nitrite, is effective in stopping or averting an attack, and the ping an attack.

However, there are cases where these forms of treatment are not use of a suppository containing a drug or drugs is placed in the rectum. A suppository is a mass of oil or glycerine, soothing to a soft tissue.

Dr. S. J. Prigal in Journal of Allergy reports the successful use of suppositories containing aminophylline and sodium pentobarbital in asthmatic patients. The suppository for an adult contains 0.5 gm. aminophylline and 0.1 grams pentobarbital sodium; the suppository for children contains one-half of these amounts. Suppositories containing aminophylline alone gave relief to only 38 to 47 patients treated by this method; the use of both drugs gave relief to 44 of 47 patients. Further, relief was obtained in half the time where the suppository contained both drugs.

The use of this simple method of preventing or stopping asthmatic attacks is especially satisfactory for children or for adults with heart disease.

The minimum cash payment and regulations required on time sales of farm implements and tractors remains the same as enacted by the Wartime Prices and Trade Board in 1941 namely:

All time sales must have a minimum cash payment of 40% of the purchase price. Where any trade-in is taken by dealer the allowance for same is to be deducted from the purchase price and the cash payment computed as 40% of balance. Full settlement must be made by purchaser before time of delivery either in cash or at least 40% cash and signed notes for the balance.

Machines cannot be left on trial. When demonstrations are necessary they must be settled for or taken back on delivery date. Customers are fully protected by warranty on purchasers' order form.

WE WISH PARTICULARLY TO DRAW YOUR ATTENTION TO REPAIR PARTS.

All dealers are endeavouring to provide an adequate supply of repair parts which necessitates a great outlay of cash to keep in stock. Therefore, all repairs are sold on a strictly over the counter cash basis. This rule must be strictly followed and applies to everyone.
