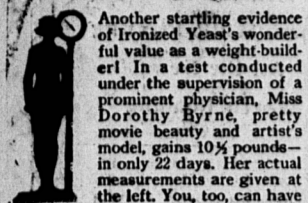

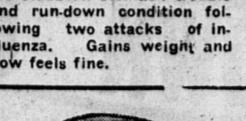
The Ohio and Tavern events carry \$5,000 purses. The Ohio is for the 2:05 trotters. In it, McGregor the Great will in all probability make his first start since 1919, when he carried everything before him in his four year old form. The other candidates include Charlesworth from the Murphy stable, the half-mile race record breaker Herbelvino, Voltage, Just David and Walter Sterling. McDonald has the Great Rose and King Watts in this race. The latter was not started since 1920, while the Peter the Great filly showed three year olds in training last season. The double called champion Prince Loree is also named. If he races up to what he has shown in his work it will take a 2:05 trotter to catch him.

Lorena Watts, a winner at Sandusky, will make her first start over the mile tracks this year in the Tavern Stakes. She will be in hot company with the other entries include Laurel Hall of Long Set from the Good Time Stable, David Axworthy, Princess Etawah, a 2:03 trotter last year, and Taurida, one of the most formidable members of the Hillendale Stable. Twenty-two youngsters are named to start in the three year old trot, which will give the public its first line in the future maetrial for 1922. Of this lot Ben White has been winning over the half-mile tracks with Lee Worthy while Addie has credited the well known pacer Adioo Guy, with his first premier. She is a member of Fred Eiman's Stable. Brook Farm will start Edith Worthy with which it made a good showing in the two year old event in 1921, while Murphy will in all probability filly take the word behind Billy Smith. The other eligible candidates include Emilee, Mary Sedey, Axwah, and Eleanor Worthy. Murphy has Peter Henley and the Sherwood in the Edwards Purse for the 2:08 pacers. JOHN PARIS STANDS TRIAL FOR FOURTH TIME ON MURDER CHARGE

Nine Year Old Sadie McAuley Outraged and Killed Last August — Two Juries Disagree as to Prisoner's Guilt, One Other Finds Him Guilty — Case Begins This Morning.

ST. JOHN, July 4.—For the fourth time within the past eleven months the life of John Paris will be placed in the hands of a jury of twelve men tried and true, and this morning he will again stand trial for his life, charged with the murder of the nine-year-old Sadie McAuley.

The story of the dastardly murder of the little cripple girl in Riverview Park last August, has been given such prominence in the press, that the pathetic narrative is by now familiar to all. The murder is believed to have been committed on August 2. On that day the little girl, accompanied by a playmate, Hattie Lavigne, to the park where the latter brought her father, who was working there, his dinner. Having fulfilled their mission, the two children wandered down the bank of the river, which slopes toward Marble Cove, and began to pick berries. A man appeared and offered to show them where the berries could get bigger berries. Sadie followed him, but little Hattie declined to do so, and returned to the Douglas Avenue entrance to the park. She called to Sadie, and, receiving no answer, made her way home. Several hours later she returned with Sadie's elder sister to get the little girl, but Sadie had disappeared. Search parties were organized but no trace was found of the child, until over a week afterwards, when her body, (to quote the words of the trial judge) "was found buried like a dog" underneath a large rock in the park. A post mortem examination disclosed the fact that the child had been horribly outraged and then choked to death. The indignation of the community reached a boiling point, and, acting on the fairly good description of the man seen with the murdered child by Hattie Lavigne, the local authorities enlisted the efforts of the police from Montreal to Halifax in an effort to track down the disreputable and the services of the superintendent of the Pinkerton Detective Agency of Boston were also secured.

Many Suspected Suspicion fell on every man who in any way answered to the description and many suspects were eliminated until only John Paris, a young mulatto, some twenty-six years of age, a native of Truro, N. S., but who had been living in West St. John for the past year, was among these, but there was no damaging evidence against him at the time he was released to the Truro police to answer to the charge.

In the meantime a reward of \$500 was offered by the city for the capture of the murderer, and it was commonly believed that the province had offered \$500 more. Some time later Walter Humphrey, a companion of Paris, disclosed to the police a confession of the murder which he alleged Paris made to him. Paris was immediately brought back from Truro, where he had been cleared of the charge, and committed to trial for the murder.

The Trials. The case came up in September, His Honor Judge Barry presided, Dr. W. B. Wallace, K. C., conducted the case for the Crown, and G. H. Vernon, K. C., of Truro, defended the prisoner. The trial lasted four days, and after much conflicting evidence had been submitted, ended in a disagreement, seven jurors voting for conviction and five for acquittal.

A second trial was ordered and came up in November, the Attorney-General, the Hon. Mr. Byrne, K. C., took over the case for the Crown, with Dr. Wallace as counsel. Mr. Vernon continuing as counsel for the defence. The case was tried before Mr. Justice Chandler and lasted ten days, the jury returning a verdict of guilty. Mr. Vernon, in an appeal to the Appellate Division of the Supreme Court, succeeded in having a new trial granted on two points, viz., the prisoner had not been present when the jury returned to the court room for further instructions and that the judge had not sufficiently instructed the jury as to the aims set up by the defence.

The third trial came up in May and was presided over by Judge Barry, the counsel being the same as at the second trial. The trial which lasted 13 days, attracted even more popular interest than either of the two preceding trials. It ended in a disagreement, seven jurors voting for conviction and five for acquittal.

On motion of the Crown a fourth trial was granted and will begin today. His Honor Judge Chandler, presiding. As matters now stand, the fate of Paris has been placed in the hands of 36 citizens of St. John, of these 26 have found him guilty on the evidence submitted, and 10 have found him not guilty.
