**St. Andrew's Credit Union Annual Meeting**

The annual meeting of the St. Andrew's Credit Union was held in St. Andrew's Jubilee Hall January 18th, with a good attendance. After calling the meeting to order the President, Mr. W. F. Rose reviewed the work done during the year. In the course of his remarks, he stressed the necessity of Study Clubs, the only true medium through which the members may gain a thorough understanding of the principles of the union and be properly fitted to discharge their duties. He complimented the members on the keen interest they manifested in their various study clubs, and urged them to continue the good work.

The treasurer then gave his report. The total business for the year was \$129,974 with a membership of 173. A dividend of 3 per cent on shares was paid and 2 per cent interest on deposits was also paid.

The report of the Credit Committee showed the amount loaned was \$5353.80 amount paid back \$3380.40 making a total loan business of \$9,234.20. The number of loans made during the year was 170 with no delinquent accounts. The report of the Supervisory Committee showed the work of the credit union was carried on in a satisfactory manner.

**APPEALS IN LIQUOR CASES ARE DISMISSED**

Argument Re Meaning Of "Sale" Of Illegal Liquor Dealt With In Court Judgment.

Judgment was filed yesterday morning by Mr. Justice Saunders in the case of Myrtle Poir, appellant, and the King, respondent, before an appeal against a conviction of Suspendatory Magistrate Tweedy of violation of the Prohibition Act. The appeal was dismissed with costs. An appeal of Elizabeth MacLean, appellant, and the basis of argument being the same as in the Poir case, was also dismissed.

In the Poir case the judgment of the Crown witness Albert Robert in some length, the evidence and finds that the identity of the appellant was established.

The judgment deals at length with the argument of counsel for the appellant that there can be no sale of illegally held liquors in the province, as section 88 of the Prohibition Act expressly declares that no exist in liquors unlawfully kept at any place in the province, and the transfer of property rights is essential to a sale.

On this point the judgment reads in part:

"To me the interpretation placed on the word 'sale' by the appellant would deprive the word when used to denote an offence under the Act of the commonly understood meaning of the term, and would substitute therefor a meaning which has been developed in the common law as attaching to the word 'sale' when used to denote a certain kind of contract."

"In what sense did the Legislature intend to use the word in this Statute? Section 88 states that 'no property rights of any kind shall exist in any liquor which is kept, stored, or deposited... for the purpose of unlawful sale'—substitute for 'sale' the words 'transfer of property rights' and the Legislature enacting: 'No property rights of any kind shall exist in any liquor which is kept, stored or deposited for the purpose of unlawful transfer of property rights.' Now, substitute for 'sale' words denoting the usual application, such as 'giving for a price,' and we have: 'No property rights of any kind shall exist in any liquor which is kept, stored or deposited for the purpose of unlawful 'giving for a price.' If the keeper of liquor keeps it with the purpose of unlawfully transferring the same in the future, his property rights therein, these rights cease immediately to exist; and he will therefore never be able to transfer them. This will be the situation under the interpretation urged by the appellant. By giving to the word 'sale' its more usual meaning, the situation will be as follows: 'The keeper of liquor keeps it with the purpose of unlawfully giving it for a price some time in the future, his property rights in the liquor cease immediately to exist; but he can still be guilty of the offence of unlawfully giving the liquor for a price at a future time.'

"I can hardly suppose the Legislature to have made a distinction so void of significance as would result from the former interpretation."

"Does not Section 89 of the 1937 Act lend colour and weight to such an interpretation of Section 88? It states in part: 'Every sale on account of liquor furnished in contravention of the Act shall be wholly null and void, and no act or omission of any kind shall be maintained on account of any liquor so furnished in contravention of the Act, or otherwise in violation of law.'"

"If there can be no sale of illegally held liquor, why is this Section necessary?"

Sections 125 and 51 are quoted in the judgment to show that the Act was intended to apply to such illegal transactions as the sale by the appellant in this case.

With regard to the counsel's objection that the witnesses were not corroborated, the judgment cites authorities to show that an agent provocateur is not on the same footing as an accomplice and the mere absence of corroboration of the evidence of a single officer is not sufficient to quash a conviction.

**APPEALS IN LIQUOR CASES ARE DISMISSED**

Argument Re Meaning Of "Sale" Of Illegal Liquor Dealt With In Court Judgment.

Judgment was filed yesterday morning by Mr. Justice Saunders in the case of Myrtle Poir, appellant, and the King, respondent, before an appeal against a conviction of Suspendatory Magistrate Tweedy of violation of the Prohibition Act. The appeal was dismissed with costs. An appeal of Elizabeth MacLean, appellant, and the basis of argument being the same as in the Poir case, was also dismissed.

In the Poir case the judgment of the Crown witness Albert Robert in some length, the evidence and finds that the identity of the appellant was established.

The judgment deals at length with the argument of counsel for the appellant that there can be no sale of illegally held liquors in the province, as section 88 of the Prohibition Act expressly declares that no exist in liquors unlawfully kept at any place in the province, and the transfer of property rights is essential to a sale.

On this point the judgment reads in part:

"To me the interpretation placed on the word 'sale' by the appellant would deprive the word when used to denote an offence under the Act of the commonly understood meaning of the term, and would substitute therefor a meaning which has been developed in the common law as attaching to the word 'sale' when used to denote a certain kind of contract."

"In what sense did the Legislature intend to use the word in this Statute? Section 88 states that 'no property rights of any kind shall exist in any liquor which is kept, stored, or deposited... for the purpose of unlawful sale'—substitute for 'sale' the words 'transfer of property rights' and the Legislature enacting: 'No property rights of any kind shall exist in any liquor which is kept, stored or deposited for the purpose of unlawful transfer of property rights.' Now, substitute for 'sale' words denoting the usual application, such as 'giving for a price,' and we have: 'No property rights of any kind shall exist in any liquor which is kept, stored or deposited for the purpose of unlawful 'giving for a price.' If the keeper of liquor keeps it with the purpose of unlawfully transferring the same in the future, his property rights therein, these rights cease immediately to exist; and he will therefore never be able to transfer them. This will be the situation under the interpretation urged by the appellant. By giving to the word 'sale' its more usual meaning, the situation will be as follows: 'The keeper of liquor keeps it with the purpose of unlawfully giving it for a price some time in the future, his property rights in the liquor cease immediately to exist; but he can still be guilty of the offence of unlawfully giving the liquor for a price at a future time.'

"I can hardly suppose the Legislature to have made a distinction so void of significance as would result from the former interpretation."

"Does not Section 89 of the 1937 Act lend colour and weight to such an interpretation of Section 88? It states in part: 'Every sale on account of liquor furnished in contravention of the Act shall be wholly null and void, and no act or omission of any kind shall be maintained on account of any liquor so furnished in contravention of the Act, or otherwise in violation of law.'"

"If there can be no sale of illegally held liquor, why is this Section necessary?"

Sections 125 and 51 are quoted in the judgment to show that the Act was intended to apply to such illegal transactions as the sale by the appellant in this case.

With regard to the counsel's objection that the witnesses were not corroborated, the judgment cites authorities to show that an agent provocateur is not on the same footing as an accomplice and the mere absence of corroboration of the evidence of a single officer is not sufficient to quash a conviction.

WASHINGTON, D. C., Jan. 31 —The three hundredth anniversary of the introduction of quinine to civilization will be observed this week.

The healing properties of the chinchona bark were made known to civilization by the Inca Indians in February 1638, when the physician to Countess Ana, wife of Don Luis, Count of Chinchon, Peru treated her for malaria with the bark of a tree which the Indians had brought into Peru from Ecuador. She recovered and her husband, Count Chinchon immediately started an expedition to the mouth of the Amazon to procure some of the bark and later took it to Spain. In 1642, Cardinal de Lugo of Spain took the bark to France and toured the country treating malaria sufferers with some success.

In its three hundred years history, quinine has proved a boon to mankind in the prevention and treatment of malaria, influenza and other fever diseases. With the progress of science in draining mosquito infested marshes in malarial districts, the dread scourge is being slowly vanquished. There is much constructive action in Southern States of the United States in battling malaria.

It is only comparatively recent years that the action of quinine in preventing malaria has been understood. Exhaustive research by the League of Nations Malaria Commission resulted in a recent recommendation of the use of quinine in daily doses of six grains during the malaria season. The preventative has resulted in a marked decrease in malaria in countries where research was undertaken. Based on recent international medical research and study, quinine is also recommended as a preventative of influenza if taken in three-grain doses, during the influenza season.

Chinchona bark was not named until one hundred years after Countess Chinchon's recovery, when Linnaeus, great Swedish botanist, named it chinchona bark in her honor. The word quinine is derived from a quina-quina, the term which the aborigines of Ecuador applied to the bark.
