Apparently, to convey the impression that Canadians attach little value to the provision of lumber to the British government, and that some increased difficulty of dealing with it from the government standpoint.

"But every possible step is being taken by representation made by the High Commissioner to the Ministry of the British government. The British government, when the matter reaches the president of the board of trade more formal representations will be made.

"Neither the British nor the Canadian government is concerned in the matter, but with a contract made by a private company known as Timber Distributors with the Russian authorities. After the contract is made, if it is believed that that contract contravenes in any way the provisions of the Maritime Provinces Agreement dealing with the matter to which I have referred, it is competent for the Canadian government to make representations to the British government, which has taken power from parliament to deal with the matter, and then action is taken in accordance with the provisions of the British statute."

available for distribution within the next few days.

The regulations provide for the pegging of prices, the orderly marketing of the product and the prevention of ruinous price cutting.

Mr. Cunningham declared tonight the Board believes that by regulating the price of the crop, prices will be increased materially. "Present indications are that the first minimum price quotation will be double that now being received by the growers," he said. "Further increases may be anticipated from time to time as market conditions justify."

He continued that it was fully realized the consumer and distributor in the larger centres did object to paying a price which would cover the farmer's cost of production. In fact, many consumers had intimated to him that they would not object to paying a price of from 75 to 80 per cent above the present price, but that so long as the producer forced his own price down they were willing to pay the going price and no more.

## YESTERDAY IN PARLIAMENT

OTTAWA, Jan. 31.—A House of figures broke out in the House of Commons today when Joseph Harris (Cons. Toronto-Scarborough) sponsored a motion acclaiming the operations of the Ottawa Imperial Conference agreements. He quoted long lists of figures showing where trade increased only to have Liberals come back with another set of figures showing trade reductions.

"The debate, which may extend over several private members' days, was considered important from a political viewpoint. When the ratification came before the House for the first time after the 1923 conference of the Liberals opposed them. Since then government supporters have been loud in their praise of the pact and it was believed they may pay a part in the general election later this year."

There were no front-benchers in the debate but it was expected they will enter it before conclusion. It was thought likely the debate will end in a division at the insistence of the government.

## AMOUNT PAID N. B.

OTTAWA, Jan. 31.—(C.P.)—Between June 1, 1934, and December 31, 1934, the Dominion government's portion of relief expenditures by the province, Minister of Labor W. A. Gordon today told the House of Commons in answer to a question by J. E. Michaud (Liberal, Restigouche-Madawaska).

The distribution was as follows: grant in aid, under the agreement of payments at the rate of \$28,000 per month, in effect until March 31, 1934—\$125,000; direct relief \$96,187; public works \$476,000; to make highways \$1,000,000; emergency relief to forest fire sufferers \$2,037.

These amounts are exclusive of relief to the single unemployed in camps, contributions to most of the trans-Canada highway, provincial highways and provincial public works undertaken to relieve unemployment.

## Trade With Free State
