**Is It Another Pineau Scandal At Ottawa?**

The MacKenzie King Government has "Acquired" a Majority After the Manner of the Peters' Government in the Allegation at Ottawa. Cabinet Minister Involved.  
 OTTAWA, Jan. 10.—The session of 1923 will probably be longer than that of 1922, especially if the Government undertakes a revision of the Bank Act in addition to the passage of a bill redistributing federal constituencies and other necessary legislation. The situation in the House of Commons from a political standpoint, too, will be somewhat different this year from that of a year ago, as a result of changes in the Progressive group. Two members elected as Progressives, W. J. Hammell, of Muskoka, and Joseph Binnette, of Prescott, have let it be known that they will give the King Government their support during the coming session. In consequence of their decision, the Government, which a year ago had a strength of 117, including Speaker Lemieux, in a House of 235 members, will this year have a voting strength of 119. In other words, the minority which last year was actually in a minority in the Commons, will now be assured a small majority. Neither Mr. Hammell nor Mr. Binnette has offered any extended explanation of his proposed defection from the Progressive group. Hence they are likely to be subjected to criticism by their former confederates in the Progressive group and to be asked to state their reasons for transferring their allegiance to the Liberal party and Government. Already Mr. Hammell has been called upon by the United Farmers' executive in the constituency of Muskoka to resign his seat on the ground that he is violating his mandate from the electors.

**Bid for Progressives.**  
 The circumstances under which the Government has acquired the support of two members would seem to make it desirable that the public be informed of their reasons for abandoning their own party for another. Rumor in Ottawa is to the effect that a Cabinet minister carried on negotiations with the prospective proselytes and that their example may be followed by several other Progressives. Both Mr. Hammell and Mr. Binnette are allying themselves with the Liberals within three months after the Progressive caucus at Winnipeg declined to enter into an alliance with the party in power and determined to maintain the identity of the Progressive party. Neither has announced that he disavows any new feature of the Liberal platform which demands his support. Mr. Hammell was elected in a constituency which has generally been strongly Conservative. In order not to estrange Conservative farmers, Mr. Hammell declined last autumn to accept a joint nomination from the Progressives and Liberals of Muskoka. He undoubtedly was elected by the aid of voters who had formerly been Conservatives and who would never have used their votes to strengthen their former political opponents, the Liberals. Mr. Binnette was elected in a three-cornered fight in Prescott. The Liberal party in the riding was split into two factions, each of which nominated a candidate. Mr. Binnette won, and now, probably foreseeing the disintegration of the Progressive movement in Ontario, seems to be seeking to conciliate the Liberal Government with an eye to a Liberal nomination in Prescott at the next general election.

 LONDON, Jan. 10.—Rt. Hon. JOHN'S Nfld., Jan. 10.—A body believed to be that of Miss Margaret Lindsay, volunteer teacher at the Labrador public school, who disappeared on August 22 last, has been reported found in the woods near Cartwright, according to a marconigram to Superintendent J. J. Collins of the Wireless Telegraph Company from the operator at Battle Harbor, Labrador. The discoverers were unable to say for sure whether the body was that of Miss Lindsay.  
 On the day of her disappearance Miss Lindsay left her quarters at Cartwright, presumably to go bathing and was never afterwards heard of, nor was her clothing or anything that would serve to account for her mysterious disappearance found. Miss Lindsay's brother came from Montreal shortly afterwards and aided in the search.

**An Imaginary Race Aged Jockey's Last**

CARLEVILLE, Ills. Jan. 10.—Clutching imaginary reins, feebly shouting encouragement to a phantom pony, and brandishing to the last his old race whip, J. A. Sweeney, 36, veteran jockey, yesterday dashed past his last goal, a winner—dying in the role he had played in his last race.  
 "I'm right in his bed and starting fixedly before him, the way he rode boldly ahead into another world—a world in which he had often said he hoped there would be horses.  
 His wife, comrade of his love for horses, played an heroic role in this last scene.  
 With her arms about his frail body, she supported him, assuring him that there was no mile, who, all was ready. His horse was waiting. She continued the pathetic race to the end, even stimulating for him the clang of the starter's bell.  
 Sweeney, several years ago, at his own request left the house in which he lived for a room in the stable.
