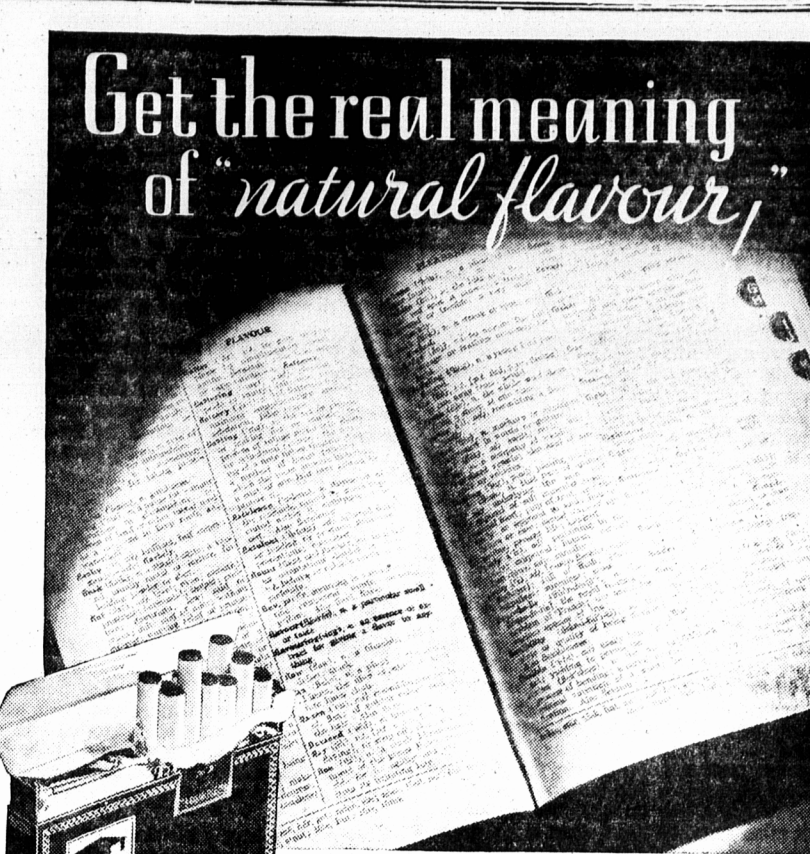

Grain Exempt From Demurrage Charges

OTTAWA, July 19—(CP)—Canada's grain trade remains exempt from demurrage charges at terminal elevators. In a judgment announced today the Board of Railway Commissioners declined a proposal of the Railway Companies that demurrage charges be assessed where unloading of grain is delayed. Other kinds of freight pay demurrage if cars remain at their destination more than 48 hours before unloading and returned to the railway. The charge has never been applied to grain, however, and the Board found the railways had not made out a case for changing the rule. Evidence was heard by the Board at Vancouver Port Arthur and Winnipeg and final legal argument was heard here last week.
