...and down and that he heard some one say "are you crazy". He also stated when cross examined by Mr. Lowther that he had no idea that it was Cahill's car or that Cahill was involved in the accident. Perry was the next witness called and testified to seeing the prisoner in his car going east west several times as she was sitting outside the house of Mrs. Frank Allen on Water Street. He was driving very fast and going from one side of the road to the other.

The last time witness saw prisoner he was driving into Bob Brady's yard. Cross examined by Mr. Thane A. Campbell for the defence, witness stated that she was sure it was Cahill driving the car and not another man. Mrs. Mary Arsenault, who lives at 200 St. John's Street, testified that she returned home from the country that evening about 7:45 and at the corner of Duke and Water Street saw prisoner in his car. He was going at a terrible rate. Witness did not see the accident but heard about it afterwards. She was about half way home when the light came on.

Wm. Arsenault, testified to seeing prisoner go past his place at the corner of Second Street shortly before 8 o'clock on Sept. 5th, driving fast. Felix Gallant gave evidence that he returned from the country about 8 o'clock on Sept. 5th, and stopped at Second Street. He saw a car going west and a few minutes afterwards was asked to take a man to the hospital. He noticed a light by the electric light post at the corner of the road.

James Edwards, a constable in the R. C. M. P. force gave evidence that he was in the office of the mounted Police about 8 o'clock when prisoner came in and told him about the accident. I told him he had been drinking and he said, "I have. Constable Spencer was with me."

Questioned by Mr. Lowther as to the prisoner's condition, witness replied, he was intoxicated. Spencer and I went with prisoner to the scene of the accident. The injured man had been taken to the hos-

pital. We saw a car at the culvert, the right front wheel was over the west end of the culvert. Parts of the buggy wheels were twisted round bumper of the car. Some parts of buggy were underneath the car and others strewn around. There was a street light at the west end of culvert.

We informed Police Officer White of the Summerside Police of the accident and went with him to the hospital and asked for the injured man. The prisoner was then placed in the County jail.

Cross examined by Mr. Lewis witness said prisoner had told him that a car had passed him with glaring lights and he could not see. Prisoner had suggested that they go to the scene of the accident. Court adjourned for recess.

AFTERNOON SESSION

The Crown had closed its case for the prosecution and prisoner had taken the stand on his own behalf when the Court adjourned at 5-15 p. m. until this morning when Cahill will continue his evidence as to what he did on September 5th. The Court will open at 10:00 this morning Constable Spencer of the R. C. M. P. took the stand after recess. He corroborated the evidence of Constable Edwards as to what took place after the prisoner came and told them of the accident. He also stated in cross examination that he was quite sure that prisoner did request that we visit the hospital. This was when we stopped to pick up Officer White. While he was with Cahill outside the Hospital prisoner told him that he had been drinking for a week but he had had trouble at home and had started drinking that day. Constable White of the Summerside Police was next called and stated that he saw accused in the R. C. M. P. car on Water Street shortly after eight o'clock on the evening of Sept. 5th, 1932. I was told there had been an accident in which prisoner was involved. I learned that the injured man was taken to the hospital, prisoner was under the influence of liquor at that time. I went to the hospital and found that the victim of the accident was Phillip Arsenault that his injuries were serious. Cahill asked how had the man was hurt and I said "quite badly, but I did not think he would die" prisoner seemed satisfied. We then took him and placed him in the Prince County Jail. I then went to the scene of the accident and saw prisoner's car No. 7461, it was standing on the bridge facing west. The bridge is between the Dowlan and Arsenaults house. Constable White corroborated the evidence of Constable Edwards as to the position of car on the bridge, the bumper was bent the lens was out of car and the glass out of windshield, fender had red paint marks on it the broken wagon was also there. Witness was satisfied that parts of wagon exhibited in court were the same as he saw at the scene of the accident. Witness described the different parts on wagon which were under car. It

was in practically the same condition as it is now. Prisoner's car would not start under its own power, there were no lights on car. Remember turning them on when I got into car, there was no speedometer on car. Chief of Police Kane sworn, stated that he did not consider the street a dangerous one to drive on, it was good as any in the Town. He had charge of the car since the accident. Wilfred E. Dystadt, mechanic at Pope's garage testified that prisoner's car was brought to him and that he checked up on the brakes. There was no speedometer on the car. Upon application of foot brakes car could be brought to a standstill at thirty feet. The emergency brake was not working. This closed the case for the Crown and prisoner took the stand on his own behalf.

LEAVE FOR 13TH NATIONAL CONVENTION

Mrs. W. J. MacIntyre, National President, leaves today for Quebec where she will preside over the 13th National Convention of the Catholic Women's League of Canada. His Excellency Rt. Rev. J. A. O'Sullivan, Bishop of Charlottetown, who is National Chaplain, will be one of the speakers and several ladies from Charlottetown and outside centres will be in attendance, among whom are Miss Florence Dorsey, local president, Mrs. Jos. Creamer, Kelly's Cross, Diocesan president; Mrs. M. M. Murphy, life member, and Mrs. J. P. McCloskey, all leaving Saturday morning.

Among the distinguished members of the hierarchy who have also signified their purpose to be present are Archbishop J. C. McGuigan of Regina, Bishop Kidd of London and Bishop Prudhomme of Prince Albert, Saskatchewan.

The programme arranged for the convention which is to be held in the Chateau Frontenac, is about complete. The session begins on Monday, June 12th, with a meeting of the National Executive presided over by Mrs. MacIntyre. The first day is given over to routine. In the evening the formal opening takes place with a reception and presentation of delegates to His Eminence the Cardinal Archbishop of Quebec. His Honor Lt. Governor Carroll and Hon. Premier Taschereau will extend the greetings of the Province of Quebec, the City's welcome will be given by Mayor Lavigne, and Miss Jean Talbot, President of Ligue Catholique Feminine will extend fraternal greetings. Following this Mrs. W. J. MacIntyre will give her Presidential address.

On Tuesday, June 13th, at 8 a.m. High Mass will be celebrated by Rt. Rev. Mgr. Eugene Lafamme, rector of the Basilica. The Convention proper will open with the raising of the League Flag by the Quebec Company of the C. W. L. Girl Guides. Mrs. J. Coffey of Montreal will present her report as Honorary Secretary, Miss Florence Boland of Toronto as Treasurer, and Miss Margaret Jones of Montreal, Executive Secretary, will give their respective reports. Mme. Charles Fremont, Canadian Government delegate to Geneva, will speak on the League of Nations at the luncheon hour. A garden party is scheduled for the afternoon at beautiful Spencerwood, official residence of Lieut.-Governor and Mme. Carroll. Two addresses are to be given in the evening—one by Miss Beatrice Brady of Ottawa, Convenor of Juniors, on "What of Our Youth?"; the other by Rev. Dr. Hugh J. Somers, St. Francis Xavier University, Antigonish, N. S., on "Training the Lay Catechist."

The business sessions will be given over to reports of Convenors of Standing Committees. A boat trip around Quebec Harbor with luncheon on board and dinner at Kent House, Montmorency Falls, with an open meeting in the evening at which the speakers will be Rt. Rev. Georges Courchesne, Bishop of Rimouski, on Catholic Standards in Social Welfare, and Lt. Col. Delaney, M. D., Quebec, on "Women in a Health Programme" form interesting features of the third day.

A full discussion on Education, National Scholarship and Study Clubs will occupy Thursday morning, while Discussion and adoption of Resolutions with time allowed for shopping and sightseeing form the afternoon programme. The banquet will be held on Thursday evening. His Eminence Cardinal Villeneuve will ask the blessing, and the toast to the Pope and the King will be spoken to by Rt. Rev. Joseph A. O'Sullivan, D. D., Bishop of Charlottetown, and Honorary Chaplain of the League. Sir Charles FitzPatrick, K. C. B., Quebec, will propose the toast "His Eminence the Cardinal," and Mrs. W. J. MacIntyre, National President, will speak to the toast "The League."

Rev. Wm. Bryan, S. J., Loyola College, Montreal, will give an address on "Catholic Contribution to Social Reconstruction." posed for increasing offerings next year is the "cent a meal" plan, by which each United Church family is invited to place a box on the table and put in a cent at each meal. General adopting of this plan would provide an adequate income for all enterprises of the church, it was said.

More than 75,000 "cent a meal" boxes already have been sent to United Church families, said Dr. Bryce, and he hoped to have 200,000 out before Christmas.

The annual banquet of Pine Hill Divinity Hall was held tonight, and the subsequent program was in charge of the Lay Association.

At Wednesday's session Rev. H. T. S. Cornell, Saint John, was re-elected secretary and Rev. G. A. Christie, Of York, P. E. I., was elected assistant secretary.

For the election of President, five names were placed in nomination, Dr. J. A. Clarke, one of the nominees having previously withdrawn. The ballot was taken and Rev. Dr. J. A. Ramsay received a clear majority. He was escorted to the platform by Dr. J. W. Falconer and Dr. H. C. Rice.

Meetings of the Lay Association and Pine Hill Alumni Association were held in the afternoon. Officers of the Lay Association were elected as follows: J. C. Gass, Halifax, president; Horace Wright, Beedon, P. E. I., and W. M. Burns, Fredericton, vice-presidents.
