CHIEF JUSTICE RECALLS 1873 SUPREME COURT PERSONNEL

Many Of The Men Connected With The Supreme Court Sitting At Confederation Lived To Become Distinguished Canadians On Bench Or At Bar.

In the course of his address to the Grand Jury at the opening of the Trinity Term of the Supreme Court yesterday, the Chief Justice referred to the forthcoming celebration of the Diamond Jubilee of Confederation and gave some interesting particulars of the sitting of the Court at the Trinity Term, 1873, during which term this Province entered Confederation.

"When the Court met on the 24th of June, 1873," his Lordship said, "we were a self governing Colony. When it closed we were a Province of the Dominion. So closely did the Court attend to its own business that I find no mention of the momentous event that had occurred. All that the Court records show is that there was an adjournment from Saturday, June 28th, until the following Wednesday.

"I have noted down the names of those who presided over the Court, of the members of the Grand Jury and of all the lawyers who were present on the trial of the various cases. The Chief Justice was Sir Robert Hodgson. Associated with him were James H. Peters, Assistant Judge and Master of the Rolls, and Joseph Hensley, Assistant Judge and Vice Chancellor. The Attorney General was Hon. F. Brecken; the Solicitor General, Hon. W. W. Sullivan; and the Leader of the Government, Hon. J. C. Pope.

"It was a strong Bench and a strong Bar. Sir Robert Hodgson was soon to close a distinguished career as the first native of the Island to hold the office of Lieutenant Governor. Hon. F. Brecken, the Attorney General, was to enter the Federal Parliament and win further laurels with his wonderful gift of speech.

Edward Palmer, the retiring Attorney General, was soon to succeed Sir Robert Hodgson as Chief Justice and to officiate with great distinction for twenty-five years. Hon. W. W. Sullivan, the Solicitor General, had before him a long and successful political career in which he was to become the leader of the Government and Attorney General, and at its close to succeed to the Chief Justiceship on the death of Hon. Edward Palmer, fully to maintain the high traditions of that office for twenty-eight years. In recognition of his long and faithful public services the Crown was to confer upon him the honor of Knighthood.

Edward Jarvis Hodgson, long noted at the Bar, was to succeed Judge Peters as Master of the Rolls and Judge of the Supreme Court. Rowan R. Fitzgerald was to succeed Judge Hensley as Vice-Chancellor and Judge of the Supreme Court, and to further improve and codify the Equity practice and procedure which Judge Hodgson had begun.

"George Alley was to become Judge of the County Court of Queens County and hold a unique but strong position there. Hon. John Longworth, renowned for his wisdom and humanity, Charles Palwood, the brilliant barrister, famed for his wit and winning ways with juries, and Malcolm McLeod, the great jurist, were to complete their years at the Bar. Robert Shaw, richly endowed with eloquence and literary talent, was to pass out of the scene before attaining the zenith of his powers.

"On Sir Louis Davies' fortune was to pour her gifts with unstinted measure. In his future lay the Premier's office, Member of the Dominion Parliament, Maritime Leader of his party, a brilliant career in Parliament, and finally the highest office ever attained by any member of this Bar—the Chief Justiceship of Canada.

"1873 was the period in the history of Bench and Bar and public life that saw the end of our Colonial history and the opening of a new era for this Island as a Province of the Dominion of Canada. In the Courts this transition period is remarkable for the solid worth and brilliance of Bench and Bar.

"The quality of the Grand Jury reflected the high standard of intelligence and character prevailing in town and country. The members of the Grand Jury for the Trinity Term, 1873, were: William Murphy, James DesBrisay, James Laird, Alexander DesBrisay, David Lawson, Henry McLeod, David McEwen, Alexander Dixon, Angus McDonald, Patrick Kearney, George Adams, James Dwyer, Robert Mutch, George Tweedy, Lemuel Hyde, Stephen Boyver, William Heard, Benjamin Rogers, Alexander McKinley, Alexander McBeth, Donald McLeod, William Wood.

"We were keeping more of our human wealth for use at home than we did in the days to follow.

"Let us regard with reverence the men and virtues of that day, and seek to emulate them."

DAUDET FREED BY NEAT TRICK OF ROYALISTS

Camelot du Roi Impersonated and Obtained Release—All Paris Laughing.

PARIS, June 28.—Leon Daudet, head of the Royalist Party in France is out of jail.

How he got out has all Paris laughing this evening.

To make it funnier, M. Daudet's release became the occasion for the freeing of M. Semard, secretary of the French Communist Party, who was in the same jail.

Ten days ago M. Daudet, together with M. Delest, publisher of L'Action Francaise, the French Royalist paper, were arrested at the office of that paper after several hundred Republican Guards and two brigades of firemen with ready rifles had besieged their "fort." They had been convicted in connection with a taxicab driver in connection with Daudet's two years ago killed his son who the police say committed suicide.

Since his "surrender," M. Daudet has been in Sainte prison, to which institution the Government planned to send next week. Deputy Marcel Cachin, head of the Communist Party, and then it planned to make a beau geste by pardoning both on the National Holiday.

Such was the situation shortly after noon today when the telephone bell rang in the office of Director Catry of the Sainte prison. The voice at the other end belonged to Albert Sarraut, Minister of the Interior, and that, the Government having decided to release M. Daudet, Delest and Semard, M. Sarraut would regard it as a special favor if these men were released today.

The director of the prison, being a clear fellow, called back the Minister of the Interior a few moments later and over the telephone obtained complete confirmation of the order to release Daudet and the two others. He did so, and in a waiting automobile the Royalist disappeared from the neighborhood.

JAPANESE TRINITY TERM OF SUPREME COURT OPENED YESTERDAY

Lengthy List Of Cases Confronts Grand Jury. True Bill Found Against Edmund Byers For Breaking And Entering.

The Trinity Term of the Supreme Court opened yesterday morning at 11 o'clock before His Lordship Chief Justice Mathieson, Mr Justice Haszard and Mr Justice Arsenault. There is a large number of civil cases on the docket, consisting largely of non-jury actions. His Lordship the Chief Justice delivered his charge to the Grand Jury which is published elsewhere in these columns after which the jury adjourned to make a tour of inspection of the jail and infirmary. Canadian Skirmisher Returns From West Indies Trip

(Special to the Guardian)

MONCTON, N. B., June 28.—Please publish the following: R.M.S. "Canadian Skirmisher" arrived Saint John, N. B., last evening after a successful maiden voyage to Bermuda. The eastern group of the Demarara, this being the first sailing under Canada West Indies trade. The steamer carried a full complement of passengers and one and all were delighted with the appointments and seaworthiness of the ship. Ideal weather was experienced practically throughout the trip.

Mr. Charles C. Ireland, assistant to the General Manager of the Canadian Government Merchant Marine line who was a passenger and who stated his observations left no doubt in his mind that the imperial sentiment, which desires closer trade relations with Canada was very strong in the British West Indies. It is felt that Canada must wrest from other countries a bigger portion of the British West Indies trade particularly now that preferential tariff concessions have been mutually arranged and improved transportation facilities have been provided by the Canadian Government Merchant Marine in conjunction with the Canadian National Railways.

Such promotion of trade, Mr. Ireland went on to say, will unquestionably result in great benefit to Canada and to the Maritime provinces especially, particularly the ports of Halifax and Saint John. It is the intention of the Canadian Government Merchant Marine to build new motor vehicles for this service which will result in solving any of the transportation difficulties hitherto experienced.

Of the passengers carried by the R. M. S. "Canadian Skirmisher" were many destined to points Montreal and west, while others were destined to points in the Maritime Provinces and Newfoundland also New York. The more noted passengers included Sir Joseph and Lady Overbridge of St. John's, Nfld, Sir Joseph and Lady Watson, Northville, N. S. The cargo consisted principally of molasses, coconuts, nutmegs and vegetables, consigned to points in the Maritime Provinces and other parts of Canada.

Says Montreal In Grip Of Great Fever Epidemic

(Canadian Press)

SARATOGA SPRINGS, June 28.—Health officers throughout New York state were today directed by Dr. Mathias Nicoll Jr., State Commissioner of Health, to exclude milk and milk products originating in Montreal or in the vicinity of the Canadian Metropolis.

In his warning, sounded at the opening session of the annual state convention of public health officers here today Dr. Nicoll said that Montreal was in the grip of the greatest typhoid epidemic of modern times, in a population of 700,000 there have been over 7,000 cases of the disease, a death rate of eleven for each one hundred cases or nearly 800 deaths.

The disease has been epidemic since January he said. It was a milk-borne epidemic and emanated apparently from a pasteurizing plant in the city.

The commissioner told the convention that the city of New York already had prohibited the importation of milk products from Montreal and its immediate vicinity. Despite the quarantine declared by the authorities of the greater city, the milk products were still coming across the border from Montreal and were being consumed in various parts of the State, particularly in the Northern frontier. At the present time two assistant surgeons and two sanitary engineers of the United States public health service are in Montreal by consent of Canadian Government authorities.

New Chemical For Dusting Wheat Fields

FARGO, June 28.—Planes for dusting wheat fields with "cola," a chemical with which experiments are also to be made in the hope that it will prevent or control black stem rust on wheat will be made on an extensive scale in Manitoba, and will be tried in a smaller way in Cass County, North Dakota, it was learned today.

Thousand Of Acres Flooded In Edmonon District

(Special to the Guardian)

EDMONON, Ita., June 28.—Thousands of acres of land in the constituency of Edmonon are flooded, several of whose families driven from their homes seek safety on higher lands, will train service between Peace River and here has been cut off at high prairie for forty eight hours as a result of a sudden rise of water in the Prairie River, in the Grand district.

Residents of the district are at a loss to explain the unusual condition except that it is from a cloud-burst in the Swan hills, which are two hundred miles northeast of Edmonton. No ice of life is reported.

Proposal Made At Naval Conference

GENEVA, June 28.—Great Britain today proposed at the technical committee of the tri-partite naval conference that cruisers be divided into two classes, one of 10,000 tons and the carrying eight inch guns, and the other of 7,000 tons with six inch guns.

The United States and Japanese delegations requested time to examine the proposal. In the light of the effect it would have on the carrying of each power concerned during the life of the treaty.
