The Hidden Nail

An Unseen Embedded Nail Will Puncture Tube After Tube

WHEN A TIRE GOES FLAT and one can see the puncturing nail or other sharp object embedded in the casing, it is a straightforward proposition of extracting the "instrument of destruction," plugging the hole in the casing with plastic and putting in a new tube, but when a tire deflates and the cause is not apparent an "inquest" ought to be held. Of course, tubes sometimes fail from internal causes, but more likely there is something wrong with the casing. Quite often a headless nail or large tack pierces it and is forced in out of sight, but is left in a position to puncture a new tube. Again the tube injury may be from a crack in the inside fabric, which opens when the casing is bent, lets the tube into it and pinches a hole in it. Before inserting a fresh tube, the casing ought to be opened out by spreading the beads and its entire inside surface carefully examined under a good light for punctures and cracks in the fabric. Running the hand over the fabric will lead to the detection of embedded nails and other pointed objects. Tire repairmen have a machine which opens a casing out nearly flat stretching the fabric so that all defects show up distinctly, but by wedging a wooden block between the beads a somewhat similar result can be obtained.

of chattering transmission bands, but it may be that damaged drive gears would also cause this. It looks as if your rear axle had been assembled incorrectly.

RING GEAR TEETH BREAK

E. C. writes: I have always been troubled by the chipping or breaking of the teeth of the ring gear of my Ford and the drive gears always make a grinding sound. What causes this? My transmission bands give trouble by chattering, although I have had new ones put in. Can this be caused by trouble in the rear end?

Answer: We presume that you are using standard parts made by the manufacturer of the car. This being the case, your trouble probably is that the driving pinion and the ring gear are not correctly meshed, that is their teeth are meshed too deeply or not fully enough, probably the latter, but perhaps the former. The teeth of the two gears should not bottom out; they should mesh as nearly full length as they can without so doing. When they are not in correct mesh, there is usually some grinding. The position of the ring gear is fixed by steel and babbitt washers, located on each side of the differential unit and you should have the two washers of the housing line up exactly and if they do not, have the housing straightened.

AXLE SHAFTS BREAK

G. S. P. writes: I have had trouble with the breaking of the left hand axle shaft of my car. Can you assign any cause for this and suggest a remedy?

Answer: This axle of yours is of the 3/4 floating type and the most probable cause of your trouble is that the left hand half of the rear axle housing is out of correct alignment. The wheel is restrained in position by its bearings on the axle

Another Conference On Irish Question

LONDON, July 16.—Another meeting between Eamonn De Valera and Premier Lloyd George took place today, this discussion of the preliminary of the hoped-for Irish peace settlement lasting about an hour and a half. At its conclusion it was announced the conversation would be resumed later, probably next Monday.

LONDON, July 16.—Eamonn De Valera, leader of the Irish Republicans, and Mr. Lloyd George had another conference in the cabinet room at Downing Street this forenoon.

The conference, which continued about an hour and a half, was again a two-man talk in an adjoining room, however, Sir Hamar Greenwood, the chief secretary for Ireland; Lord Curzon, the foreign secretary; Art O'Brien, president of the Gaelic League in London, and Robert C. Barton, of the Irish delegation, were on hand should their presence be desired.

On leaving Downing Street, Mr. De Valera said there would not be any further meeting today and that he did not think there would be a meeting Saturday.

A member of De Valera's party gave definite assurance that nothing in the nature of a deadlock or a breakdown of the conferences threatened at any time.

Meanwhile, Sir James Craig the Ulster premier, arrived in London today from Belfast, announcing on his arrival that he would see the premier this afternoon. Asked for an expression of opinion on the

Irish situation, Sir James said: "The less said now the better."

He added, however, that he was hopeful.

The official communication on today's conference issued shortly before two o'clock this afternoon read:

A further conversation between Mr. Lloyd George and Mr. Eamonn De Valera took place this morning in Downing Street and will be resumed at a later date, probably Monday."

Stefansson's Venture

WALLA WALLA, WASH., July 14.—Vilhjalmur Stefansson is organizing a new expedition to the Arctic which will leave Seattle about August 6, according to a statement made privately Tuesday. This expedition will be for commercial purposes and, it is supposed, will take colonists into the Arctic circle. Stefansson stated that the north would be populated within the next thirty years and that the development would be rapid. Allan Crawford, of Toronto, and E. L. Knight, of McMinnville, Oregon, members of former expeditions, are in Walla Walla in conference with Stefansson, and it is thought that Knight will head the new expedition.

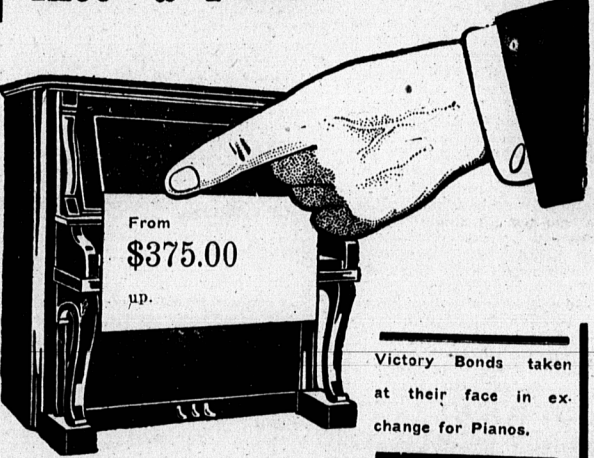
