**C. N. R. Employees
Topped Past Record
In 5th Victory Loan**

MONTREAL, Nov. 12.—Employees of the Canadian National Railways and affiliated companies in the Fifth Victory Loan topped their record subscription of the Fourth Loan by more than a million and a half dollars according to D. C. Grant, vice president Finance and Accounting who today presented a statement covering the period of the campaign to R. C. Vaughan, chairman and president.

Mr. Grant reported that 78,494 individuals employed in the railway organization Trans Canada Air Lines and National Railways Munitions Limited had subscribed for a total of \$3,411,100. This sum is \$1,586,100 or over 23 percent in excess of the final amount of \$2,825,000 achieved in the Fourth Victory Loan campaign.

In addition to the individual purchases by the workers the company made purchases of a total of \$1,000,000, thus bringing the grand total of Canadian National System employee and management contributions to the Fifth Victory Loan to \$3,411,100. The company subscription included \$1,050,000 from the railways employees pension fund and \$400,000 from the employees pension of Trans Canada Air Lines.

Furthermore Mr. Grant stated there was an increase of more than 14 percent in the number of subscribers of 9,680 more than the 68,814 who made purchases of Fourth Loan Bonds. This was one of the primary aims of the Canadian National campaign in accordance with the major objective plan by the Minister of Finance and the chairman of the National War Finance Commission to increase the number of subscribers and in the amount of the purchases were general having been established in all sectors of the company's operations throughout Canada.

Ottawa dealers have been instructed they may deliver up to three tons of coal to a customer,

Price Violations

Overcharging for women's dresses and cotton material proved costly to a Quebec retail firm when its owner was fined \$100 last week for violation of the Wartime Prices and Trade Board ceiling price. Altogether 59 violators were fined for Prices Board infractions the weekly summary of the Board's enforcement administration reveals.

In addition contraventions of regulations administered by controllers of the Department of Munitions and Supply resulted in court penalties for 33 persons. Prince Edward Island figured in the list of convictions. This was the case of a retailer prosecuted for a rationing violation. This case was previously reported.

Price Violations

were found guilty of price violations. Overcharging for foods, including meats, potatoes, sugar, fresh fruits, eggs, rice, tea and coffee, led to fines for 18 wholesalers and retailers. Other goods found to have been bought and sold above ceiling levels were: fuelwood, restaurant meals, overcoats, gloves, dressed, woolen and cotton cloth, children's snowsuits, linoleum, zinc fruit jar rings and wire clothes line.
