Prize Maple Leaves On Display At C. N. Hotel
There is now on display in the Canadian National Hotel, Charlottetown, P. E. I., the winning entries among others, in the 1936 Maple Leaf contest conducted by the Canadian Travel Bureau at Ottawa in co-operation with the Canadian National and Canadian Pacific Railways. The prize of \$100 for the most beautiful leaf went to Quebec being won by Miss Madeleine Cote of Quebec City. Second prize of \$40 was won by a New Brunswick entry, that of Miss Barbara Mills, of Rothesay, N. B., Kings Co. Last year the first prize was awarded to a New Brunswick entry with second prize to Quebec. The year previous, the first year of the contest, the award for the most beautiful leaf was also won by a New Brunswick entry. The third prize of \$20, in the 1936 contest was won by Miss Simmone Chamard, Matapedia, Que. for a leaf found at Point Legarde. A fourth prize of \$10, was won by Miss Marjorie Gillespie of MacTier, Ont., who was awarded a special prize for her beautiful collection in 1935, with fifth prize of \$5, going to Mrs. J. Porter Moffatt, North Sydney, N. S. This year, as last, the prizes for the largest leaf went to British Columbia, the entries of Miss Marina Krjivitzky and Miss Vera Krjivitzky both of Lady Smith, B. C., winning the first prize of \$30, and the second prize of \$10, respectively. The winning leaf measured 22 1-2 by 19 1-4 inches with a surface area of 236.4 square inches. The second prize leaf measured 23 3-4 by 17 3-4 inches with a surface area of 233.4 square inches. Last year's winning leaf had a surface area of 235 1-2 square inches.

EIGHT GIVE EVIDENCE IN SUPREME COURT
The Manslaughter Case, The King Vs. Charles Gavan Duffy Continues.

Eight witnesses were heard yesterday as the Duffy manslaughter case continued for the second day in Supreme Court. The trial opened on Friday when after the evidence of five witnesses had been heard Court adjourned until yesterday.
John Horgan, Patrick Horgan, Helena Horgan and Mary Horgan, brothers and sisters of Michael Horgan, who died from injuries received in the collision which led to the case, all gave evidence yesterday. Other witnesses were Thomas Horgan, Sr., father of Michael Horgan, Joseph Robison of Stanhope, who was in Dr. J. E. Blanchard's car which arrived at the scene of the collision shortly after it happened, Frank Auld, Covehead, who lived near the scene of the crash, and Maurice Bowen of Summerside who examined the cars involved yesterday.
Mr. Justice A. E. Arsenault is presiding at the trial.
Court adjourned last evening at five o'clock until 10.30 this morning.

A short summary of evidence heard yesterday follows:
John Horgan, brother of Michael Horgan, testified that he was riding on the right running board of his brother's car on the night of the collision. Just before the accident he noticed they were on the shoulder of the gutter on the east side of the road. That was on a few moments before the accident. He saw the other car come around the bend on its own side and come straight for them at an angle across the road and strike them on their own side of the road, the witness said.
Judge Duffy appeared to be satisfied or in a daze after the accident.
Cross examined by Mr. McPhee the witness said they were somewhere in the vicinity of the south curve when the Duffy car came around the north curve. After the collision he got up out of the ditch or alongside it by the Horgan car. He scrambled out in a hurry because he feared the car, which was still trembling, would upset on him. He did not know what knocked him off the car, he supposed it was the impact.
The witness said he saw the wheels turning on the left hand side of Judge Duffy's car before the accident happened. That was just before the accident.

Patrick, Helena and Mary Horgan, all occupants of the rear seat on the night of the collision testified that they were on the right side of the road before and at the time of the collision.
Thomas Horgan, Sr., father of the dead boy, testified he was sitting on the right side of the front seat of the night in question. He told of events leading up to the time of the collision. They were driving along the east side of the road and the other car came diagonally across the road and sideswiped them. There was an awful crash and sound of glass breaking and iron tearing.
"He never changed his course from the time I first saw the car until he struck us," the witness said. The wheel of their car sort of raised up and he thought for a moment that it was going over, he continued.
The Duffy car was way over on his right side of the road at the top of the hill and steered a course from there in an angle to the point where the collision took place.
Just after the witness got out he met Mr. Gesner who was examining the lights on the Horgan car. He said "You only had one light". That was all they had at that time, the witness said. He then walked over to the other car and said "You are a nice man to be killing people on the road." He was on the way to where the boy was lying when he spoke to Judge Duffy.
Michael was somewhere to the east side of the Duffy car. He didn't remember in what position the boy was lying. The judge was standing by his side and his head down. He never made any reply to what the witness said to him.
"Judge Duffy made no move to help us," Mr. Horgan said. The children were all crying and asking for a clergyman and the judge made no attempt in any way, shape or form to help. There was considerable time before Dr. Blanchard arrived. He couldn't tell how long. There was plenty time to have started for help.
He didn't know whether their car went ahead after the collision.
He had some experience driving cars the witness said, although he had not driven one since March, 1907. He drove one of the first White steam cars in Cleveland, Ohio, he testified.
Before the accident he could see both the road and the approaching car. He could see they were on the right hand side near the gutter so near he exclaimed to Thomas who was driving to look out or they'd be into the ditch. He could see the other car coming right for them.
Joseph Robison, Stanhope, testified he was accompanying Mr. Dr. Blanchard on the night of the collision. At the scene of the accident when he came on it the Hudson was not in direct line with the centre of the road as pictured in the plan. The Hudson car was on the road with the front

FINE SHOWING BY LIQUORIAN CREDIT UNION
Encouraging Reports Submitted At Annual Meeting Last Night.
The Liquorlian Credit Union lent more than \$2,000 among its 128 members in the first eight months since its founding in June, 1936, according to the treasurer's report read at the first annual meeting held last night in Holy Redeemer Hall.
A dividend of three percent on paid-up shares has been declared by the directors, it was announced.
The report, which was presented by Secretary Treasurer E. J. H. Morrissey, told a story of steady progress and increasing achievement from modest beginnings.
The 21 founding members of last June subscribed \$36 for shares. With the membership of 30 in July this was increased to \$62. In December 112 members had subscribed \$1217 for shares and had deposited \$102.
Borrowings went from \$132 to \$1588 in August up to \$1588 to more than \$60 in December.
The balance sheet revealed that assets, consisting of loans and cash totaled \$1294, with the same amount of liabilities in the form of shares, deposits and the guaranty fund.
R. J. MacDonald, chairman of the Credit Committee, reported there were five loans of more than \$50, 48 less than \$50, and 36 less than \$25.
Dealing the object of the movement was "to create in the minds of our people the spirit of thrift," James Leitcher, in his presidential address, paid tribute to Dr. J. T. Croteau, of Prince of Wales College, and St. Dunstan's University, for the "rapid progress" of the organization.
Rev. Francis McQuaid, Bursar of St. Dunstan's University, asserted that the hope of the credit union grew out of its emphasis on a preparation for all knowledge.
Other speakers were: Rev. Daniel O'Sullivan, C.S.S.R., Dr. J. T. Croteau, Professor Frank McMillan, of St. Dunstan's University and Prince of Wales College, and Martin Kenny.
Officers elected were: Melvina Richardson, Pius Callaghan, Emmet McDonald, directors; Rainy Gallant, credit committee member; L. L. Goodman, supervisory committee member.
