### Full Details of Subscriber's Contest

How good are you at prediction? How many subscriptions do you estimate the candidates in The Guardian and Examiner's Big Contest will secure?

To the person who sends in the correct answer to the above question, or the nearest correct, in the event no one has the answer correct, we will give \$100.00 in Cash. The subscriber with the second nearest correct answer will be given \$50.00 in Cash; next five subscribers having next nearest correct answers will each be given \$10.00 in Cash; next five subscribers having nearest correct answers will each be given a Yearly Subscription to either the Guardian or Examiner. Read over the following Rules. . . You must comply with them in competing for the subscribers free prizes.

1. A subscriber may enter into the prediction competition, provided he or she gives at least one year's subscription to a candidate in THE GUARDIAN AND EXAMINER BIG PRIZE CONTEST, or pays at least a year's subscription into the Contest Office of the Guardian and Examiner for the benefit of a candidate.

NOTICE— Read Rule 1 carefully. Notice that the subscriber must pay directly to a candidate or to the Contest Office. A subscriber will NOT be allowed an estimate if his or her subscription is paid to an agent who deducts a commission on the subscription.

2. The number of estimates allowed each subscriber will depend upon the length of the subscription paid, as set forth in the schedule below.

- 1 year's subscription entitles you to 1 estimate.
- 2 years' subscription entitles you to 3 estimates.
- 3 years' subscription entitles you to 6 estimates.
- 4 year' subscription entitles you to 10 estimates.
- 5 years' subscription entitles you to 15 estimates.

3. The Free Prizes for the subscribers' Prediction Contest will consist of the following:—

- \$100.00 in Cash.
- \$50.00 in Cash.
- Five \$10.00 Cash Prizes.
- Five Subscriptions to the Guardian or Examiner.

4. Either the candidate or the Contest Department of the Guardian and Examiner will supply you with the necessary blank or blanks to fill in your answer or answers.

5. A subscriber may send subscriptions to boys at Military Hospitals or to other friends, and be entitled to send in estimates as per the schedule above.

6. In the event the person subscribing does not wish to take advantage of the Subscriber's Prediction Contest the candidate who secured the subscription, provided said subscriber gives the candidate written permission to do so. In a case of this kind, the following is to appear on the back of the Prediction Coupon: "I have submitted this Prediction, as subscriber did not wish to take advantage of the Prediction Contest;" the candidature's signature

must be attached. Then also this article must follow. "I relinquish all claims to any prize in your subscribers' contest which this coupon may win, in favor of the above signed candidate." Subscribers' signature must be attached.

7. In the event of a tie, priority will be the deciding factor and the tying answer which reached us first will be given the preference. If the tying answers reached the Contest Department simultaneously, the subscriber who gave the longest term subscription will be given the preference. If the tying answers arrived simultaneously and the same amounts were paid by the parties tying, new subscribers will be given the preference over renewals or arrearage subscriptions.

8. A subscriber may give his or her subscription or subscriptions now and send in his or her answer or answers any time before the close of the subscribers' Prediction Contest, which will be one week before the close of the Candidate's Big Prize Contest.

9. In estimating the number of subscriptions be sure to remember that candidates will be securing subscriptions one week after your answer or answers must be in. Make due allowance for work done during this week.

10. All answers to the above question mailed to the contest Department by out-of-town subscribers, must reach the Contest Office not later than five days after the close of the Prediction Contest. We feel certain that this will allow us ample time to hear from all out-of-town subscribers who waited until the last minute to send in entries.

11. Five days after the close of the Prediction Contest, all the entries that have been received will be placed in a sealed package and given into the keeping of the officers of the Canadian Bank of Commerce, who will place the sealed package in a safety deposit vault for safe keeping, until the night of the Judge's Final Count of Votes in The Guardian and Examiner's Big Prize Contest, at which time the officers of the Canadian Bank of Commerce will hand the sealed package over to the Judges, who will decide upon the winners of the Cash Prizes and the other subscribers' prizes.

12. The winners of the Subscribers' Contest will be announced with the other prize winners at the close of the Big Auto Contest.
