## YOUTHS ARE COMMITTED TO SUPREME COURT

Sensational evidence was given at the Police Court yesterday morning when George Kerwin confessed to having participated in the robbery of the Misses Gertrude and Blanche MacNeill on the night of August 24th last.

Detective Cordwell of the R. C. M. P. after giving evidence presented Kerwin's signed confession.

The hearing of Lund and Gormley was held jointly. At the conclusion the two, when asked if they had anything to say, replied in the negative. When the question was put to Kerwin he replied that all he told Detective Cordwell was true.

His Honor committed all three to the Supreme Court for trial.

Following is a summary of the evidence: Gertrude McNeill, proprietress of the Mayfair Tea Rooms on being sworn testified that after leaving the tea room on the night of Aug. 24, and reaching School Street, she saw a man from a vacant lot, one grabbed the witness by the arm, she sister, taking box of money and purse from them. Did not recognize them. Identified the purse. Blanche McNeill proprietress of the tea room gave similar evidence as her sister.

George Kerwin on being sworn testified that on the night of Aug. 24, he was around town with Earl Lund and Maurice Gormley. They went to School Street. Went in a gangway. When the two girls came along Lund and witness jumped out and took the purse and money.

Witness took purse. Grabbed it and ran through back yards till they got to a cemetery. There witness took money out of the purse and some silver from the box. Threw purse and box over fence among bushes in a back yard. They went out to St. Dunstan's College, cut across to Brighton Road, took boat, rowed to York Point, went up to school house and stayed there for the night. Counted the money, took \$83 each, in morning cut across to Bass' Cove. Met a man, asked him the time. Came to Cornwall. Bought cigarettes then went up road. Got a man to drive them to Cape Traverse. Paid him \$1 each. Walked to Borden shore. Got boat to take them across to Tormentine. Paid him \$15 for all three. Went to Port Elgin. Slept in barn. Walked to Sackville. Slept in another hay barn. Went to Moncton where bought tickets to St. John. Went to Eaton's. Witness looked up pair of pants and shirt. Did not know what the rest looked like. Went to National Hotel in Saint John. Signed register for himself and Lund. Gormley signed it. (Page produced, identified it.) Saw Gormley sign. Up at Edwards in St. John all three bought leather jacket. Witness paid \$15.50 for his. Had money before he stole theirs, about \$10. Others had less. Did not know how much. Spent the money and came back. Had arranged about division of money.

Victor McPhail, Meadowbank, on being sworn testified recalling Aug. 25th, to having the three accused to Cape Traverse and pointed out two accused. The last witness was the other.

Claude Howatt, Cape Traverse fisherman, testified a young man indicates Kerwin, came to him looking for witness' brother. Later took the three accused in a dory to witness' brother's boat. Witness and brother took them to Tormentine about 8 o'clock. Paid them \$15.

Clinton Howatt gave corroborative evidence.

## Stresses Value Of Music In Education

The importance of music in education was strongly emphasized to a Guardian representative yesterday by Mr. Harry Gomez, professor of the violin, whose performances have delighted Charlottetown audiences on recent occasions.

Mankind, Mr. Gomez suggested, has in its development neglected the sense of hearing and has used the eye far more as a medium of understanding. Consequently our hearing has probably far less acuteness than that of a primitive man. We should try to reacquire the sensitive sense of hearing. For this there is probably no better means than through music.

Mr. Gomez emphasized the value of music, not so much as a profession, but in its development of personality, as a requisite to culture and mainly as a stimulus to the mind and imagination. The cultivation of beautiful minds in our children was desired, and the best way was to present them with beautiful thoughts. Music's most valuable quality, he said, is that it stirs the imagination.

Mr. Gomez also declared that of all the Arts, none is so universal and simple in its appeal as music, which indeed has been called the language of the universe, its function in life being as normal and natural as speech itself.

## COUNCIL MEETING OF TRADE BOARD

At a council meeting of the Charlottetown Board of Trade held last evening, the regulation regarding the shipping of uninspected meat was further discussed. President T. E. MacNutt, who presided, stated that the committee, appointed at the last meeting, had interviewed the Premier on Tuesday. He further reported that the government will thoroughly investigate the matter.

Mr. MacNutt made the suggestion that, since there seems to be some doubt as to what is in the best interests of the Province, the groups interested (the dealers, packers, Swine Growers' Association and the Livestock Marketing Board) have a conference and try and straighten the matter out.

The letter further stated that the commissioner would like to show moving pictures of an educational nature of Australia. He would also like to show pictures in the various High Schools of the Province. A prize has also been offered for the best essay on Australia. ## S. O. S. CALL

The chief wireless operator said he was not routed out of his cabin when fire was first discovered but was called by an assistant at 2.55 a. m. E. S. T.

"I went at once to the radio room, and assumed command as required by law. I told my first assistant (George Alagna) to go to the bridge to act as messenger between me and the mate."

"After Alagna failed to return in a reasonable time I had MacKay (Charles MacKay, second assistant operator, soak a towel in water so that if the smoke became much thicker I could breathe through it and be able to remain at my instruments. I then told him to go to the bridge, find Alagna and let him know that I was waiting for him."

"At 3.13, Alagna returned and said to me: 'Come on chief, get out of here. You'll die like a rat if you remain here.'"
