glad to meet her always. About seven months ago she went to visit her daughter and son-in-law, Daniel and Mrs. Shaw, New Perth, and almost immediately was stricken down by an attack of jaundice from which she never really rallied. Apart from this there was every reason to believe she might have lasted years for she had a splendid constitution and her active habits and overflowing spirits were in her favor. The Rev. In the Supreme Court in Summerside on Saturday the libel and slander case of Martha Jeanette McCallum vs. Geo. Bowness, commenced on the previous day, occupied the attention of the Court all day. The first witness called was Jarvis Tanton, who gave evidence regarding his conversation with the defendant. The next and last witness for the plaintiff was Mrs. McCallum (the plaintiff) and her evidence and cross-examination occupied the greater part of the day. At the conclusion of her evidence the plaintiff's counsel then rested her case. Considerable argument then took place before the Court by the counsel on both sides, after which the defendant opened the case for two or three witnesses. At four o'clock the Court adjourned until 11 o'clock this morning, when the case will be resumed. The sessions of the Court on Saturday were held behind closed doors, no persons excepting the witnesses, jurors and Court officials being allowed to enter. At the morning session of the Court Mr. McQuarrie intimated to the Court that he would either before the court closed or at the Court in Charlotte to ask leave to apply for a new trial and also for a reserve case in the case of Ulford Cunningham, who was convicted of manslaughter on Wednesday last. Before Court adjourned for dinner His Lordship announced that the court when it resumed at two o'clock would be thrown open to the public while the prisoners were being sentenced. After dinner the Court resumed after adjourned as follows: John McDonald, indicted and found guilty of assault and intent to do bodily harm was sentenced to two years in Dorchester Penitentiary. Geo. McFadden, indicted and found guilty of breaking into and stealing a quantity of liquor from the railway freight house at Tignish, was sentenced to four years in Dorchester. Ulford Cunningham, indicted for murder, but found guilty of manslaughter, was sentenced to twenty years in Dorchester Penitentiary. The prisoner, on being asked if he had anything to say, said that he was innocent of the crime.
