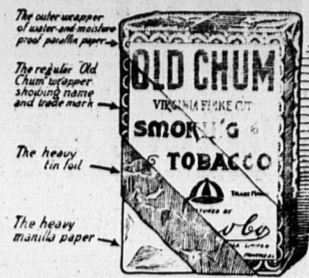

PRESIDENT BUTLER GIVES PROHIBITION ANOTHER SWIPE

NEW YORK, Oct. 17—Discussing what he termed the "new American revolution," Dr. Nicholas Murray Butler, president of Columbia University in an address before the Institute of Arts and Sciences last night said there was danger of federal government being transformed into an unrecognizable and novel form of despotism in which more than a majority and now various minorities will wreak their will on all that most intimately concerns the individual, the family, the community and the state.

Dr. Butler declared that the "new revolution" is not progress, but a backward swing of the pendulum following the long movement in the other direction, which seems to have reached its climax about a generation ago.

Referring to prohibition, Dr. Butler said: "It is the political, moral and governmental problems which the existence of this amendment presents are not dealt with courageously and with high intelligence the nation presently will find itself permanently face to face with a second edition of the

The Foreign Liquor Tavern at Jaffna Island of Ceylon has been closed after a fight of several years according to a letter to the World League Against Alcoholism from Dr. C. N. Paramanathan of Kalmun. According to Dr. Paramanathan, the voting this year was 68 per cent for the abolition of the Tavern, which is 8 per cent more than the required percentage. Three previous votes were unsuccessful.

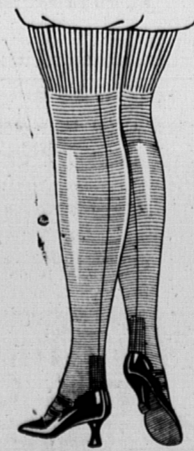

BRITAIN IS TO HAVE NEW WASHINGTON EMBASSY

WASHINGTON, Oct. 17.—The British embassy has outgrown its present quarters and a new embassy building is being sought. Lord Earle, permanent chief of the British office of works, has just completed an inspection of a number of sites that might be suitable for the erection of a more commodious structure to house the British government's activities. He has left Washington to return to London to take up with the government the appropriation and additional funds to acquire a site and erect a modern embassy building. The present buildings at Connecticut avenue and N. Street is nearly forty years old, being one of the first embassy buildings to be erected in Washington. It is located in a neighborhood that is rapidly becoming commercialized.

NOTED VIOLINIST FORCED TO PLAY ON THE STREETS

PITTSBURGH, Oct. 17.—Back in a violin recital in Carnegie Hall, New York, and critics acclaimed the artistry in his performance of Paganini's concert in D Major. He had studied under Ysaye at Antwerp and Brussels, and had been a member of the Boston Symphony Orchestra.

Friday night a group of men idling about the entrance to the Fort Pitt Hotel saw a blind street musician preparing to play. To them he was just a gypsying fiddler.

But apathy vanished and a crowd gathered as the strains of Schumann's "Traumerl" came sweetly from the instrument in the hands of the sightless player. "Evening Star" from Tannhauser, "Souvenir" by Drda, the Drigo Serenade, the prison scene from "Il Trovatore" and the intermezzo from "Cavalleria Rusticana," followed for a two hour program.

Bill folds were opened and the battered hat held more than \$50 when the collection was over. The blind player was Peter van der Meer, sightless since 1915, when cataracts followed measles in a prolonged illness. For six years he was in Bellevue Hospital, New York, where specialists told him he would never see again.

He has played his way to Pittsburgh. He will continue in a few days his journey southward with his violin, and what Ysaye and his own passion for the instrument have given him, will pay the way.

MR. JOSEPH E. BAGNALL

In the early morning hours of Thursday, August 7th, Mr. Joseph E. Bagnall, a highly esteemed resident of Hazel Grove passed peacefully away in the Prince Edward Island Hospital, Charlottetown at the age of seventy-four years.

The deceased had been in his usual good condition of health until less than a week before the coming of the end—when blood-poisoning began its deadly work.

The immediate cause of the blood poisoning is not definitely known. It was believed to have been, due, either to the sting of a wasp, or to the prick of a thorn—or perhaps partly to both.

Shortly after having been taken all Mr. Bagnall was removed to the P. E. Island Hospital. Here all that kind friends and the best medical skill could do was done—but to no avail. He grew gradually worse until on the above mentioned date his spirit took its heavenly flight.

Besides a sorrowing widow—who has been bereaved up wonderfully under the sudden shock, Mr. Bagnall leaves to mourn the loss of a kind and loving father four sons and three daughters. The sons are Gordon, Peavee River, Albert and Harold; Hazel Grove; and the daughters are Mrs. Louisa Mutt, Borden, Mrs. John Lank, farmer, North Carolina, and Miss Mary at home.

Two sons namely Rev. Herbert and Elmer pre-deceased their father by a number of years.

Mr. Bagnall was one of the members of a family of loved brothers and five sisters—the sons and daughters of Mr. Richard Bagnall one of the early pioneers of this section of P. E. Island.

Besides the deceased the other brothers were PHILIP, Hazel Grove and Dr. John S., Charlottetown, and the sisters were Mrs. John McCullum, Farmington, Minn., Mrs. Fred Bulman, Rustico, Mrs. John McMillan Edmonton, and Mrs. Joseph Bagnall, Springfield, All of these, except Mrs. Joseph Haslam who passed away over thirty years ago survive their brother.

In the passing of Mr. Bagnall the whole county has met with a distinct loss. For many years he was one of the leaders in all movements which pertained to the best interests of the church and of the community.

Together with carrying on successfully the work of his farm he was engaged in a milling business in New Glasgow. He was very widely known and was much admired by all who knew him. He was indeed one of nature's noblemen and at all times he proved himself to be a christian gentleman of the highest type. Though out life he was a loyal member and active worker in the Baptist Church and his place there will be very difficult to fill.

Sometimes we wonder why men so noble and so much needed as he should ever be allowed to grow old and eventually pass away. Yet in a world such as this we know that this must come to pass. This being so when our loved ones are called away—and so often as in this case, they are called suddenly and unexpectedly—whether the call comes early in life or whether it loved ones left behind even late in life is too early—we each can only bow in humble submission to the Divine decree saying "Not my will but Thine be done."

During Mr. Bagnall's last illness because of his unflinching trust in the wisdom and the love of God he was calm and unmoved. In the promises of the old Book of Books which had been his daily companion all through life he found comfort and peace. When he was ill and he could not read he had the nurse read many of his old familiar passages for him.

When the end came he was found ready—ready awaiting the Master's call "Suffering one come home."

His passing was one of deep peace. Death had no terrors for him. It was but the gate to that life eternal which to him would be joy forevermore.

The funeral which was one of the largest ever seen in the section of the Island was held on the afternoon of Saturday, August 9th. The services were conducted by Rev. A. K. Herman, assisted by Rev. R. H. Stavart, Rev. O. H. Peters, Rev. A. P. Hodge, Rev. E. M. Atken and Mr. Preston Warren, Student Catechist.

The floral tributes were numerous and beautiful. They were, Messrs. George Simpson, Simpson, Bell, Arch McKinnon, Angus Nicholson, John Craswell and D. M. McDonald.

Interment was in the Hunter River cemetery.

Sues Leopold And Loeb For \$100,000

CHICAGO, Oct. 17.—A suit for \$100,000 damages for an attack alleged to have been incurred at the hands of Nathan Leopold, Jr., and Richard Loeb, was filed in Circuit court today by Charles Ream, a taxicab driver.

Leopold and Loeb, each of whom is 19, are made defendants in this suit in which Ream charges that they were the persons who injured him after making him unconscious by the use of a drug after pointing a revolver at him and making him a prisoner in an automobile.
