New York's Times Square district was thrown into an uproar in the dawn of Sunday as three men raided a beer garden, stripped two score patrons of a few hundred dollars and slew Tom Heaney, 28, because he offered a low-voiced objection. Heaney had just stepped into the garden, a stone throw from Broadway, for a beer.

A mile away in another beer garden Joe Revillo, the 34-year-old proprietor, sat drinking at his bar. A dark complexioned man entered, fired three fatal shots into Revillo's back, and fled.

Scour Texas

Police scoured Texas for the bandit-woman and two men who shot to death 20-year-old Elizabeth Hammond of Kosse, and perhaps fatally wounded her companion, Ervin Conway of Bryan. After the bandits left with the few dollars Conway had in his pockets, the youth drove his car into Bryan, his dead sweetheart in his arms. He collapsed as he reached a hospital, a bullet through his lungs.

At Lafayette, Ind., Patrolman Wesley Wilson, 42, died of wounds received in a gun battle last Friday with robbers. He was the second victim of the pitched street battle.

Wong Poy, young son of a wealthy Chinese grocer of San Antonio, Tex., was found beaten to death in his delivery truck. Police theorized robbery was the motive.

Near Poteau, Okla., Nora Boyette, 12, confessed beside the body of her slain father in their mountain cabin that she shot and killed him after he had beaten her with a stick.

Two young Chicago robbers trussed the manager of the A. H. Bieber store to a ceiling rack and escaped with \$7,000 in furs.

A sorely needed lighter touch came from Joliet, Ill. While their fellow tradesmen stripped the citizenry of booty, some 300 convicts in Joliet Penitentiary peeled off clothing and went nudist behind the confines of the tall walls.

The warden said sun bathing was good for them.

His Lordship was the celebrant at the Choral Communion service when a very large congregation partook of Holy Communion. He was assisted by Ven. Archdeacon C. DeWolfe White, D.D., Rector of the parish.

At this service eight candidates were presented to the Bishop for Confirmation. His address to the candidates was taken from the text "That ye might be filled with all the fullness of God." Ephesians 3-19. He stressed particularly the sacred trust and the responsibility of the church in the future which rested upon those who had just been confirmed.

That is, he feels that France should pay the \$19,000,000 on which she defaulted last December and make at least a partial payment of satisfactory amount on the \$40,000,000 instalment that fell due and went unpaid last Thursday.

William Phillips, acting Secretary of State, and assistant Secretary Raymond Moley will confer tomorrow and Tuesday on the schedule of Conference, now tentatively set to begin late in July.

The debt talks will overlap the London Economic Conference, possibly at a time when it is discussing reciprocal tariff concessions. Whatever decisions Phillips and Moley reach will be communicated at once to the Diplomatic representatives of the governments involved so that they may make whatever preparations they consider necessary.

Continuing his policy of dealing personally with the debt problem, Mr. Roosevelt, himself, will participate in the debt conferences. Holding that the debt of each nation is a separate problem, the President will confer with only one nation at a time. Whatever may be decided upon, he has made clear, must be approved by a Congress now frankly hostile, before it can become effective.

What proportion of the \$40,000,000 defaulted by France on Thursday the United States Government would consider a satisfactory payment was unknown, but an indication at least was seen in a frank statement made in the note to Italy.

"The government of the United States would not be entirely candid," the communication said, "if it did not express its thought that a payment of \$1,000,000 on a total payment due of more than \$14,000,000 may be regarded in the United States as unsubstantial, and may occasion disappointment on the part of the Congress and the people."

A similar tone ran through all the debt notes delivered over the weekend. France was told, after note had been made of her failure to pay on Thursday:

"The Government of the United States must in all frankness call attention to the problems raised by the failure of the French Government to meet the payments due on December 15th, 1932, which have not yet been solved or even discussed between the two nations." Identical language was contained in notes to Belgium and Poland.

"The Government of Finland, by this action, has justified the high regard with which it has always been held by the Government of the United States. It is significant that the people of Finland have regarded this payment as an important national obligation and have discharged its terms in full."

To Italy went the following message:

"In reply to Your Excellency's note of June 14th, the President directs me to say that the Government of the United States notes that the payment of \$1,000,000 has been made on account and as an acknowledgment by Your Excellency of the debt due to the United States.

"This Government also notes the request of the Italian Government for an opportunity to present representations concerning the entire debt question and in reply desires to inform you that it will be glad to confer with you in regard to this matter.

"Furthermore it is noted that the Italian Government has not made full payment at this time for the reasons which were presented to this Government by Finance Minister, Mr. Jung, during his recent visit to Washington, at which time he discussed Italy's capacity to pay.

"The Government of the United States, however, would not be entirely candid if it did not express its thought that a payment of \$1,000,000 on a total payment due of more than \$14,000,000 may be regarded in the United States as unsubstantial and may occasion disappointment on the part of the Congress and the people of the United States."

Business Revival Is Recorded

NEW YORK, June 18—The business revival, which has been gathering momentum since the early part of April, shows no signs yet of wiling under the summer's heat.

Activity increased last week and plans for summer shutdowns were in many cases abandoned.

With the termination of the tumult and shouting in Washington business began to examine anew the administration's sweeping programme for recovery from the depression. Particular attention was naturally focused upon plans regarding the National Industrial Recovery Act, unprecedented in scope and intent.

The Kirk In Assembly (By Burning Bush in the Toronto Globe)

(Concluding article by Burning Bush in Toronto Globe)

When the Assembly rose in the long metre doxology another phase in the Knox College question ended. There was no cant in that "Praise God from whom all blessings flow" that ascended from several hundred throats. The Assembly was rejoicing because it had unanimously found a way out, although the end is not yet. The committee had been in session again after the anticlimax of the previous day. And the Assembly had divested itself of all hyper-emotional attitudes and settled down to deliberate calmly. The Church and its work must continue and justice must be done.

Rev. William Barclay of Central Church, Hamilton, as Chairman, presented the findings of the committee. Prior to reading the recommendations he said that he hoped the high strain of emotion and excited feeling of the previous day was stilled. Words had been spoken that many would like to recall but he blamed no one, and hoped that the report which had achieved the support of the whole committee would receive the same just consideration of the Assembly.

"Let us do something that the eyes of all Presbyterians will light up with new hope. Let us lift this discussion into an atmosphere of good-will," said the Chairman. He wished to say that there had been no denial of British justice, which one veteran of the World War had demanded. He also had served his King and country in the Far East, and he had learned in the Mohamadan regions around Mesopotamia that there was Christian justice—a far, far bigger thing than British justice.

Dr. Hugh Munroe's remark of the previous day was recalled when he pertinently observed that there were two ways out: (1) To give Dr. Eakin a trial; (2) to appoint a strong committee to investigate every angle of conditions in the college. The first way out had been defeated by vote of Assembly; the other channel left was now suggested, viz, that we proceed to a complete investigation of all affairs at Knox College.

There were seven recommendations, six of which were presented by the Chairman, Rev. William Barclay, and the seventh was submitted by Dr. J. S. Shortt. The seven recommendations are given here in shorter form. They were as follows:

1. The deliverance of the Assembly of 1932 stand undefined in the meantime.

2. The committee to be appointed would investigate Knox College from top to bottom—and Assembly gave it judicial powers and access to all evidence and records.

3. The Moderator, Dr. Hugh Grant to be Principal and preside at all public affairs at the College.

4. That the language used in Knox College report which cast reflections upon the judgment of last Assembly be deleted from the report of that body.

5. That the whole Church be informed that Dr. Eakin's removal is not due to any fault in his teaching or in his morals.

6. That all interested in the case withhold judgment until the investigation is completed and the facts presented to next Assembly.

7. And this was, as noted, conveyed by the Vice Chairman, Dr. Shortt; that a Deputy Principal be appointed. The name suggested and accepted without question by the Assembly was that of the Chairman who had piloted the committee to its decision, Rev. William Barclay.

Dr. J. S. Shortt, in speaking to the report, suggested that we all should seek to be brethren dwelling together in unity—so that no discords should mar the harmony of our fellowship.

When the Chairman of the committee stood to present the first recommendation it appeared that there might be another minor outbreak of disension, as several technical points were mooted. But these were all answered satisfactorily. And then the recommendations, one by one, were presented. Some slight alterations of a word here and a line there were accepted as amendments, but not one voice nor one vote rose in protest. The report was accepted unanimously. And yet, with only minor additions that clarified their purpose and proposals, the report was substantially the same as that presented by the committee and attacked on the previous day. One important amendment gave the committee judicial powers.

As the recommendations were received the committee explained their purport. The question of the good name of Dr. Morrow was brought forward, but Mr. McConnell was informed that Dr. Morrow's name was not before the Assembly in any way and that the investiga-

tion would cover all angles. In presenting the recommendation that made clear to the Assembly that neither the doctrine nor morals of Dr. Eakin was involved in the removal from office, the Chairman said: "We do not want Dr. Eakin to go home imagining things and have his soul more embittered." The applause of Assembly during the reception of the report was restrained, but universal.

The thanks of the Assembly was tendered to the committee and its Chairman. When the recommendation to appoint Mr. Barclay as Deputy Principal to care for all details in the absence of the Moderator carried, he accepted, saying that he believed it to be an onerous honour. But he was quite willing to exercise his talents in this temporary capacity, and assured the Assembly that his services would not cost the Church budget anything apart from his out-of-pocket expenses in travel. The Moderator graciously acquiesced to the desire of the Assembly to act as Principal and humorously remarked: "I am glad that you have given me a deputy." Then, with the long, intense crisis sent forward for a final solution, the Assembly sang its stanza of praise.

The Moderator has endeared himself to every Commissioner. A man of few words and a winning smile, his popularity elsewhere than in the Assembly has been evidenced by the host of friends who telegraphed congratulations among them being Right Hon. Mackenzie King, the Mayor and Council of Fort William, the United Church, Fort William; Dr. Robert Laird, Treasurer of the United Church offices, and many, many Presbyterians. Suffering slightly from arthritis that caused his absence from the chair for one seditious, a Commissioner remarked on his return: "Our admiration for your conduct in the chair is only equalled by our affection for yourself."

A man of wise counsel, and even temper, he came to his term of office in the hour of crisis. No happier leader in the Assembly is to be seen than Dr. Shortt of Barrie, who was a close second for the office. He has been most cheerful, although the honor came not this time, but "Jim" will in the very near future be chosen skip of the General Assembly.

Dr. Grant, addressing the court, in moving the budget recommendations, stated that the Mission Board has not closed a field, recalled a missionary nor cut a salary grant. The Presbyterian Church is in a strong position today and becoming an even greater and stronger influence in the Dominion.

"This is no time to cut men who are now under-salaried," he said. Mr. James Dutton, leading layman in the Assembly Church, also voiced his disapproval of touching the small salaries of the majority of hard-working ministers. Dr. Grant told of many laymen who had privately pledged their support to him for one or more missionaries in the foreign field. He said he expected more money for missions. "We are not after those who have no money," he declared, "but those who still have the money."

A closely contested decision resulted in the abolition of the Commission of Assembly. No one could define the powers of this Commission, and it had been guilty of several drastic and seemingly unnecessary recommendations. It was felt that the boards of the Church would be the only machinery necessary in any emergency. The Commission that was created in the crisis of 1925 now passes into history.

The Assembly decided to continue Dr. Allan Reid organizing the funds of the budget for another year. Tribute was paid to the excellent pamphlets prepared by Dr. Reid and delegates from East and West spoke of the inspiration created by his visit. No permanent appointment was recommended, but the number of loose ends to be picked up caused the Assembly to make a temporary appointment of Dr. Reid because of his fine organizing ability.

The Historical Society report was much enjoyed by the Assembly. Rev. Austin Budge spoke of the many old churches that were this year marking their centennials; not only St. Paul's, Hamilton, but Oakville, Smiths Falls and the church in Peterboro'. The Historical Committee have arranged for the care of the Gordon homestead, where the brothers, George and James, left the plow to become missionaries in the South Seas and were martyred on lovely Enomanga.

Mr. Budge also referred to a Western jubilee, the golden jubilee of First Church, Regina, where Rev. Samuel Farley so ably ministers. Assembly thanked Mr. Budge for



his work in gathering historical records.

As the Assembly closes, a word of appreciation is to be moved. The kindly reception to our Church Commissioners will not soon be forgotten. Many homes other than Presbyterian entertained delegates. The banks, business men and citizens vied with each other in welcoming the stranger. The Y. M. C. A. must be remembered for providing necessary and needed shower baths during the intense heat. To the session and people of St. Paul's our most profound thanks. And to the great King and Head of the Church be our gratitude and praise now and forever.

man, Governor of the Bank of England, and Clement Moret, Governor of the Bank of France.

Banks Ready

American delegation quarters understood that technical arrangements between the central banks have been completed to start control at such a time as an arrangement is reached by the governments. It was pointed out that Mr. Harrison had no official connection with the American group at the economic parley.

Many statesmen and experts went to the country for the weekend for a rest before the conference plunges into grueling committee work tomorrow. French delegates to the conference, however, remained busy today. Finance Minister Georges Bonnet stayed in London, dashing about on undisclosed missions. With France playing a lone hand among the chief powers in fighting for the gold standard and having difficult dealings with Washington over debts, its representatives continued to work like beavers.

An apparent rift within the American delegation over the proposal for a general 10 percent reduction on all tariffs was described as "a tempest in a teapot."

Senator Key Pittman issued a statement explaining the suggestion heard Saturday was merely part of a list of topics drawn up by American experts to aid in making up the economic commission agenda and did not in any way represent an official delegation proposal as headlines in the London press seemed to indicate.

Tariff Cut Plan

Several American delegates privately disowned the tariff cut plan which was published as a "suggested agenda for the economic commission in the field of tariffs and commercial policy; submitted by the American delegation."

The plan was drawn up by Henry Chalmers, of the Bureau of Foreign and Domestic Commerce, a member of the technical staff, and its submission to the conference came as a surprise to most of the Americans who said no vote had been taken on it.

After hurried queries were made it was said at American headquarters that the planned submission did not commit the delegation and the idea was simply a suggestion for consideration. One delegate said he believed it stood little chance for adoption and pointed out the delegation has no authority to commit the United States to a 10 percent tariff reduction as that power resides in Congress.

Extension of the tariff truce beyond the end of the conference and liberalization of import restrictions also were inserted in the memorandum.

Roosevelt Disapproves

President Roosevelt's disapproval of the proposed currency stabilization figures was seen in American quarters as emphasizing the conflict between the administration's domestic policy and international undertakings here. The news caused no surprise among the delegates as it was felt that Mr. Roosevelt would be unwilling to stabilize the United States dollar at the present level lest such action undo all that has been accomplished in raising prices.

While they believed the President is unwilling to stabilize until the dollar is appreciably lowered, the delegates said they were not advised definitely what figures are acceptable to him.
